To provide policy and guidelines for Next Purpose. 1. Generation Enterprise Network (NGEN) Outlook e-mail file sizes and user's help guides. NGEN contract details are in reference (a). E-mail content policies are in reference (b). Chief of Naval Air Training (CNATRA) Chief Information Officer (CIO) Mission, Functions and Policy are in reference (c). Help Desk Procedures for CNATRA Technical and Application Support for NGEN are in reference (d). NGEN Outlook e-mail file size limits have been approved by the Chief of Naval Operations (CNO) and executed by the Program Executive Office for Enterprise Information Systems (PEO-EIS) to enforce and preserve bandwidth. Enclosures (1) through (4) are for users who may require assistance and guidance to store over the limit files either by archiving old files, saving onto the hard drive, or storing files in a personal storage file. In the event a user is not sure on how to apply these guidelines, he or she may call the NGEN Help Desk at 1-866-843-6624 at San Diego, California, for further technical support.

2. Cancellation. CNATRAINST 5230.5A

3. <u>Background</u>. NGEN Outlook file sizes are limited to increase bandwidth and provide better functionality to the mail exchange server. This restriction is maintained under the NGEN contract. Size limitations have been implemented to improve system performance and reliability.

4. <u>Policy</u>. All NGEN Outlook e-mail users will have the following file size allowances:

a. The default storage capacity of all standard account mailboxes is 2 GB.

The following table explains the thresholds for mailboxes on the NGEN Outlook Exchange 2010 server:

Exchange 2010 Mailbox Size	Mailbox Actions
Less than 5 MB below limit	If approaching the storage limit for any NGEN email profiles. An automated email will be received that the mailbox is almost full.
2 GB	If the storage limit is reached a second email notice will be received prohibiting emails from being sent until the mailbox size is reduced to less than 2097152 KB.
More than 2 GB	User is unable to send or receive email traffic.

(1) The inbox size limit is based on all folders in the mailbox. This includes Contacts, Calendar Appointments/Meetings, Sent Items, Deleted Items, and any other user-created folders.

(2) Laptop users: Data saved to the H: drive is available only if connected to the network either directly via docking station, port replicator, or remotely using Remote Access Service (RAS).

b. The type of NGEN account will determine the amount of H: drive storage space allotted. The table below outlines the amount of storage space per account type:

Account Type	H Drive Storage Space
Standard NMCI Account	5 GB
Lite Account	200 MB
Lite Account Without Storage	None
Logon Only Account (when available)	None

If 90 percent of storage limit is reached on the H: drive (5242880 KB or 180 MB for Lite Accounts), a warning window appears stating that the user is approaching capacity.

c. Total Shared file storage (S: Drive)is based on the number of network users in the command.

(1) Users will maintain Outlook folder sizes within allotted allowances. Anything exceeding over the collective limit must be archived, stored on the network storage H: or stored on the user's hard drive.

(2) When an excess over the limit warning message appears on the Outlook in-box, the user will continue receiving e-mails. However, the user will not be able to send e-mails, until the folder sizes have been reduced.

5. <u>Procedures/Actions</u>. Refer to references and user help guides at web links in enclosure (3) for assistance in maintaining and/or keeping under or within the prescribed folder sizes range. Enclosure (4) refers to How to Send Large Outlook Attachments.

6. <u>Responsibility</u>. CNATRA CIO is the official authority for NGEN for CNATRA, Naval Air Training Command (NATRACOM) and the Naval Flight Demonstration Squadron (NFDS/Blue Angels) units. All actions and documentations relative to NGEN will be channeled and coordinated through the CNATRA CIO office. Unit Commanding Officers will implement this policy and guidance within their commands upon NGEN implementation. in enclosure (1) and a list of Unit Identification Codes (UICs) can be found in enclosure (2).

SHORTCUT TO EMAIL FOLDER SIZE

The following is an easy short cut to reveal the status of personal Outlook e-mail folder size at any time of the day:

a. INSTRUCTIONS 1

(1) Open Outlook, right-click on email folder in the left menu.

Example: john.doe@navy.mil

(2) Click on "Data File Properties".

(3) Click on "Folder Size".

Note: Limit is 2097152 KB.

b. INSTRUCTIONS 2

(1) Open Outlook, click the "File" tab on the menu bar.

(2) Click on "Cleanup Tools".

(3) Click on "Mailbox Cleanup".

(4) Click on "View Mailbox Size".

(5) Click on the "Server Data" tab.

Note: Limit is 2097152 KB.

Note: ALL calendar + Contacts + Deleted Items + Drafts + Inbox + Journal + Notes + Outbox + Sent items count for the maximum folder size, that needs to be reduced. All Deleted files must also be deleted in order not to count against the allotted totals.

1. IAW REF A, THIS JOINT NAVY - MARINE CORPS NIA ESTABLISHES MAXIMUM EMAIL ATTACHMENT FILE SIZE TO 10MB FOR NGEN. THIS POLICY APPLIES ONLY TO THE NGEN UNCLASSIFIED NETWORK.

2. <u>BACKGROUND</u>. NGEN EMAIL ATTACHMENTS IN EXCESS OF 10MB SLOW NETWORK TRAFFIC AND DO NOT FOLLOW BEST PRACTICES FOR MAIL SIZE. DIRECTOR NGEN AND THE STAKE HOLDERS COUNCIL HAVE PREVIOUSLY AGREED TO THE 10 MB LIMIT. BY REDUCING UNUSUALLY LARGE EMAIL AND ATTACHMENT QUANTITIES, ALL NGEN USERS WILL BENEFIT FROM GREATLY IMPROVED STABILITY AND FASTER RESPONSE TIME OF THE NGEN EMAIL SERVICE.

3. <u>POLICY</u>. ON 01 APR 2004, THE TOTAL SIZE OF ALL ATTACHMENTS TO ANY SINGLE OUTGOING EMAIL WILL BE LIMITED TO 10MB. THE NGEN CONTRACTOR WILL SET THIS LIMIT ON ALL NGEN USER EMAIL ACCOUNTS. AS A RESULT, EMAILS WITH ATTACHMENTS THAT EXCEED 10 MB WILL BE REJECTED.

4. IN THE NEAR FUTURE, THE ABILITY WILL EXIST FOR NGEN USERS TO POST LARGE FILES TO THE ENTERPRISE FILE SPACE (EFS).

5. AT THE PRESENT TIME, AS AN ALTERNATIVE TO SENDING LARGE EMAILS, THE FOLLOWING PROCEDURE MAY BE USED, GIVING NGEN USERS A MEANS TO ACCESS LARGE FILES:

A. NGEN USERS MAY SHARE FOLDERS AND FILES ON THEIR PERSONAL SHARE DRIVE (H:) SPACE WITH OTHER NGEN USERS. THE ORIGINATOR GIVES PERMISSIONS TO INTENDED ADDRESSEES AS FOLLOWS:

(1) IN WINDOWS EXPLORER, RIGHT CLICK ON THE H: DRIVE FOLDER OR FILE THAT YOU DESIRE TO SHARE WITH OTHER NGEN USERS.

(2) LEFT CLICK PROPERTIES, LEFT CLICK SECURITY TAB, AND CLICK ADD BUTTON.

(3) IN THE TOP MOST PULL-DOWN MENU, SELECT NADS.NAVY.MIL AS THE DIRECTORY TO BE SEARCHED FOR. OTHERWISE IN THE NEXT STEP, ONLY USERS IN YOUR DOMAIN WILL BE EXAMINED.

(4) IN THE BOTTOM BOX, TYPE IN THE NGEN USERS LOG-IN NAME (E.G. FIRSTNAME.LASTNAME). THE CORRECT LOG-IN NAME CAN BE FOUND IN THE NGEN GAL, CLICKING ON THE NGEN USERS NAME, AND PROPERTIES. THE CORRECT LOGIN NAME IS LISTED UNDER THE ALIAS BLOCK.

(5) NAMES ARE REQUIRED TO BE SEPARATED BY SEMI-COLONS.

(6) AFTER TYPING IN THE NAME IN THE BOTTOM BOX, SELECT CHECK NAME. THE NAME SHOULD RESOLVE INTO AN EMAIL ADDRESS.

(7) CLICK OK. REPEAT THE PROCEDURE UNTIL ALL INTENDED ADDRESSES ARE SELECTED. THE NAMES SHOULD THEN AUTOMATICALLY BE ADDED TO THE TOP BOX.

(8) THE BOTTOM BOX WILL NOW SHOW BLOCKS THAT NEED TO BE CHECKED TO GIVE FULL ACCESS, READ, WRITE ETC. SELECT THE APPROPRIATE ACCESS. CLICK OK. INTENDED USERS NOW HAVE ACCESS TO ONLY THE FOLDERS AND FILES YOU AUTHORIZED.

(9) EACH NGEN USER WILL NOW NEED TO MAP TO YOUR H: DRIVE. TO DETERMINE PATH TO MAP TO THE INTENDED FILE, GO TO WINDOWS EXPLORER, AND SCROLL DOWN TO YOUR H: DRIVE.

(10) THE NGEN SERVER NAME THAT YOUR ACCOUNT USES SHOULD BE LISTED AFTER YOUR LOG-IN NAME FOLLOWED BY A \$ SIGN. FOR EXAMPLE: JOHN.DOE\$ ON NAEAWNYDFS02VB. DETERMINING THE PATH IS A MATTER OF TYPING A DOUBLE BACK SLASH, THE SERVER NAME, YOUR LOGIN NAME AND A \$ SIGN FOLLOWED BY A BACK SLASH, THEN THE NAME OF THE FOLDER OR FILE.

EXAMPLE:\\NAEAWNYDFS02VB\JOHN.DOE\$\FOLDERNAME.

(11) THIS PATH WOULD THEN BE SENT TO THE INTENDED NGEN USERS WHO WOULD NEED TO MAP TO YOUR H: DRIVE.

(12) THE NGEN USER SHOULD SELECT MY COMPUTER, TOOLS, MAP NETWORK DRIVE, PASTING THE PATH IN THE FOLDER BLOCK AND FINISH. WINDOWS WILL THEN CONNECT TO THE AUTHORIZED FOLDER OR FILE.

B. THESE PROCEDURES WILL ALSO BE MADE AVAILABLE ON THE NGEN HOMEPORT HTTP:/HOMEPORT, UNDER USER TRAINING THEN NGEN USER INFORMATION.

6. <u>EXCEPTIONS</u>. UNIT COMMANDERS MAY HAVE THE 10 MB LIMIT REMOVED FOR THOSE USERS WITH A CURRENT OPERATIONAL NEED TO SEND FILES LARGER THAN 10 MB. THE EXCEPTION SHALL ONLY BE GRANTED WHEN THE ALTERNATIVE SUGGESTED ABOVE CAN NOT MEET THE FUNCTIONAL NATURE OF THE USER'S JOB.

NOTE: THE OPERATIONAL NATURE OF COMMAND CENTER WATCH OFFICERS IS SUCH THAT THEY SHOULD ALWAYS BE WAIVED.

7. THE FOLLOWING PROCEDURE WILL BE FOLLOWED TO OBTAIN WAIVERS:

A. <u>CURRENT USER</u>. UNIT COMMANDS MAY PREPARE AN INITIAL, NO COST ADMIN MOVE ADD CHANGE (MAC) REQUEST THAT CONTAINS A LIST OF ALL USERS THAT MEET WAIVER CRITERIA. COMMANDS WILL SUBMIT THE INITIAL USER WAIVER LIST THROUGH NORMAL MAC PROCESSING CHANNELS NO LATER THAN 15 MAR 2004. INCLUDE FULL NAME, NGEN EMAIL ACCOUNT AND COMMAND NAME OF EACH USER. THE WAIVED USERS WILL REMAIN ON THE EXCEPTION LIST UNTIL REMOVED BY THE COMMAND. COMMANDS WILL MAINTAIN A CURRENT EXCEPTIONS LIST AND WILL REVIEW AND MODIFY THE LIST QUARTERLY. AN ADMIN MAC WILL BE SUBMITTED AS REQUIRED TO UPDATE THE LIST. THE REVISED LIST WILL INDICATE USERS AS DELETIONS, ADDITIONS OR NO CHANGE.

B. <u>ACCESSIONS</u>. WHEN NEW MEMBERS JOIN A COMMAND, COMMANDS WILL INDICATE USERS WHO REQUIRE WAIVERS ON THE SERVICE REQUESTS FOR NEW COMMAND MEMBER.

C. <u>EMERGENT NEED</u>. COMMANDS MAY SUBMIT AN ADMIN MAC AT ANY TIME TO ADD USERS TO THEIR WAIVER LIST.

8. ACTIVITIES CUTTING OVER. PRIOR TO BEGINNING CUTOVER, ACTIVITIES WILL IDENTIFY USERS REQUIRING A WAIVER ON THE SERVICE REQUEST PREPARED DURING THE TRANSITION PROCESS.

9. <u>30 MB INBOUND/OUTBOUND LIMITS</u>. REGARDLESS OF THE 10MB WAIVER, THERE IS AN ABSOLUTE LIMIT OF 30MB FOR INBOUND/OUTBOUND EMAIL.

10. FORCED WAIVER REDUCTION. HP ENTERPRISE SERVICES WILL NOTIFY NETWARCOM (NAVY), THROUGH NNSOC/GNOC AND HQMC C4 (MARINE CORPS), IF THE NUMBER OF WAIVERS BECOMES EXCESSIVE, EFFECTING OVERALL EMAIL PERFORMANCE. IN THIS CASE, NETWARCOM AND HQMC C4 WILL TAKE APPROPRIATE STEPS TO REDUCE THE NUMBER OF WAIVERS.

11. THIS NIA WILL REMAIN IN EFFECT UNTIL CANCELED OR SUPERCEDED.
