- Subj: UNDERGRADUATE MILITARY FLIGHT OFFICER (UMFO) PIPELINE FLOW PROGRESSION
- Ref: (a) CNATRAINST 1542.162 (b) CNATRAINST 1542.157B

1. <u>Purpose</u>: To promulgate Student Naval Flight Officer (SNFO) pipeline syllabus execution guidance until the Multi-Crew Simulator (MCS) is ready for student training (RFT) and the first student is enrolled in the Advanced Maritime Command and Control UMFO Training System (CNATRAINST 1542.171). While the MCS is still in development, the current expected RFT date is April 2014.

2. <u>Syllabus</u>: All SNFOs shall enroll in Primary 1 and subsequently Primary 2 as described in reference (a). Upon completion of Primary 2, students shall be selected for the Intermediate, Maritime, or TACAMO pipelines. All students selected for the following pipelines will proceed as follows:

a. SNFOs selected for the Intermediate pipeline will remain in Training Squadron (TRARON) TEN and enroll in the Intermediate UMFO Training System (CNATRAINST 1542.163). Upon completion, students will be selected for the E-2 or Strike Fighter pipelines.

(1) SNFOs selected for Advanced Strike Fighter will proceed to TRARON EIGHT SIX for Advanced Strike Fighter UMFO Training System (CNATRAINST 1542.164) and designation as a Naval Flight Officer.

(2) SNFOs selected for the E-2 pipeline will proceed to TRARON FOUR and enroll in the Intermediate Jet Multi-Service NFO Training System Curriculum, reference (b). When complete, SNFOs will transfer to CARAEWRON ONE TWO ZERO for the Advanced portion of training and designation as a Naval Flight Officer.

b. SNFOs selected for the Maritime or TACAMO pipelines will transfer to PATRON THREE ZERO or FAIRECONRON SEVEN respectively for the Advanced portion of training and designation as a Naval Flight Officer.
