## CNATRA NOTICE 1542

Subj: ROYAL SAUDI AIR FORCE NON-CARRIER QUALIFICATION STRIKE SYLLABUS PROCEDURES

Ref: (a) CNATRANOTE 1542 of 25 Mar 13 (b) CNATRAINST 1542.167 (c) CNATRAINST 1500.4H

1. <u>Purpose</u>. To promulgate syllabus execution guidance for Royal Saudi Air Force (RSAF) Strike pipeline flight students not requiring Carrier Qualification (CQ). Reference (a) is hereby cancelled and superseded.

2. <u>Syllabus</u>. In addition to the requirements delineated in reference (b) and (c), the following additional curriculum guidelines are effective immediately:

a. Field Carrier Landing (FCL) and Carrier Qualification Landing (CQL) stages are waived.

b. Programmed syllabus flight hours for Intermediate Jet: 78.3; Advanced Strike: 59.8. Total programmed syllabus hours: 138.1.

c. Assessment of landing tasks shall utilize Behavior Statements 22 (Visual Flight Rules (VFR) Landing Pattern), and 23 (Landing/Touch-and-Go) from reference (a) pages IX-16 and IX-18 as training standards in determining landing skill and proficiency.

d. Maneuver Item File (MIF) grade references to "Field Carrier Landing" in all other non-FCL and CQL stages shall be removed from syllabus.

e. No minimum number of Field Carrier Landing Practice (FCLP)-type landings is required.

f. Minimum night hours to complete Advanced Strike: 10.0.

g. Minimum solo hours to complete Advanced Strike: 15.0.

h. Five Extra Training events (coded YXX87) per student are authorized for language adaptation, or language-related Student Monitoring Status(SMS) remediation plans. If a particular student requires more than five Extra Training events, further coordination with Naval Education and Training Security Assistance Field Activity (NETSAFA) and the RSAF (Country Liaison Officer (CLO) is required.

i. No further syllabus deviations are authorized by this Notice. Additional deviations may be requested by the squadron Commanding Officer via Training Air Wing Commander, and authorized by Chief of Naval Air Training (CNATRA) via the NETSAFA Saudi Arabia Country Program Manager (CPM).
