# CNATRA NOTICE 5200

Subj: CNATRA MANAGER'S INTERNAL CONTROL PLAN

Ref: (a) CNATRAINST 5200.8

1. <u>Purpose</u>. To publish the Chief of Naval Air Training (CNATRA) Manager's Internal Control (MIC) Plan for reporting period ending 30 June 2017. Reference (a) provides guidance for individual responsibilities.

# 2. Background

- a. CNATRA is required to submit an annual MIC Certification Statement (CS) to Commander, Naval Air Force, Pacific (COMNAVAIRPAC) for the reporting period 1 July 2016 and ending 30 June 2017. The statement will be used as a feeder report for the Department of the Navy's 2017 Statement of Assurance as required by the Federal Managers' Integrity Act (FMFIA) and the DON'S MIC policy.
- b. The CNATRA MIC Plan is submitted annually per reference (a).
- c. The Chief of Staff (COS) shall sign the annual CS and submit to COMNAVAIRPAC.
- d. The Administrative Officer is the CNATRA MIC Coordinator.
- e. The Government Accountability Office (GAO) has established a set of standards for internal control that include: Control Environment, Risk Assessment, Control Activities, Information and Communication and Monitoring. The enclosures within this notice are the forms to be used in documenting the MIC program.

- (1) Enclosure (1) is the Assessment Schedule for FY 2016 for the Naval Air Training Command (NATRACOM). This is a schedule of Risk Assessments, Command Evaluations and Command Assessments within CNATRA.
- (2) Enclosure (2) is CNATRA HQ staff specific. The Assessable Unit List includes the assessable units and the subassessable units. This list should be reviewed by the assessable unit managers and changes should be reflected in the next year's annual MIC Plan.

# 3. Policy

- a. It is DoN policy that commands establish MIC programs to evaluate and report on the effectiveness of Internal Controls (IC) throughout their organizations and make corrections when necessary. Commands shall use organizational assessments, evaluations, and other contributing information (performance metrics, external audits and inspections, etc.) as forms of monitoring ICs.
- b. In addition to the DoN MIC program, the DoN Risk and Opportunity Assessment (ROA) is a SECNAV directed annual data call led by the Naval Inspector General (NAVINSGEN) in which Navy and Marine Corps activities identify high-level vulnerabilities that represent significant challenges to senior naval leadership. The purpose of the annual DoN ROA is to guide the development of the Annual Oversight Plan (AOP). Leadership can consider including risks identified through the ROA as part of their internally-identified MIC risk assessment. Risks from the ROA, and command or activity-identified risk, can then be assessed to aid in identifying control deficiencies. While the ROA and MIC program serve different purposes, they should be viewed as complementary processes that both involve risk identification and assessment.

#### 4. Action

a. ACOS/Subordinate Commands: Assessable Unit Managers and designated points of contact who are assigned tasks within reference (a) shall follow the schedule that is set forth in enclosure (1) and utilize the data collection forms found in reference (a) to evaluate the assessable units.

- b. Throughout the year CNATRA HQ Assessable Unit Managers will evaluate their assessable units to determine whether they should remain listed on enclosure (2). They will also look at other processes within their purview to determine if they should be added to enclosure (2) the following year.
