9:00 Final Remarks and Looking to the Future--Carol Stitt

The Board will continue to advocate for change to improve children's lives. The Board will work to advocate for: additional placements to meet children's needs, support for the front-line DHHS workers, and oversight for private contractors.

Budget Cuts 1999-2002

The Board lost 5 reviewers and 2 support staff, and thus "stood down" 15 boards, due to the economic conditions. The Board lost 2 more reviewers due to a reduction in federal fund eligibility.

Child Deaths Examined 2003-2004

The Board worked with Governor Johanns, HHS Director Ron Ross, and the Legislature to bring attention to problems in the CPS system and advocated for 120 more workers. The Board initially looked at 33 deaths, then analyzed 4,000 CPS responses.

ASFA 1991-1995

The Board assisted with a conference on extreme abuse at Boys Town in 1993. This workshop laid the groundwork for changes to PL 96-272. The Board's data was used to challenge the federal focus on reunification due to the Board's mandate of best interests and data on failed reunification.

The Board's Executive Director was called upon to testify before Congress, and worked with a national coalition on changes to the family policy act. The federal Adoption and Safe Families Act was passed in 1997. The Nebraska Act was passed in 1998. ASFA put in place the aggravated circumstances provisions and required consideration of termination of parental nights at 15 of 22 months.

The Expansion of the Board 1996-1998

The Board participated in study of the review process that led to LB 642 (1996) sponsored by Senator Avery, which provided funding for an additional 22 boards, and named the Board as Nebraska's IVE review agency.

Changes to Child Welfare System 1997-1998

The Board responded to changes in the child welfare system, such as the five-agency merger, contracting for services, and N-FOCUS (the HHS data system). The Board began working collaboratively with the Courts on obtaining information on children in foster care.

The Creation of the Board 1982-1991

The Board was created as a result of a number of concerns regarding children in foster in care. The Board's tracking system put in place with the assistance of Dr. Coyne. The initial review system put in place by Carol Stitt and Kathy Moore.

The Board played an important role bringing abuse allegations forward which led to the Legislative Franklin Investigation. As a result of the Legislative Committee's work protections were put in place.
