On Thursday, January 28, 2016 a Regular Meeting - Riverboat of the Illinois Gaming Board ("Board") was held on the 5th floor at 160 N. LaSalle at the Michael J. Bilandic Building, Chicago, Illinois at 9:12 A.M. Present were the following: Members Lee Gould, Hector Alejandre and Member Dee Robinson. Chairman Don Tracy and Member Dunn participated via telephone

Member Alejandre moved that the Board approve the open session minutes from the Illinois Gaming Board Regular Meeting held on December 16, 2015. Member Robinson seconded the motion. The Board approved the motion unanimously by roll call vote.

CHAIRMAN'S COMMENTS –

Chairman Tracy stated that he could not attend the open session meeting in person due to employment purposes related to the business of the public body.

BOARD MEMBER'S COMMENTS –

Member Dunn stated that he could not attend the open session meeting in person due to personal illness.

Member Robinson made a statement referencing equal access to minority vendors and Member Gould stated that the Illinois spend should also have a role in awarding contracts.
