# MINUTES OF REGULAR MEETING - VIDEO OPEN SESSION March 4, 2016 ILLINOIS GAMING BOARD Chicago, ILLINOIS

On Thursday, Friday March 4, 2016 a Regular Meeting - Video of the Illinois Gaming Board ("Board") was held on the 5<sup>th</sup> floor at 160 N. LaSalle at the Michael J. Bilandic Building, Chicago, Illinois. The Open Session on Video Gaming started at approximately 9:30 A.M. Present were Chairman Don Tracy, Members Lee Gould, Hector Alejandre, Member Dee Robinson and Member Dunn.

## **APPROVAL OF MINUTES: Open Session**

Member Robinson moved that the Board approve the open session minutes of its Regular Meeting of January 28, 2016. Member Alejandre seconded the motion. The Board approved the motion unanimously by roll call vote.

## <u>ADMINISTRATOR'S COMMENTS –</u>

Administrator Ostrowski stated that there are 5,322 locations up and running along with 22,620 live machines. There will be a Terminal Operator's meeting at the WMS facility on April 4, 2016.

Member Robinson seconded the motion. The Board approved the motion unanimously by roll call vote.

## Lucky Dog Gaming, LLC

Member Robinson moved to issue a Disciplinary Complaint revoking the establishment license of Lucky Dog Gaming, LLC for violating Section 55 of the Video Gaming Act, said action to take effect 21 days from the date of service of the Complaint, unless a \$4,962.45 fine is paid or an Answer is properly filed within that timeframe. Member Alejandre seconded the motion. The Board approved the motion unanimously by roll call vote.

for allowing illegal gambling at the location, said action to take effect 21 days from the date of service of the Complaint, unless a \$10,000 fine is paid or an Answer is properly filed within that timeframe. Member Dunn seconded the motion. The Board approved the motion unanimously by roll call vote.

#### Loke, Inc. d/b/a Wolve's Crossing Golf

Member Dunn moved to issue a Disciplinary Complaint revoking the establishment license of Loke, Inc. d/b/a Wolve's Crossing Golf for allowing an illegal raffle at the location and for having an undisclosed person acting as video gaming manager, said action to take effect 21 days from the date of service of the Complaint, unless a \$15,000 fine is paid or an Answer is properly filed within that timeframe. Member Alejandre seconded the motion. The Board approved the motion unanimously by roll call vote.

# Misrepresentations made to Illinois Gaming Board Agents

## J.K. Neill, Inc. d/b/a 5 O'Clock Bar & Grill

Member Alejandre moved to issue a Disciplinary Complaint revoking the license of J.K. Neill, Inc. d/b/a 5 O'Clock Bar & Grill, due to misrepresentations made to Illinois Gaming Board Agents, said action to take effect 21 days from the date of service of the Complaint, unless an Answer is properly filed within that timeframe. Member Gould abstained from voting. The motion passed 4-0.

## Amending DC V-15-46 Hyperactive Gaming, LLC

#### **Hyperactive Gaming, LLC**

Member Alejandre moved to revoke the Terminal Operator License of Hyperactive Gaming LLC for the violations set forth in DC-V-15-46 issued following the Board's July 2015 meeting, said action to take effect 21 days from the date of service of the Complaint, unless an Answer is properly filed within that timeframe. I further move to authorize legal staff to amend pending Disciplinary Complaint DC-V-15-46 issued to Hyperactive Gaming, LLC to reflect the revocation. Member Gould abstained from voting. The motion passed 4-0.

# Roy Vanderpool Post #81 d/b/a American Legion Post 81

Member Alejandre moved to adopt the Administrative Law Judge's Recommendation and issue a Final Board Order fining Roy Vanderpool Post 81 \$1,500 for operating Video Gaming Terminals without a valid liquor license in violation of Section 55 of the Video Gaming Act. Member Robinson seconded the motion. The Board approved the motion unanimously by roll call vote.

#### Vonch, LLC d/b/a Polekatz Gentlemen's Club

Member Robinson moved to adopt the Administrative Law Judge's Recommendation and issue an Order granting the Illinois Gaming Board's Motion for Summary Judgment. I further move that because Vonch, LLC is currently a pending applicant due to the Board's July 23, 2015 motion rescinding the denial of Vonch, LLC's establishment application, this is not a Final Board Order. Member Gould seconded the motion. The Board approved the motion unanimously by roll call vote.

#### Eric Hoelscher

Member Dunn moved to adopt the Administrative Law Judge's Recommendation and issue a Final Board Order revoking the Terminal Handler License of Eric Hoelscher. Member Gould seconded the motion. The Board approved the motion unanimously by roll call vote.

At 10:02 A.M. Member Dunn motioned to adjourn and Member Alejandre seconded the motion. All Members voted in favor of adjournment.
