On Thursday, April 21, 2016 a Regular Meeting - Riverboat of the Illinois Gaming Board ("Board") was held on the 5th floor at 160 N. LaSalle at the Michael J. Bilandic Building, Chicago, Illinois at 9:11 A.M. Present were the following: Chairman Don Tracy, Members Lee Gould, Hector Alejandre, Member Dee Robinson, and Member Dunn participated via telephone

Member Alejandre moved that the Board approve the open session minutes from the Illinois Gaming Board Regular Meeting held on March 4, 2016. Member Gould seconded the motion. The Board approved the motion unanimously by roll call vote.
