Summer brings the rush

of licensure renewal. In March, the Board sent 54,305 letters to licensed practical nurses (LPNs) as a reminder to renew and to provide online password and log-in information. While many have already renewed, some have not. We urge LPNs to renew online as soon as possible and not wait until the deadline approaches. This is the most efficient method for renewing your license. If you have misplaced the information to renew online, please contact the renewal unit at renewal@nursing.ohio.gov.

We also urge LPNs to complete the Nursing Practiceforce Survey at the end of online renewal. The National Council of State Boards of Nursing (NCSBN) is conducting the survey in conjunction with the Board. NCSBN also distributed the survey to RNs this year. We urge you to complete the survey — it takes a few minutes and provides valuable information about the nursing practice force in Ohio.

Online renewal is one way that the



Board is working to use technology to provide more effective and efficient services. Another example is that the Board now has application information available online for nurses already licensed in other states who are seeking licensure in Ohio through "endorsement." This means that endorsement applicants are able to directly access and view the status of their application documents to know if the Board has received the necessary materials.

Lastly, now on the Board Web site, under Law and Rules, is a "Table of Contents" for the Nurse Practice Act (Chapter 4723, ORC) and the administrative rules (Chapters 4723-1 to 4723-27, OAC). We hope you find this helpful when you reference the statute and rules.

The Board is committed to public protection, and at the same time, is striving to make information more readily available and processes more efficient and effective at a time when practiceloads are increasing and budgets are declining.

Thank you in advance for renewing your license in a timely manner and completing the nursing practice force survey! •

The Board has been work-

ing in conjunction with others on several state initiatives over the last few months. Governor Strickland established the Ohio Prescription Drug Abuse Task Force (OPDATF) by Executive Order on April 2, 2010. Prescription drug abuse has become an epidemic in Ohio. To represent the Board, I joined representatives from federal, state and local government with concentration in the fields of public health, law enforcement, mental health, substance abuse, health care, and regulation. The Task Force is charged with coordinating a multi-disciplinary, multi-jurisdictional approach to the problem of prescription drug abuse. In April, the Board testified for the Sunset Review Committee, a legislative committee gathering information to evaluate the "usefulness, performance, and effectiveness" of committees, advisory councils, and commissions. The Board's testimony was to recommend continuation of the Committee on Prescriptive Governance (CPG). "The Board strongly recommends that the CPG continue. It has a track record of being a cost-effective committee of multiple health care professionals who assist the Board in promoting safe patient care, increasing public protection, and providing a forum

for public participation regarding the prescriptive authority of APNs." We are pleased to report that the CPG will continue.

Senate Bill 89, sponsored by Senator Morano, was enacted on Dec. 28, 2009, and became effective March 29, 2010. The Bill permits an out-of-state or federally employed advanced practice nurse with prescriptive authority that includes controlled substances to obtain prescriptive authority in Ohio without completing an externship. Senate Bill 89 also permits an out-of-state or federally employed advanced practice nurse with prescriptive authority that does not include controlled substances to obtain prescriptive authority in Ohio with a limited externship. Board staff revised the certificate to prescribe applications to meet Senate Bill 89 requirements, and these applications are available for download on the Board's Web site.

LPN RENEWAL


This is a final reminder that if you are an LPN in Ohio, your license will lapse after Aug. 31, 2010. A lapsed license is one that "expires" without any communication from the licensee or certificate holder. If you do not intend to practice nursing in Ohio, temporarily or permanently, notify the Board in writing that you are requesting that your license be placed on "inactive" status, or check the box on the paper renewal application that requests "inactive" status.

All LPNs who are eligible to renew their license in 2010 were sent a renewal notice through the mail during the month of March to the address of record with the Board.

The renewal notice included your personal ID, password, and instructions on how to renew your license online. When renewing online, you can pay the required application fee using MasterCard or VISA credit cards, or debit cards with a MC or VISA logo. By utilizing the online renewal process, you may be able to verify the renewal of your license/certificate through the Board's Web site at *www*. nursing.ohio.gov in as little as three business days after completing the online renewal application. LPNs who do not want to renew their license online must submit a written request for a paper renewal application by e-mail at renewal@nursing.ohio.gov, fax at (614) 466-0388, or by mailing the request to the Board. Fees for renewal are as follows:

- July 1, 2010, through Aug. 31, 2010 (late application fees apply) \$115
- After Aug. 31, 2010 (lapsed license fees apply) \$165

UNLICENSED PRACTICE OF NURSING: *More Than A Non-Nurse Performing Nursing Duties*

Everyone recognizes that the primary reason for preventing the unlicensed practice of nursing is to protect the public. Similarly, most people know that unlicensed practice is punishable as a criminal offense. However, misconceptions exist regarding what acts constitute unlicensed practice and who constitutes an "unlicensed" person. A using a title such as "nurse," "graduate nurse," or "professional nurse;" or using initials such as R.N., L.P.N., G.N., or P.N. Use of these designations is prohibited, whether the person is working as a volunteer or for profit. Unlicensed practice goes beyond the actions of the unlicensed person. Someone holding out an unlicensed person as a nurse is equally

The legal consequences for unlicensed practice of nursing may include felony charges for the non-nurse, nursing student, out-of-state licensee or suspended licensee. A lapsed or inactive licensee may face misdemeanor charges. In cases involving the unlicensed practice of nursing, the Ohio Nurse Practice Act allows the Board to initiate disciplinary action against a suspended, lapsed or inactive licensee as well an unlicensed individual when that person seeks initial licensure.

person who has no nursing license, training, and education is prohibited from performing nursing duties, regardless if for profit or as a volunteer. For licensed nurses, the need to be vigilant in identifying and avoiding unlicensed practice is crucial, because aiding and abetting another's unlicensed practice of nursing may subject the licensed nurse to Board disciplinary action.

Besides engaging in nursing services, unlicensed practice includes representing that one is a nurse or using any designation to imply that a person is a nurse when, in fact, that person does not hold a current, valid Ohio nursing license. For unlicensed persons, prohibited designations include, but are not limited to, considered to be engaging in or aiding/abetting in the unlicensed practice. As businesses increasingly use personal marketing tools, such as staff biographies on direct mailings and online social netpractices, the risk of misidentifying an individual's credentials and engaging in unlicensed practice increases. The following hypothetical illustrates this point: The human resources director for ABC Staffing Agency creates a Facebook page for the agency and personal profiles for all staff persons using information in their personnel files. Jane Doe is aware that her profile identifies her as a nurse, when in fact, she does not hold a current, valid Ohio nursing license. The H.R. director, Ms. Doe, and perhaps others, may

be engaging in the unlicensed practice of nursing by disseminating the erroneous profile information.

Understanding who is an "unlicensed" person is equally important. An unlicensed person is more than simply someone with no nursing license, training, and education. The person with no nursing background or experience can definitively be identified as a non-nurse. Unlicensed persons also include nursing students, out-of-state licensees, and persons with suspended, lapsed, or inactive Ohio nursing licenses or expired temporary permits.

A nursing student is considered to be an unlicensed person, regardless of whether he or she is enrolled in and nearly graduated from an education program, passed the NCLEX or submitted an application for licensure. Until the nursing student receives an Ohio nursing license, the individual is an unlicensed person. There is a legal exception from the unlicensed practice of nursing for nursing students that enables them to perform nursing duties in a very limited circumstance. The student must be enrolled in and actively pursing completion of a Board-approved nursing program; practicing under the auspices of the program; and acting under the supervision of a registered nurse who is a faculty member or teaching assistant in the program. (Section 4723.32, Ohio Revised Code (ORC)). Although a student under this limited circumstance may engage in the practice of nursing, there is nothing in the law that permits a student to hold himself out as a nurse or allow others to hold him out as a nurse.

An unlicensed person is also an individual who is licensed in a state other than Ohio, also known as an out-of-state licensee. Section 4723.32, ORC, provides specific instances where an out-of-state licensee may engage in activities, including the practice of nursing, without the activities being considered unlicensed practice. However, similar to nursing students, the outof-state licensee is prohibited from representing himself as an Ohio licensee. No legal exceptions exist for suspended, lapsed, or inactive licensees to engage in the practice of nursing or to represent themselves as nurses.

The legal consequences for unlicensed practice of nursing may include felony charges for the nonnurse, nursing student, out-of-state licensee or suspended licensee. A lapsed or inactive licensee may face misdemeanor charges. In cases involving the unlicensed practice of nursing, the Ohio Nurse Practice Act allows the Board to initiate disciplinary action against a suspended, lapsed or inactive licensee as well an unlicensed individual when that person seeks initial licensure. Knowing the fundamentals of unlicensed practice of nursing helps identify the prohibited scenarios, avoid the consequences, and protect the public.

An Ohio nursing license can be verified by visiting the Board's Web site at www.nursing.ohio.gov and clicking on the link entitled, "License and Certificate Verification" to enter the Ohio eLicense Center.

For more information on the unlicensed practice of nursing, please refer to Sections 4723.03, 4723.44, 4723.73, and 4723.99, ORC. For a list of exceptions from licensure requirements, please refer to Section 4723.32, ORC.

INSULIN ORDERS IN THE PUBLIC SCHOOL SETTING

During the last few weeks of the school year, the Board received a number of inquiries from school nurses practicing within public school systems and parents of children with type I diabetes concerning the requirements for the administration of insulin to students during school. The questions relate primarily to medication orders received by the school district and the licensed nurse for the administration of insulin that may require the nurse to clarify the order and/or consult with the family and authorized prescriber.

In the public school setting, Ohio Revised Code (ORC) Section 3313.713 provides specific requirements in order for medication to be administered to students. Each school district is required to adopt a policy regarding whether medication can, or cannot, be administered in the school, and if medication may be administered, under what circumstances. The law requires that if medications are to be administered, the authorized prescriber must submit an order in a very specific format that is signed by the prescriber and includes but it not limited to:

- 1. The name and address of the student
- 2. The school and class the student is enrolled
- 3. The name of the drug and the dosage to be administered
- 4. The times or intervals at which each dosage of the drug is to be administered
- 5. The date the administration of the



drug is to begin

- 6. The date the administration of the drug is to cease
- 7. Any severe adverse reactions that should be reported to the prescriber and one or more phone numbers at which the prescriber can be reached in an emergency
- 8. Special instructions for administration of the drug, including sterile conditions and storage

In addition, before medication is administered, the law requires that "any other procedures required by the [school] board be followed."

The Board of Nursing is not a part of the Ohio Department of Education, and it does not administer and enforce the above ODE law. However, licensed nurses employed in public school systems, in addition to complying with the applicable medication administration policy established by their school system, must also comply with practice requirements set forth in the Nurse Practice Act, Chapter 4723, ORC, and administrative rules. The following rules contain the analysis that all licensed nurses, regardless of their nursing specialty or clinical setting, are required to apply when implementing an order.

Chapter 4723-4, Ohio Administrative Code (OAC), contains the standards of practice applicable to registered nurses and licensed practical nurses. Rule 4723-4-03, OAC (registered nurses), and Rule 4723-4-04, OAC (licensed practical nurses), contain the respective nurse's "standards relating to competent practice." These require a nurse to timely implement an order unless the nurse believes or has reason to believe the order is inaccurate; not properly authorized; not current or valid; harmful or potentially harmful to a client; or contraindicated by other documented information. If any of these conditions exist or are believed to exist by the nurse, it is the nurse's responsibility to timely clarify the order. When a nurse makes a decision not to follow the order, the nurse is required to notify the ordering health care provider of the decision, document the notification, and take any other action needed to assure the safety of the client.



Dialysis Technician CMS Clarification



The Federal requirement for dialysis technicians to be certified has a timeline of 18 months from date of hire. Ohio law that currently allows for extensions of a temporary dialysis technician certificate for longer than 18 months is less stringent than the Federal requirement, if those extensions allow greater than 18 months to achieve certification. <u>The</u> <u>more stringent requirement would apply</u> <u>according to the Centers for Medicare &</u> <u>Medicaid Services (CMS)</u>.

When a facility is surveyed for compliance with the Federal Conditions for Coverage in Ohio, if the facility has individuals working as dialysis patient care technicians (PCTs) under an Ohio temporary certificate, who are not yet certified, and those individuals have been employed more than 18 months as a PCT working in dialysis, the <u>facility would be</u> <u>cited</u> for not meeting the Federal regulations.

NAME/ADDRESS CHANGE QUESTIONS

How do I change my name with the Board?

You must submit a certified document of a name change (i.e. marriage certificate/abstract, divorce decree/dissolution, name change document) within 30 days of the change. Certified documents can be obtained from the court where the original record was filed. Photocopies or notarized copies are not acceptable for a name change. Submit your certified document with a "Name/Address Change Form" or with a brief letter which includes your Ohio license/certificate number, your previous name, your new name as you want it to appear on Board records, your current address, county and telephone number. A Name/Address Change Form is available on the Board's Web site at *www.nursing.ohio.gov* under the "Forms" link. Any name change documents must be mailed to the Board.

Will the certified document of my name change be returned? Yes. The Board will return your certified document within 10 business days.

Will I receive a license with my new name on it?

No. The Board no longer issues wallet cards. However, once your name has been updated, it can be verified on the Board's Web site.

Click on the "Verification" link located on the menu of the Board's home page.

How do I change my address with the Board?

Address changes must be submitted in writing within 30 days of the change. Submit your address change with a "Name/Address Change Form" or with a brief letter which includes your name, Ohio license/certificate number, address, county and telephone number. BOARD DISCIPLINARY ACTIONS

- **Permanent Revocation** = Prohibited from ever practicing nursing or dialysis care, or as a certified community health practiceer.
- **Indefinite Suspension** = Indefinitely prohibited from practicing for a specified minimum period of time. The Board will reinstate only if all conditions for reinstatement, set at the time the action was taken, are met.
- Automatic Suspension = Suspension for a violation of a consent agreement or Board order or suspension required by law for commission of a specified felony.
- **Immediate Suspension** = Suspension required by law for a felony drug abuse offense.
- Indefinite suspension with a stay = On "probation." May practice if the license status is active but will be monitored by the Board under conditions and restrictions.
- **Restrictions** = Limits such as prohibition from passing narcotics or working in certain areas of practice.

- **Reprimand** = Least amount of discipline. Acknowledgment that what the nurse, dialysis technician or community health practiceer did was wrong. Does not prohibit practice.
- Voluntary surrender = May not ever practice again. Permanent action following a formal agreement by the nurse, dialysis technician or community health practiceer to give up the license or certificate.
- Fines = A fine of up to \$500 imposed for each violation.

Below are the Board's actions taken during the last Board meetings. The actions are an accurate representation of information maintained by Ohio Board of Nursing at the time of posting. Because the name of a licensee may be the same as another, please do not assume from the name alone that a particular individual has had disciplinary action. 
