



strives to communicate regulatory information. As you may already know, we implemented Facebook and Twitter last year, in addition to our website and eNews services. You can sign up for all of these on our website at *www.nursing.ohio.gov.*

This year, the Concord Evaluation Group (CEG) conducted a usability audit of 62 board of nursing websites on behalf of the National Association of State Boards of Nursing (NCSBN) for the purpose of assisting boards in providing information and improving website ease of use.

CEG found "that the Ohio Board of Nursing website contained a large amount of useful information. adding to site's overall credibility and relevance to its users." While we were pleased about the findings, we took this as another opportunity to review the website and have made additional changes to enhance its usability. We hope you are able to easily navigate and find information you need.

Another means of communication is the *Momentum* magazine. Due to the significant increase in the numbers of licensed nurses in Ohio, in order to continue the quarterly magazine at no cost to licensees or taxpayers, the publisher must change the method of distribution. The total quantity of printed magazines will be no less than 75,000, with multiple copies of printed magazines going to 196 hospitals or medical centers; 593 nursing homes, rehabilitation centers, residential care and retirement facilities; all pre-licensure nursing education programs approved by the Board; all post-licensure education programs that offer a Master's Degree in nursing; a minimum of 95 Dialysis Centers; and a minimum number of 5,200 individuals, including nurse executives, managers, and recruiters.

In addition, the publisher will email unlimited copies of magazines, at no cost, to every individual or entity who requests a copy of the magazine. The magazine will also be available via email if you send the publisher your email address. These requests should be sent to *subscriptions@pcipublishing.com*. Lastly, the Board will continue to post *Momentum* on our website.

The Board is committed to make information readily available. Please sign up to receive updates via eNews, Twitter, or Facebook, or check our web site frequently.

Speaking of commitment, I had the opportunity to attend the Board's All Staff meeting on June 16, 2011. 

All rights reserved. *The on-site Bachelor of Science in Nursing (BSN) degree program can be completed in three years of year-round study instead of the typical four years with summers off. In May, Governor Kasich signed into law Amended Substitute House Bill 93, sponsored by Representatives David E. Burke, R.Ph., and Dr. Terry Johnson, D.O. Amended Substitute House Bill 93 aggressively focuses on further regulating facilities and prescribers operating as pain management clinics by requiring that the Board of Pharmacy license those clinics. Additionally, the Medical Board

is used to monitor the misuse and diversion of controlled substances and other dangerous drugs.

Specifically for the Nursing Board, the bill provides enhanced investigative access to OARRS, the ability to share confidential investigatory information more freely with law enforcement and other state agencies, and access to the Ohio Law Enforcement Gateway. HB 93 also

must adopt rules establishing standards for physician operation of pain management clinics and standards to be followed by physicians who provide care at pain management clinics. The bill also modifies the operation of OARRS (Ohio Automated Rx Review System), a drug database administered by the Pharmacy Board that requires that the Nursing Board adopt rules to set standards and procedures for Advanced Practice Nurses with prescriptive authority to access the OARRS drug database. The Board will propose a new rule to establish circumstances that would trigger a prescriber's request and review of a patient's OARRS report. Currently the Board is discussing a proposed new rule with interested parties and a public hearing is tentatively scheduled for November.

From the outset of this legislative initiative, the Board has collaborated with legislators, law enforcement and other state boards and agencies in the fight against prescription Specifically for the Nursing Board, the bill provides enhanced investigative access to OARRS, the ability to share confidential investigatory information more freely with law enforcement and other state agencies, and access to the Ohio Law Enforcement Gateway.

drug abuse. This commitment by the Board and others is consistent with our mission to actively safeguard the health of the public through the effective regulation of nursing care. The Board will be diligent in ensuring that our licensees are practicing and collaborating with physicians in accordance with the statutory requirements, rules, and standards when prescribing pain medication. It is essential for Advanced Practice Nurses with a certificate to prescribe to be familiar with the laws and rules governing prescribing, including the newly effective laws.

While you as licensed health professionals are responsible for keeping current with your knowledge of laws and rules governing your practice, we want to assist by making information and updates available. Please be aware that the Medical Board promulgated emergency administrative rules, effective June 20, 2011, including Ohio Administrative Rule 473129-01, Standards and Procedures for the Operation of a Pain Management Clinic. Information on this rule, other rules proposed to implement House Bill 93, and other topics related to safe prescribing may be found at www.med.ohio.gov/Center_for_Safe_ Prescribing.html, the Center for Safe Prescribing. I also suggest that you bookmark the Nursing Board's home page as it contains a wealth of information that may help inform your practice. Do I Need an Order to Administer or Recommend an Over-the-Counter (OTC) Medication to a Client?

The response to this question is "it depends."

The FDA defines OTC medications as drugs that are safe and effective for use by the general public without a doctor's prescription. It is this definition of OTC that is used in this article. Examples of OTC medications would include ibuprofen, aspirin, acetaminophen, and an array of FDA-approved OTC medications.

The first decision point is whether or not the registered nurse is administering or recommending the OTC medication in accordance with Section 4723.01(B)(2), Ohio Revised Code (ORC), "Executing a nursing regimen through the selection, performance, management and evaluation of nursing actions," or Section 4723.01(B)(5), ORC, "Administering medications, treatments, and executing regimens authorized by an individual who is authorized to practice in this state and is acting within the course of the individual's professional practice."

If the registered nurse is administering or recommending the OTC as an independent nursing action, an intervention for a specific nursing problem or nursing diagnosis, an order from an authorized health care provider is not required as the registered nurse is licensed to engage in nursing practice. If the nurse is administering the medication in accordance with an authorized health care provider's regimen, then an order from the provider is required so that the registered nurse knows the regimen he/she is to implement for the client on behalf of the authorized provider.



The statutory scope of practice for a registered nurse is located in Section 4723.01(B), ORC. This section contains six subsections, only one of which, (B)(5), requires an authorized health care provider's order. 4723.01(B)(5), ORC, "Administering medications, treatments, and executing regimens authorized by an individual who is authorized to practice in this state and is acting within the individual's professional practice." Rule 4723-4-03(D)(4), Ohio Administrative Code (OAC) states that "When the nursing care is to be provided in accordance with division (B)(5) of section 4723.01 of the Revised Code, the nurse has a specific current order from an individual who is authorized to practice in this state and is acting within the course of the individual's professional practice." Otherwise, a registered nurse is authorized to assess the health status of a client for purposes of providing nursing care, identify actual or potential health problems amenable to a nursing regimen, and to execute a nursing regimen through the selection, performance, management, and evaluation of nursing actions, which could include, when appropriate, the administration or recommendation of an OTC medication.

Should a registered nurse administer or recommend an OTC medication as a nursing action, the registered nurse is required to engage in practice consistent with the standards of safe nursing practice contained in Chapter 4723-4 OAC. The OTC medication should be in the original manufacturer's packaging with the FDA required labeling, including instructions for *continued on page 10*




If the registered nurse is administering or recommending the OTC as an independent nursing action, an intervention for a specific nursing problem or nursing diagnosis, an order from an authorized health care provider is not required as the registered nurse is licensed to engage in nursing practice. If the nurse is administering the medication in accordance with an authorized health care provider's regimen, then an order from the provider is required so that the registered nurse knows the regimen he/she is to implement for the client on behalf of the authorized provider.

use and other relevant drug information. The nurse must administer or recommend the OTC medication in accordance with the manufacturer's directions for use. For instance, a registered nurse should not recommend or administer an OTC medication in a dosage that may only be obtained by prescription. In executing the nursing regimen all of the requirements of Chapter 4723-4, OAC, apply, including but not limited to, completion of a health assessment, knowledge of the client's current medications and allergies, knowledge of the OTC medication being recommended/ administered, etc.

The scope of practice for a licensed practical nurse is located in Section

4723.01(F), ORC. The practice of nursing as a licensed practical nurse is "dependent" meaning that licensed practical nurses provide nursing care under the direction of licensed physicians, dentists, podiatrists, optometrists, chiropractors, or registered nurses. It is not within the scope of practice for a licensed practical nurse to independently identify nursing actions such as administering or recommending an OTC medication. Such an action would require direction from one of the above health care providers.

Some facilities/institutions may have policies that further restrict nursing practice and may require registered nurses to obtain an order from a prescriber before administering an OTC medication. Registered nurses should adhere to the scope and standards of practice for registered nurses, as well as complying with applicable facility/ institutional nursing policies. •

RN and Advanced Practice Nurse Renewal



A lapsed license is one that "expires" without any communication from the licensee or certificate holder. If you do not intend to practice nursing in Ohio, temporarily or permanently, notify the Board in writing that you are requesting that your license be placed on "inactive" status, or check the box on the paper renewal application that requests "inactive" status.

Renewal notices were mailed during the month of March to the address of record with the Board. The renewal notice included your personal ID, password, and instructions on how to renew your license online. When renewing on-line you can pay the required application fee using Master Card or VISA credit cards, or debit cards with a MC or VISA logo. By utilizing the online renewal process, you may be able to verify the renewal of your license/certificate through the Board's website at www.nursing.ohio.gov in as little as three business days. RNs and advanced practice nurses who do not want to renew their license online must submit a written request for a paper renewal application by e-mail at renewal@nursing.ohio.gov, or if you are an advanced practice nurse at apn@nursing.ohio.gov. You may also fax your request to (614) 466-0388, or mail the request to the Board. Fees for renewal are as follows:

RENEWAL FEES

July 1, 2011 through August 31, 2011 (includes a late application fee) registered nurse - \$115 advanced practice nurse -(each COA - \$135)

After August 31, 2011 (reinstate a lapsed license) registered nurse - \$165 advanced practice nurse -

(each COA - \$185)

Certificate to prescribe - \$50

Board staff are available to assist you in taking the necessary steps to renew your license/certificate. If you have questions about the renewal process, please contact the Renewal Unit at (614) 995-5420 or by e-mail at renewal@nursing.ohio.gov. If you are an advanced practice nurse, contact the Advanced Practice Unit at (614) 995-3680 or by e-mail at apn@nursing.ohio.gov.

Name/Address Changes

How do I change my name with the Board?

You must submit a certified document of a name change (i.e. marriage certificate/ abstract, divorce decree/dissolution, name change document) within thirty days of the change. Certified documents can be obtained from the court where the original record was filed. Photocopies or notarized copies are not acceptable for a name change. Submit your certified document with a "Name/Address Change Form" or with a brief letter which includes your Ohio license/certificate number, your previous name, your new name as you want it to appear on Board records, your current address, county and telephone number. A Name/Address Change Form is available on the Board's website at www.nursing. ohio.gov under the "Forms" link. Any name change documents must be mailed to the Board. There is no fee for a name or address change.

Will the certified document of my name change be returned?

Yes. The Board will return your certified document.

Will I receive a license with my new name on it?

No. The Board no longer issues wallet cards. However, once your name has been updated, it can be verified on the Board's website. Click on the "Verification" link located on the menu of the Board's home page.

How do I change my address with the Board?

Address changes must be submitted in writing within thirty days of the change. Submit your address change with a



"Name/Address Change Form" or with a brief letter, which includes your name, Ohio license/certificate number, address, county and telephone number. A Name/ Address Change Form is available on the Board's website at *www.nursing.ohio.gov* under the "Forms" link. Please submit to the attention of the appropriate department as follows:

Submit your certified document with a "Name/ Address Change Form" or with a brief letter which includes your Ohio license/ certificate number, your previous name, your new name as you want it to appear on Board records, your current address, county and telephone number. A Name/Address Change Form is available on the Board's website at www.nursing.ohio.gov under the "Forms" link.

Will I receive confirmation that my address has been changed?

No. If you wish to verify that your address has been changed, call the Board at (614) 466-3947 for verbal verification. •







RULE REVISION CONCERNING APN COLLABORATING PHYSICIAN SIGNATURES



Rule 4723-8-04, OAC, which addresses the requirements for standard care arrangements, was revised effective February 1, 2011, to allow a physician's designated representative to sign for a group of physicians in order to comply with the previous requirement that each collaborating physician sign the standard care arrangement. For purposes of the rule, a physician's designated representative means a physician who serves as the department or unit director or chair, within the same institution, organization, or facility department or unit, and within the same practice specialty, that the nurse practices, and with respect to whom the physician has executed a legal authorization for the

representative to enter collaborating agreements on the physicians' behalf.

In other words, if the criteria are met, individual physicians may authorize their department chair, for example, to sign standard care arrangements with APNs on their behalf, rather than having multiple physicians sign the standard care arrangement. This rule change does not apply to podiatrist signatures when collaborating with an APN.

COMPLANCE REMINDER Forget to Renew? What Can Happen?

Ohio law requires nurses to renew their licenses and certificates every two years.¹ Renewal requirements include submitting the Board's renewal application, completing the required continuing education, and providing the applicable fees. Registered nurses must renew by August 31st of odd numbered years.² You can choose to renew your license on-line by visiting the Board's website at *www.nursing.ohio.gov* If you work as a nurse while your license or certificate of authority is lapsed, then you are engaging in the practice of nursing without a current, valid license. Under Ohio law in order to provide nursing services, a person must first have a current, valid license, or in the case of advanced practice nurses, you must have a current, valid certificate of authority.⁴ You must also have a current, valid license license. Possible discipline may include license revocation, suspension, restriction, reprimand, and/or fine.⁷

Advanced practice nurses must also renew each certificate of authority.⁸ All advanced practice nurses should be careful to renew their license as a registered nurse and each individual certificate of authority issued to avoid lapse. Under Ohio law, if your license as a registered



or requesting a paper renewal application by email at *renewal@nursing.ohio.gov*, fax at (614) 466-0388, or by mailing the request to the Board.

So what happens if you fail to renew? If you do not submit a completed renewal application by August 31st, your license will lapse, unless you request that your license be placed on inactive status prior to August 31st. *Lapsed* means that you failed to fulfill all requirements of renewal for your license or certificate of authority.³ in order to represent to others that you are a registered nurse or use the title "registered nurse" or "RN."⁵

Ohio law allows for criminal penalties for the unlicensed practice of nursing, including possible felony charges. If you are working as a nurse with a lapsed license, you may face criminal misdemeanor charges.⁶ In addition to the possible criminal penalties, Ohio law also allows for the Board to discipline the licensee for practicing with a lapsed nurse lapses, then any certificate of authority issued to you also lapses.⁹

Employers should be aware of the penalties involved in engaging nursing services from licensees with lapsed licenses. Employing a registered nurse without a current, valid license to practice nursing is a violation of Ohio law.¹⁰ Employing an advanced practice nurse without a current, valid license or certificate of authority is a violation of Ohio law.¹¹ Employers may be subject to felony criminal penal-

ties for employing a nurse without a current, valid license regardless of whether the employer had actual knowledge of the nurse's licensure status. Employers can verify any Ohio nursing license by visiting the Board's website at www.nursing. ohio.gov and clicking on the link entitled, "License and Certificate Verification" to enter the Ohio eLicense Center.

BOARD DISCIPLINARY ACTIONS

- Permanent Revocation = Prohibited from ever practicing nursing or dialysis care, or as a certified community health worker.
- Indefinite Suspension = Indefinitely prohibited from practicing for a specified minimum period of time. The Board will reinstate only if all conditions for reinstatement, set at the time the action was taken, are met.
- Automatic Suspension = Suspension for a violation of a consent agreement or Board order or suspension required by law for commission of a specified felony.
- Immediate Suspension = Suspension required by law for a felony drug abuse offense.
- Indefinite suspension with a stay = On "probation." May practice if the license status is active but will be monitored by the Board under conditions and restrictions.
- Restrictions = Limits such as prohibition from passing narcotics or working in certain areas of practice.
- Reprimand = Least amount of discipline. Acknowledgment that what the nurse, dialysis technician or community health worker did was wrong. Does not prohibit practice.
- Voluntary surrender = May not ever practice again. Permanent action following a formal agreement by the nurse, dialysis technician or community health worker to give up the license or certificate.
- Fines = A fine of up to \$500 imposed for each violation.


