The Board continues to be

an active participant in the Prescription Drug Abuse Action Group, the Ohio Prescription Drug Abuse Task Force, the Governor's Cabinet Opiate Action Team (GCOAT), the Governor's Law Enforcement Working Group, and most recently, the Governor's Reforming Prescribing Practices Committee and Metrics Subcommittee. The Governor, Ohio Legislature and the Ohio Attorney General have been focused on addressing public safety concerns associated with the inappropriate prescribing of opioids.

Through the Governor's Reforming Prescribing Practices Committee, the Board participated in meetings with health care licensing boards and stakeholders to develop prescribing guidelines for Ohio's clinicians. The Board recently approved the *Guidelines for Prescribing Opioids for the Treatment of Chronic Non-Terminal Pain 80 mg of a Morphine Equivalent Daily Dose (MED) Trigger Point*, The Guidelines will be used to promote educational efforts to decrease negative opioid prescribing patterns. Metrics will be developed to measure opioid prescribing, and the effectiveness of the Guidelines and educational efforts to decrease unnecessary or ineffective opioid prescribing patterns.

and the Committee on Prescriptive Governance endorsed the Guidelines. The Guidelines will be used to promote educational efforts to decrease negative opioid prescribing patterns. Metrics will be developed to measure opioid prescribing, and the effectiveness of the Guidelines and educational efforts to decrease unnecessary or ineffective opioid prescribing patterns.

In addition, the Nursing, Medical, and Pharmacy Boards issued the *Joint Regulatory Statement on the Prescription of Naloxone to High-Risk Individuals* endorsing the prescription of naloxone (NarcanTM) to those who are at high-risk for opioid drug overdose. The purpose of the statement is to promote wider utilization of naloxone for high-risk individuals by educating prescribers on the proper use of naloxone. Naloxone is a medication primarily used to prevent or reverse the effects of opioids, including respiratory depression, sedation and hypotension. When administered during an overdose, naloxone blocks the effects of opioids on the brain to restore effective breathing. The Board will continue to work with the administration, legislature, other agencies, licensees and stakeholders in combatting opioid abuse and diversion. •

The Board mailed 190,522 RN, APRN, and CTP renewal notifications in May for the renewal period ending August 31, 2013. This year's renewal includes the collection of nursing and primary care workforce data. We thank all who renewed and completed the nursing

for all health care professionals. Specifically for nursing, HRSA states that understanding the supply, distribution, and educational pipeline of nurses is important for policies and programs that will ensure access to care and an effective health care system.

Statewide, workforce data is vital to the Ohio Action Coalition. The Coalition was organized to implement the eight recommenda-

Nationally, the National Center for Health Workforce Analysis of the Health Resources and Services Administration (HRSA) is encouraging the collection of workforce data tions for nursing contained in the Institute of Medicine (IOM) report, *The Future of Nursing: Leading Change, Advancing Health.* The Coalition formed a Data/Research Work Group to facilitate acquiring workforce data and to develop recommendations for data analysis necessary for regional and state-

wide planning about the nursing and primary care workforce.

Recently, the Ohio Senate Finance Subcommittee on Medicaid convened panel discussions regarding workforce shortages and programs. The panels discussing workforce issues in Ohio were composed of physicians, advanced practice registered nurses, physician assistants, representatives from various organizations, the Director of the Ohio Department of Health, and the Medical Director of the Ohio Department of Mental Health. The Board provided information to the legislative subcommittee and the Ohio Department of Health regarding the RN and APRN workforce data collection in past years and the current enhanced initiative for 2013.

Collection of data and the Board's work with the Coalition provides a means to address patient safety and health care issues related to the supply of and demand for nurses and other health care workers. •

APRNS:

Do You Know the Content that Must be Included in Your Standard Care Arrangement?

The Board frequently receives questions from APRNs and institutional credentialing bodies about the content that must be included in a standard care arrangement (SCA), and requests for a SCA form or template. The SCA requirements are contained in Chapter 4723-8, Ohio Administrative Code (OAC). Because the nature of the SCAs, a practice-specific, and legally required agreement between the certified nurse midwife, certified nurse practitioner, and clinical nurse specialist (APRN) and their respective collaborating physician(s) or podiatrists, it is not possible for the Board to furnish a template or form for SCAs. SCA content details should be developed jointly between the APRN and the collaborating physician or podiatrist with counsel advice as needed. The Board can provide guidance as to the requirements of the administrative rules, and what must be included in the SCA.

Rule 4723-8-04(B), OAC, requires the APRN to collaborate with a physician or podiatrist whose practice is the same as or similar to the nurse's specialty and enter into a standard care arrangement **before the APRN engages in practice.** The SCA is required to have the signature of the APRN and each collaborating physician, or the signature of one physician if the physician is the designated representative of a group, the date the SCA is executed, the date of the most recent review of the SCA, and the complete name, specialty and practice area, business address, and business telephone All of these items must be addressed within an APRN's SCA in order for the APRN to be in compliance with the nursing law and rules. The Board does not review or approve APRN SCAs before they are executed, but upon request, the APRN must provide a copy of the SCA to the Board for review.

number or number at which each collaborating physician or podiatrist, and APRN who is party to the SCA may be reached at anytime.

The SCA must address:

- A statement of services offered by the APRN.
- A plan for incorporation of new technology or procedures.
- Quality assurance provisions, including at minimum a schedule for periodic review of the SCA, and criteria that warrants a patient's referral to another health care provider. In the case of a certified nurse midwife, a plan for referral of an obstetrical patient with a fetal breech or face presentation.
- A plan for regular review of referrals made by the APRN to other health care professionals, the care outcomes for a representative sample of all patients

seen by the APRN, and a process for chart review if the APRN's practice includes any direct patient care, patient education, or patient management.

- A policy regarding the APRN's care of infants up to age twelve months, and, if the APRN provides care to pediatrics up to age three, recommendations for when those patients' will be seen by the collaborating physician.
- A plan for coverage of patients in instances of emergency or planned absences by either the APRN, or the collaborating physician or podiatrist.
- A process for resolution of disagreements regarding matters of patient management.
- An arrangement regarding reimbursement under the medical assistance program, i.e., Medicaid.

For APRNs who hold a current, valid

certificate to prescribe (CTP holder), there are additional provisions that must also be included in the SCA. These additional requirements are:

- Provisions to ensure timely direct, personal evaluation of the patient with a collaborating physician or podiatrist, or the physician or podiatrist's designee when indicated.
- Additional prescribing parameters for drugs and therapeutic devices contained in the Formulary including: provisions for the use of FDA approved drugs for indications that are not FDA approved (off-label use); provisions for the use of FDA approved drugs reviewed by the committee on prescriptive governance (CPG) subsequent to the effective date of the SCA; provisions for the use of drugs previously reviewed by the CPG but approved by the FDA for new indications subsequent to the date of the

SCA, and provisions for the use and prescription of any schedule II controlled substance medications.

• A procedure for the CTP holder and the collaborating physician, or a designated member of an institution's quality assurance committee composed of physicians, of the institution, organization, or agency where the nurse has practiced during the period covered by the review, to conduct at least a semiannual periodic review of the following: a representative sample of prescriptions written by the CTP holder, a representative sample of schedule II prescriptions written by the CTP holder, and provisions to ensure that the CTP holder is meeting all of the requirements of Rule 4723-9-12, OAC, the standards and procedures for review of the Ohio automated Rx reporting system (OARRS).

All of these items must be addressed

within an APRN's SCA in order for the APRN to be in compliance with the nursing law and rules. The Board does not review or approve SCAs before they are executed. However, Rule 4723-8-04(13) (D), OAC, requires the most current copy of the SCA to be retained and readily available upon request at each site where the APRN is engaged in practice. Upon request of the Board, the APRN must provide a copy of the SCA to the Board.

The Board cannot provide legal services in reviewing/approving the practice-specific language that is included in the SCA, but will answer questions about the SCA requirements. APRNs seeking additional advice beyond the information that the Board can provide about developing a SCA or about specific language to include may wish to contact one of the APRN professional associations, the legal department at the APRN's work setting, or private legal counsel. •

BOARD REVISES INTERPRETIVE GUIDELINE "Role of the Registered Nurse in Monitoring Obstetrical Patients Receiving Epidural Infusions"

At the Board's March 2013 meeting, the Board reviewed and revised the Interpretive Guideline (IG) "Role of the Registered Nurse in Monitoring Obstetrical Patients Receiving Epidural Infusions." The Board reviews its existing IGs every two years to ensure the IG under review remains relevant to current nursing practices and consistent with nursing law and rules. Prior to the Board's review, a public announcement of the IGs scheduled to be reviewed is sent via eNews, with an invitation for public input or comment. The IG regarding monitoring obstetrical patients receiving epidural infusions was one of five IGs scheduled for Board review at its March. 2013 meeting. The other four IGs: Guidelines for the Care of Patient's Receiving Intramuscular, Subdermal, or Subcutaneously Injected Medications for Cosmetic/ Aesthetic Treatment; Guidelines for Registered Nurse Performance of a History and Physical Examination for Purposes of Providing Nursing Care; Guidelines for Monitoring and Management of Epidural Infusions (non-obstetrical); and Guidelines for Conservative Sharp Wound Debridement were re-approved without revision.

After review and discussion of the public comments received regarding monitoring obstetrical patients receiving epidural infusions, the Board determined that a revision was necessary to make the IG consistent with the existing Association of Women's Health, Obstetric and Neonatal Nurses position. The IG was revised by inserting language that a registered nurse may not decrease the infusion rate of the epidural infusion, and may only stop the continuous infusion after the patient has given birth, or if complications arise and the nurse needs to intervene immediately.

In developing, approving and revising IGs regarding specific nursing activities or procedures, the Board is not creating a new policy. Rather the Board uses IGs to give licensees specific instruction regarding existing law. An IG is not a regulation of the Board, and does not carry the force and effect of law. An IG is adopted by the Board as a guideline to licensees who seek to engage in safe nursing practice.

The revised Interpretive Guideline is provided below:

Guideline for Intrapartum Monitoring of Obstetrical Patients Receiving Epidural Infusions

The registered nurse should not assume care of the epidural infusion of an intrapartal patient until the anesthesia provider who placed the catheter has verified and documented correct catheter placement, the vital signs of the patient and fetus have stabilized, and the infusion has been initiated. Monitoring sedation levels, analgesic effect, and other clinical parameters of patients receiving epidural infusions may be within the scope of registered nursing practice if the following guidelines are observed (section 4723.01 (B) ORC):

- A. With a valid order from an authorized anesthesia provider, the registered nurse may:
 - Administer and monitor medication infused through an epidural catheter;
 - Replace a bag or syringe with identical, Pharmacy prepared solution containing the same medication and concentration;
 - 3. Stop the continuous infusion after the patient has given birth;
 - Remove the epidural catheter after delivery, if the catheter insertion was documented as uncomplicated and no catheter-related complications have occurred.
- B. In executing a nursing regimen, the registered nurse should:
 - Monitor the patient's vital signs, mobility, level of consciousness, and perception of pain;
 - 2. Monitor the status of the fetus;
 - Communicate any changes in patient or fetal status to the anesthesia provider as indicated by institutional policy;
 - Stop the continuous infusion if complications arise and initiate emergent therapeutic measures.

The registered nurse caring for an intrapartal patient receiving an epidural infusion should not:

 prepare solutions for infusion, increase the rate of infusion, inject, *continued on page 12* bolus, or rebolus the epidural infusion, or re-initiate an infusion once it has been stopped;

- remove the following types of epidural catheters:
 - a tunneled epidural catheter;
 - an epidural catheter with exposed metal;
 - a spinal cord stimulator placed in the epidural space; or
- □ insert or reposition an epidural catheter.

Considerations in Providing Care to Obstetrical Patients Receiving Epidural Infusions: (Rule 4723-4-03 OAC)

1. The registered nurse providing care to obstetrical patients receiving intrapartum epidural infusions should maintain documentation of his/her acquisition of education and demonstrated competency, and other documentation required to ensure that practice is in compliance with written employer/ institutional policies and procedures. A licensed anesthesia provider should be readily available as defined by employer/institutional policy, to manage any complications that might arise when the registered nurse is monitoring or administering intrapartal epidural infusions.

- 2. The registered nurse's education/training and demonstrated competence should include, but is not limited to, the following:
 - a. Epidural anatomy and physiology;
 - Indications, contraindications, and potential complications related to analgesia technique or medications relative to the patient or fetus;
 - c. Pharmacology of analgesia medications administered during the intrapartum period via the epidural route;
 - d. Catheter maintenance and removal;

- e. Utilization of appropriate monitoring modalities, infusion devices, and related equipment;
- f. Patient care responsibilities during intrapartal epidural infusions including, but not limited to: observation and monitoring of sedation levels and other patient/ fetal parameters; applicable teaching for patients and family/significant other; and other nursing care responsibilities as defined and approved in the employer/institutional policy.

Accountability and Responsibility of Registered Nurses

Section 4723.01(B) of the Ohio Revised Code (ORC) defines the scope of practice for the registered nurse. Rule 4723-4-03, Ohio Administrative Code (OAC) holds registered nurses responsible for main-

taining and demonstrating current knowledge, skills, abilities, and competence in rendering nursing care within their scope of practice. The registered nurse must apply the Nurse Practice Act (Chapter 4723, ORC) and rules regulating the practice of nursing (Chapters 4723-1 to 4723-27, OAC) to the specific practice setting. Further, the registered nurse must utilize good professional judgment in determining whether or not to engage in a given patient-care related activity, consistent with the law, rules, and guided by the Board's Decision-Making Model, Publication OBN-103. It is critical to note that the law and rules require that the licensee provide nursing care only in circumstances that are consistent with their education, experience, knowledge, and demonstrated competency.

In this statement the Board does not announce a new policy but instead gives licensees specific instructions regarding their obligations under existing law and rules.

Licensees should review the following:

- Section 4723.01(B), Ohio Revised Code

MEMBERSHIP ON THE OHIO BOARD OF NURSING OR BOARD ADVISORY GROUPS

THE OHIO BOARD OF NURSING

The Ohio Board of Nursing is a regulatory agency established by Ohio law to regulate the practice of nursing in the State. The mission of the Board is to actively safeguard the health of the public through the effective regulation of nursing care. This includes regulation of nursing education programs, and individual licensure, advanced certification, practice and compliance with legal standards. In addition to licensed nursing, the Board regulates dialysis technicians, community health workers, and medication aides.

The Board is composed of 13 members. By law, eight members must be registered nurses, four must be licensed practical nurses, and one member must be a non-nurse representing the interests of consumers of healthcare. To qualify as a licensed nurse member of the Board, an To qualify as a licensed nurse member of the Board, an individual must be licensed to practice in the State of Ohio, and have been actively engaged in nursing practice for five years immediately preceding the appointment.

individual must be licensed to practice in the State of Ohio, and have been actively engaged in nursing practice for five years immediately preceding the appointment. Members are appointed to serve a fouryear term and may be re-appointed to serve an additional term. Members are required by Ohio law to attend a minimum of three-fifths of all regular and special meetings held during a two-year period. Members are compensated for their time in attending public meetings according to a statutory rate, and receive reimbursement for expenses.

Appointments to the Board are made by the Governor. Information regarding the appointment process, including vacancies and the Boards and Commissions Application, are available on the Governor's website at: *www.governor.ohio. gov* under the Administration/Boards and Commissions link.

OHIO BOARD OF NURSING ADVISORY GROUPS

The Board maintains a number of Advisory Groups that provide recommendations to the Board on various issues and programs, including:

- Continuing Education
- Dialysis
- Nursing Education
- Committee on Prescriptive Governance Advisory Groups are similar to "standing committees." They meet several times

a year, or more often as requested by the Board, to provide advice regarding the regulation of on-going Board programs. Advisory Groups are composed of public members, a Board member who serves as the chairperson, and Board staff. Members of Advisory Group members are not compensated for their time, but they receive their actual and necessary expenses incurred in the performance of their official duties The Board will appoint members to the 2011 Advisory Groups during the November 2010 Board meeting. COMPLIANCE UPDATE ADVANCED PRACTICE REGISTERED NURSES

Section 4723.28 of the Ohio Revised Code (ORC), requires that the Board investigate evidence that appears to show that any person has violated any provision of Chapter 4723 of the Ohio Revised Code, or any rule of the Board in accordance with Chapter 4723 of the Ohio Administrative Code (OAC). When the Board receives a complaint regarding an Advanced Practice Registered Nurse (APRN), an investigation may occur. During the course of the investigation, the APRN may be asked to provide documentation to the Board to determine compliance with certain requirements specific to APRN practice or prescribing provisions. APRNs should be aware of the following requirements, since failure to practice under these provisions may result in disciplinary action, according to Section 4723.28 of the Ohio Revised Code.

- Each practicing APRN is required to participate in a quality assurance process, and is legally required to immediately provide documentation, satisfactory to the Board, of such participation upon request of the Board (Rule 4723-8-05, OAC).
- The most current copy of the standard care arrangement is required to be retained, and be immediately available upon request of the Board, at each site where the practice of the certified nurse-midwife (CNM), certified nurse practitioner (CNP), or clinical nurse specialist (CNS) occurs (Rule 4723-8-04, OAC).
- Annually, each CNM, CNP, and CNS is required to verify the licensure and,

if applicable, board certification status of each collaborating physician or podiatrist with whom there is a standard care arrangement (Rule 4723-8-05, OAC). Verification of the physician or podiatrist licensure and certification status may be obtained from the State Medical Board of Ohio or an employing institution, organization, medical group practice, or agency. The CNM, CNP, or CNS is required to document that such verification was obtained upon request of the Board.

Additionally, each CNM, CNP, or CNS who holds a certificate to prescribe (CTP) or CTP-Externship, may be asked to show proof of registration with the Ohio Automated Rx Reporting System (OARRS), and show, through documentation in the patient's medical record and the standard care arrangement, that he or she is in compliance with the provisions specific to prescribing schedule II and other controlled substances (Rule 4723-9-12, OAC).

Lastly, APRNs should be aware of the Medical Board's Rules on Drug Treatment of Intractable Pain (Rule 4731-21, OAC), as each APRN is required to utilize and incorporate into their practice knowledge of Chapter 4731 of the Ohio Revised Code and the rules adopted under these Chapters that govern the practice of the APRN's collaborating or supervising physician or podiatrist (Rule 4723-8-02, OAC).

RN AND ADVANCED PRACTICE REGISTERED NURSE RENEWAL

This is a final reminder that if you are a RN or advanced practice registered nurse (APRN) in Ohio, your license will lapse after August 31, 2013. A lapsed license is one that was not renewed by the deadline, and thus "expires" without any communication from the licensee or certificate holder. If you do not intend to practice nursing in Ohio, temporarily or permanently, you may notify the Board in writing (including e-mail and fax) that you are requesting that your license be placed on "inactive" status, or check the box on the paper renewal application that requests "inactive" status.

All RNs who were eligible to renew their license, certificate of authority (COA), and certificate to prescribe (CTP) this year, were sent a renewal notice through the mail in May to the address of record with the Board. APRNs were mailed one notice for their RN license and their COA, and an additional notice, if applicable, for a CTP. To reduce the delay between online renewal submission and the online verification of COAs, APRNs are required to renew their RN, each COA, and CTP, if applicable, <u>sepa-</u> <u>rately</u> within the system.

The format for the renewal notice was new this year. Instead of a letter, the Board mailed out perforated sealed envelopes. This included your personal ID, password, and instructions on how to renew your license/certificate online. When renewing online you can pay the required application fee using Master Card or VISA credit cards, or debit cards with a MC or VISA logo. By utilizing the online renewal process, you may be able to verify the renewal of your license/ certificate through the Board's website at www.nursing.ohio.gov in as little as three business days after completing the online renewal application. RNs and APRNs who do not want to renew their license/certificate online must submit a written request for a paper renewal application by e-mail at renewal@nursing.ohio.gov, fax at (614) 466-0388, or by mailing the request to the Board. Telephone requests will not be accepted.

Renewal fees are as follows: July 1, 2013 through August 31, 2013 (includes late processing fee) RN - \$115 APRN – each COA - \$135 CTP - \$50 After August 31, 2013 – you must request a reinstatement packet

The Board audits nurses each year to determine compliance with continuing education (CE) requirements. If you were notified of an audit of your CE for the period of September 1, 2009 through August 31, 2011 and have not submitted the information required by the Board, you will not be eligible to renew for 2013-2015 until you complete the audit requirements.

Board staff are available to assist you in taking the necessary steps to renew your license/certificate. NAME/ADDRESS CHANGES

How do I change my name with the Board?

You must submit a certified document of a name change (i.e. marriage certificate/abstract, divorce decree/dissolution, name change document) **within thirty days of the change**. Certified documents can be obtained from the court where the original record was filed. Photocopies or notarized copies are **not** **acceptable** for a name change. Submit your certified document with a "Name/ Address Change Form" or with a brief letter which includes your Ohio license/ certificate number, your previous name, your new name as you want it to appear on Board records, your current address, county and telephone number. A Name/ Address Change Form is available on the Board's website at *www.nursing.ohio*. *gov* at the "Change Your Name/Address" link. Any name change documents must be mailed to the Board. The Board will return your certified document. There is no fee for a name change.

How do I change my address with the Board?

Address changes must be submitted in writing within thirty days of the

change. Submit your address change with a "Name/Address Change Form" or with a brief letter, which includes your name, Ohio license/certificate number, address, county and telephone number. A Name/Address Change Form is available on the Board's website at *www.nursing.ohio.gov* at the "Change Your Name/Address" link. If you wish to verify that your address has been changed, call the Board at (614) 466-3947 for verbal verification. There is no fee for an address change.

ADVANCED PRACTICE REGISTERED NURSE NATIONAL RECERTIFICATION

If you are an advanced practice registered nurse,* your certificate of authority (COA) is current and valid only if you meet all requirements of the Board, which includes maintaining certification by the applicable national certifying organization (please refer to the Board's website at *www.nursing.ohio. gov* for a list of Board approved national organizations). The Board requires primary source verification for advanced practice registered nurse national recertification. For this to occur, you must request that your national certifying organization notify the Board directly of national recertification within thirty days of your recertification. The Board will not accept documentation of recertification from a COA holder.

*An exception to this requirement applies to CNS certified by the Board on or before December 31, 2000.

OHIO AUTOMATED RX REPORTING SYSTEM (OARRS)

APRNs are reminded that Board Rule 4723-9-12, Ohio Administrative Code, sets forth certain situations which require review of OARRS prior to prescribing or personally furnishing a controlled substance or tramadol to a patient. BOARD DISCIPLINARY ACTIONS

- **Permanent Revocation** = Prohibited from ever practicing nursing or dialysis care, or working as a certified community health worker or certified medication aide.
- **Indefinite Suspension** = Indefinitely prohibited from practicing for a specified minimum period of time. The Board will reinstate only if all conditions for reinstatement, set at the time the action was taken, are met.
- Automatic Suspension = Suspension for a violation of a consent agreement or Board order or suspension required by law for commission of a specified felony.
- Immediate Suspension = Suspension required by law for a felony drug abuse offense.
- Indefinite suspension with a stay = On "probation." May practice if the license status is active but will be monitored by the Board under conditions and restrictions.
- **Restrictions** = Limits such as prohibition from passing narcotics or working in certain areas of practice.
- **Reprimand** = Least amount of discipline. Acknowledgment that what the nurse, dialysis technician or community health worker did was wrong. Does not prohibit practice.
- **Voluntary surrender** = May not ever practice again. Permanent action following a formal agreement by the nurse, dialysis technician, medication aide or community health worker to give up the license or certificate.
- **Fines** = A fine of up to \$500 imposed for each violation.


