The Ohio Board of Nursing

supports the Governor and General Assembly initiatives for veterans, many of which are set forth in the *Valuing Ohio Veterans, Executive Order 2013-05K Recommendations* Report. The Board is pleased that we have streamlined licensure processes for veterans and their spouses through the following actions:

- Implemented a new policy to decrease the processing time for military veterans and nurses licensed in other states seeking reciprocity by "endorsing" their out-of-state licenses into Ohio.
- Revised all applications, so military trained personnel and/or their spouses may indicate their military status on the application to enable Board staff to prioritize the application for immediate processing upon receipt.
- Established a dedicated web page for Military and Veterans on the Nursing Board website to assist military personnel in locating pertinent information for them and/or their spouses.
- Amended administrative rules to require nursing education and dialysis, medication aide and community health worker training programs to establish policies for review of military education and training, and also require education and training programs to award the student credit for any military education or skills training that is substantially similar to the curriculum established in rule.
- Assured that licensure and certification examinations are on the

Department of Veterans Affairs qualified list of non-federal government licensure and certification examinations allowing eligible veterans and their dependents to be reimbursed for the cost of the test. This includes testing for registered nurses, practical nurses, dialysis technicians, and medication aides.

- Amended administrative rules to specify that renewal and reinstatement fees for active duty military personnel or spouses be waived, according to Ohio law, for licensed practical nurses, registered nurses, advanced practice registered nurses, dialysis technicians, medication aides and community health workers.
- Amended administrative rules to provide for time extensions to complete continuing education for nurses, dialysis technicians, community health workers, and medication aides called to active duty, equal to the number of months spent in active duty.

We are proud that the Board received positive feedback regarding the new processes to assist veterans and spouses. For example, the Board received a handwritten thank you from a veteran: "Thank you for being so helpful. You have made this a simple easy process for veterans coming home."

On behalf of my Board colleagues, a sincere thank-you to all military personnel, veterans, and spouses! •

This summer the Board is in its peak season for LPN renewal, and licenses must be renewed online. Thank you for all who have already renewed, and for those who have not, please renew as soon as possible and avoid your license lapsing on August 31, 2014, the renewal deadline.

This time of the year is also the peak season for individuals applying for initial nursing licensure. Each fiscal year since 2008, newly licensed registered nurses and licensed practical nurses in Ohio have increased by an average of 14,000! To address the challenge of streamlining initial licensure processes, the Board is piloting an online licensure application for LPNs. Once fully operational, the Board will expand this process for registered nurses and others who are licensed or certified by the Board.

This year a number of legislative initiatives and Ohio Administrative Code rule changes impact APRNs with prescriptive authority (CTP holders) and other prescribers, as Ohio continues to fight drug abuse and opioid prescribing abuses. While this issue of *Momentum* highlights important information for prescribers, the Board encourages APRNs with prescriptive authority to review the legislation and administrative rules, and refer to the Board web site at *www.nursing.ohio.gov.* The Board has estab-

ARE REGISTERED NURSES AND LICENSED PRACTICAL NURSES REQUIRED TO INITIATE CPR?

The most direct response is: Yes, unless there is a "do not resuscitate order," licensed nurses are required to initiate cardiopulmonary resuscitation (CPR) and take actions necessary to intervene or rescue the patient when the nurse's patient is found in cardiopulmonary arrest. In the absence of a do not resuscitate order, a licensed nurse is required to perform CPR, and take other actions necessary to intervene, until one of the following occurs: the patient's cardiopulmonary functions are restored and the nurse's care focuses on the patient's stability and other necessary actions; an order has been received to stop CPR and the other life-preserving interventions; or the CPR and other emergency interventions have been continued by other qualified health care providers.

Although a nurse is authorized to observe, describe, recognize, and intervene when this most serious of complications occurs, except as discussed below in regards to Section 4723.36, ORC, a nurse cannot legally determine that a patient has expired and withhold CPR based on that determination, because that determination is considered to be a medical diagnosis. Section 4723.151, Ohio Revised Code (ORC), prohibits a nurse from providing a medical diagnosis, prescribing medical measures, and practicing medicine or surgery or any of its branches.

For a do not resuscitate order to be considered valid for implementation it must be obtained prior to any possible need to initiate CPR. In other words, a nurse may not withhold CPR when it is otherwise indicated and subsequently obtain a do not resuscitate order.

licensed practical nurses, require the licensed nurse to demonstrate competence and accountability in all areas of practice in which the nurse is engaged including (1) consistent performance of all aspects of nursing care; and (2) recognition, referral or consultation, and intervention when a complication arises.

Rule 4723-4-07, OAC, for registered nurses and Rule 4723-4-08 for licensed practical nurses address the implementation and application of the nursing process through which the nursing needs of the patient are to be addressed. If a licensed nurse has reason to believe that the patient's documented health care information necessitates further discussion and consultation with the patient's health care provider, the patient and significant others, for purposes of determining end of life care including whether a do not resuscitate order is appropriate, the nurse is required to engage in this process.

Effective March 22, 2013, Section 4723.36, ORC provides a very limited authorization for a registered nurse to determine and pronounce a patient's death if: (1) The patient's respiratory and circulatory functions are not being artificially sustained; and (2) The nurse is providing or supervising the patient's care through a licensed hospice program or through an entity that provides palliative care. When a registered nurse is acting under this section of the law, the registered nurse is required to notify the attending physician of the determination and pronouncement of death within a reasonable period of time, but not later than twenty-four hours following the determination and pronouncement of death. In this situation, a registered nurse is still responsible for verifying that the patient's record includes a do not resuscitate order, the nurse is still responsible for complying with the Standards of Nursing Practice contained in Chapter 4723-4, OAC.

In the absence of a "do not resuscitate order," registered nurses and licensed practical nurses do not have the ability to determine that a patient has expired or to determine the "futility" of CPR. Even when a registered nurse acts in accordance with Section 4723.36, ORC, the hospice or palliative care nurse would be required to have a do not resuscitate order. In circumstances unrelated to licensed hospice care or palliative care, the decision to stop CPR must be determined by a physician and a physician's order. Further, for a do not resuscitate order to be considered valid for implementation it must be obtained prior to any possible need to initiate CPR. In other words, a nurse may not withhold CPR when it is otherwise indicated and subsequently obtain a do not resuscitate order.

Note that it is the nurse's personal choice as to whether he/ she offers bystander assistance in performing CPR, because if the individual is not the nurse's patient, there is no nurse-patient relationship, and the nurse has no obligation under the Ohio Nurse Practice Act to initiate CPR. However, the nurse's employer or facility may have policies or requirements that apply to providing bystander assistance.

For more information about the law related to the limited circumstances in which a registered nurse may determine and pronounce death, see Section 4723.36, ORC. NEW REQUIREMENTS FOR APRNs WITH PRESCRIPTIVE AUTHORITY (CTP HOLDERS)

The appropriate treatment of pain is a priority in Ohio. Effective pain management, however, needs to be balanced against Ohio's opioid drug abuse epidemic. The Governor's Cabinet Opiate Action Team (GCOAT), the Nursing Board, and a group of professional health care provider regulatory boards, associations, individual providers and other key stakeholders have focused efforts on educating health care professionals and patients. The goal of this educational effort is to help reduce and eliminate the misuse and abuse of opioid drugs.

The Nursing Board has established a link on the front page of its website, "Prescriptive Authority Resources" (www. *nursing.ohio.gov/Practice.htm*#*CTP*) to provide faster access to resources supporting prescriber awareness and education. In addition, the Ohio State Board of Pharmacy announced earlier this year the availability of the Practice Insight Report as a part of the Ohio Automated Rx Reporting System (OARRS). This report provides prescribers improved access to obtain prescription data information about their patients. It was designed after feedback from prescribers who regularly use OARRS.

There are recent legislative and rules changes to be aware of:

 It is important that all CTP holders with authority to prescribe controlled substances register for OARRS. The Board encourages you to register immediately so you practice in compliance with Rule 4723-9-12, OAC, and



additional legal requirements that go into effect April 1, 2015. For more information on OARRS, go to https://www.ohiopmp.gov/Portal/Brochure.pdf. To register for OARRS, go to http://www.ohiopmp.gov.

HB 341 imposes new legal requirements for CTP holders. First, CTP holders who hold appropriate DEA certification and prescribe opioid analgesics or benzodiazepines are required to register with OARRS not later than January 1, 2015, and certify to the Board at the time of license renewal that they are registered. Second, beginning April 1, 2015, the prescriber, before initially prescribing or personally furnishing an opioid analgesic or a benzodiazepine, must request patient information from OARRS that covers at least the previous

12 months, and make periodic requests for patient information from OARRS if the course of treatment continues for more than 90 days. Exceptions to the requirement to check OARRS under these circumstances include drugs prescribed to hospice or cancer patients, drugs to be administered in hospitals or long-term facilities, drugs to treat acute pain from surgery or a delivery, and drug amounts for use in seven days or less. The law further requires the Nursing Board to verify that licensees prescribing in this manner are registered and using OARRS appropriately. Violations of these legal requirements may subject licensees to discipline.

• Effective August 18, 2014, tramadol and products containing tramadol will be classified as Schedule IV controlled substances in the state of Ohio pursuant to a rule adopted by the United States Drug Enforcement Agency.

APRNs with prescriptive authority will continue to be able to prescribe tramadol and products containing tramadol, in accordance with the Formulary. However, you should be aware of the requirements in preparation for the change in the drug classification. For example, because tramadol and products containing tramadol will be classified as controlled substances, APRNs prescribing these products will need to obtain a DEA number, if you do not have one already. For specific information, review the guidance document at http:// www.pharmacy.ohio.gov/Contact.aspx.

• HB 314, effective September 16, 2014, establishes an explicit informed consent requirement for prescribers who, in the absence of a medical emergency, intend to prescribe controlled substances that contain opioids to minors. Case Western Reserve J N I V E R S I T Y form) separate from any other document the prescriber uses to obtain informed consent. There are limited, narrow exemptions to these requirements, including when the minor's treatment is incident to a medical emergency, is incident to surgery, and is rendered in a hospital, nursing home, pediatric respite care program, or similar institutional facility. Violations of these legal requirements may subject licensees to discipline.

• HB 483, effective September 16, 2014, permits a prescriber to request information from OARRS relating to the mother of a newborn or an infant patient if the purpose of the request is for providing medical treatment to the newborn or infant patient following their being diagnosed as opioid dependent. The rationale for this permitted use of OARRS is to provide another source of information to address neonatal abstinence syndrome (NAS) in Ohio newborns. NAS results from a series of problems that occur in newborns following their exposure to addictive drugs while in the mother's womb.

As noted above, recent legislative initiatives and Ohio Administrative Code rule changes continue to target prescribing of opioids, benzodiazepines and other drugs that can be dangerous when misused or abused. The Board strongly encourages CTP holders to review legislation and administrative rules regularly to keep current with laws governing their practice. Licensees are reminded to refer to the Board web site at www.nursing. ohio.gov as another way to keep current with new and changing legal requirements.

NURSING LICENSURE AND EMPLOYMENT

The Board of Nursing (Board) receives frequent questions related to employment. For example, many questions relate to whether an individual may accept a position that does not require a nursing license, or involve practicing at a level below an individual's highest level of licensure. The Board does not regulate employer-employee issues such as salary, work hours, or position descriptions in general. Some of the ways that the Board regulates nursing practice is by ensuring that only qualified individuals are issued a nursing license, that licensed nurses engage in practice within the scope and according to the standards of their nursing license, and that the recipients of nursing care know the licensure level of the individuals responsible for their nursing care.

The responses to the questions below address these types of regulatory issues. General labor or employment issues, or policies implemented by an institution/ employer may also affect employment.

Question #1: I have a registered nursing license, but would like to accept employment that does not require a nursing license. The position description includes responsibilities that are the same or similar to that of a nurse aide. Am I allowed to work in this capacity? Do I have to tell patients that I am a RN?

Answer #1: The Nurse Practice Act does not prohibit a licensed nurse from accepting employment that does not require a nursing license. An individual who chooses nonnursing employment, especially in places where nursing care is provided, should not identify him/herself as a licensed nurse or engage in the licensed practice of nursing, as patients would need to know whom they should look to for licensed nursing care. Should the individual identify him/herself as a licensed nurse or perform any activity

Storing your fingerprints saves you valuable time and gas! included in Section 4723.01(B), Ohio Revised Code (ORC) for RNs, or Section 4723.01(F), ORC for LPNs, the Board would consider the individual to be engaging in the licensed practice of nursing, and would hold the individual accountable for complying with the Nurse Practice Act and the Administrative Rules regulating nursing practice in Ohio.

Question #2: I recently graduated from nursing school, passed the NCLEX-RN, and received my RN license, but I need employment and want to continue to work for my current employer in my nurse aide position until a licensed nursing position becomes available. Can I do this? Can I continue working in my nurse aide position, but identify myself as a RN?

Answer #2: Answer #1 above also applies to this question. A newly licensed LPN or RN is not prohibited from continuing employment in a position that does not require a nursing license. Once a RN or LPN license has been issued by the Board, the licensee is entitled to identify him/herself as an RN or LPN as applicable, however, in order to avoid misleading patients, you should not identify yourself as a licensed nurse unless you are working in that capacity.

Question #3: Can a licensed nurse work as a State Tested Nurses Aide?

Answer #3: Answer #1 also applies to this question. State Tested Nurses Aides (STNA)s are individuals who have received specific nursing assistant instruction and have met other requirements that permit them to be registered with *continued on page 16*

the Ohio Department of Health, enabling the individual to be employed as nursing assistants in certain long-term care settings. For more information about the Nurse Aide Registry please refer to the Ohio Department of Health website.

Question #4: I hold both active RN and LPN licenses. Can I accept an LPN position rather than RN employment where my nursing responsibilities are that of an LPN? Answer #4: The Nurse Practice Act does not prohibit an individual who holds both a RN and LPN license from accepting a LPN position and thus limiting the individual's nursing practice to that level. However, the individual should identify him/herself as a LPN and limit the practice to that of a LPN, so that patients and the public know the level of nursing care that is to be provided to them.

Question #5: I have a certificate of authority to practice as an Advanced Practice Registered Nurse, can I still practice as a RN? What if I choose to work as an RN and not utilize my certificate of authority?

Answer #5: All APRNs are registered nurses and are required to practice according to the standards of practice contained in Chapter 4723-4, Ohio Administrative Code, as well as adhering to the requirements that authorize them to practice in their

advanced practice roles. An individual, who chooses not to utilize their certificate of authority as an advanced practice registered nurse, or who seeks employment that that does not involve advanced practice and otherwise seeks to limit his/her role to that of a RN, may accept a RN position. In doing so, the nurse should identify him/ herself as a RN, and not as an APRN, and contain their nursing practice within the RN scope defined in Section 4723.01(B), ORC, rather than the advanced scope that is in Section 4723.43, ORC. At anytime an individual engages in APRN practice or holds him/herself out as an APRN, the individual is accountable for adhering to all aspects of the scope, requirements and standards of practice for APRN practice, including but not limited to, providing care that is within the nurse's formal education, national certification, standard care arrangement or supervision as applicable to the type of APRN. •

IMPLEMENTATION OF ORDERS BY AN LPN



Question: I am an LPN working on a hospital unit with Advanced Practice Registered Nurses (APRNs) and Physician Assistants (PAs). Both the APRNs and PAs are writing orders. Can I follow orders to administer medications and treatments written by APRNs and PAs?

Answer: LPNs can legally follow orders to administer medications and treatments authorized by APRNs and PAs. The Nurse Practice Act specifies that LPNs may implement orders to administer medication and treatments from "an individual who is authorized to practice in this state, and is acting within the course of the individual's professional practice...." [Section 4723.01(F) (3), ORC]. Individuals who are statutorily authorized to order the administration of medications and treatments include, among others, APRNs and PAs. Regarding the implementation of medication orders, the authorizing APRN or PA must hold a certificate to prescribe, and the LPN must be licensed to administer medications.

Question: Whom should I contact if I have additional questions?

Answer: The Ohio Board of Nursing regulates LPN, RN, APRN nursing practice in Ohio, so contact the Nursing Board regarding the LPN role and practice. For information regarding nursing practice, please refer to the Board's website, *www.nursing.ohio. gov*, or if you have questions, email the Board at *practice@nursing.ohio.gov*. Individuals who are statutorily authorized to order the administration of medications and treatments include, among others, APRNs and PAs.

The Ohio State Medical Board regulates physicians and PAs, among other professionals, so for questions regarding physician and PA practice, please refer to the Medical Board web site at *www.med.ohio*. *gov* for medical practice information and contact information. •

2014 LPN RENEWAL

Current active LPN licenses in Ohio lapse after August 31, 2014. A lapsed license is one that was not renewed by the deadline, and thus "expires". If you do not intend to practice nursing in Ohio, temporarily or permanently, you may notify the Board in writing (including e-mail and fax) that you are requesting that your license be placed on "inactive" status.

All LPNs who were eligible to renew their license this year were sent a renewal notice through the mail in May to the address of record with the Board. The format for the renewal notice for LPNs was new this year. Instead of a letter, the Board mailed out perforated sealed envelopes. This included your personal ID, password, and instructions on how to renew your license/certificate online. In addition, this year you were able to access your User ID and Password for online renewal through the Board web site at *www.nursing.ohio.gov.* **Starting with the 2014 LPN renewal, all nurses were required to renew their licenses online.**

When renewing online you can pay the required application fee using Master Card or VISA credit cards, or debit cards with a MC or VISA logo. By utilizing the online renewal process, you may be able to verify the renewal of your license through the Board's website at *www.nursing.ohio.gov* in as little as three business days after completing the online renewal application.

Incomplete applications may result in late or lapsed processing fee charges, and delay the renewal of your license. Fees for renewal are as follows:

- July 1, 2014 through August 31, 2014 (includes late processing fee) – \$115
- After August 31, 2014 (contact the Board for a reinstatement application)

The Board audits nurses each year to determine compliance with continuing education requirements. If you were notified of an audit of your continuing education for the period of September 1, 2010 through August 31, 2012 and have not submitted the information required by the Board, you will not be eligible for renewal.

Board staff are available to assist you in taking the necessary steps to renew your license. If you have questions about the renewal process, please contact the Board at (614) 995-5420, by fax at (614) 466-0388, or by e-mail at *renewal@nursing.ohio.gov.* •

ADVANCED PRACTICE REGISTERED NURSE NATIONAL RECERTIFICATION

If you are an advanced practice registered nurse,* your certificate of authority (COA) is current and valid only if you meet all requirements of the Board, which includes maintaining certification by the applicable national certifying organization (please refer to the Board's website at *www.nursing.ohio.gov* for a list of Board approved national organizations). The Board requires primary source verification for advanced practice registered nurse national certification and recertification. You must request that your national certifying organization notify the Board directly of national recertification within thirty days of your recertification. The Board will not accept documentation from a COA holder.

Please note that you may have more than one national certifying organization submit certification or recertification documents on your behalf if it is related to the certificate of authority that you hold (i.e. certified nurse mid-wife, certified nurse practitioner, clinical nurse specialist).

*An exception to this requirement applies to CNSs certified by the Board on or before December 31, 2000.

OHIO AUTOMATED RX REPORTING SYSTEM (OARRS)

APRNs are reminded that Board Rule 4723-9-12, Ohio Administrative Code, sets forth certain situations which require review of OARRS prior to prescribing or personally furnishing a controlled substance to a patient. Note that effective August 18, 2014, tramadol and products containing tramadol will be a schedule IV controlled substance. MILITARY

The Board of Nursing has established a dedicated page on the Board web site for military personnel and spouses. To access the page, click on the "Military and Veterans" link listed on the left side of the home page. The page provides current military personnel and veterans with information about licensure and renewal processes, continuing education, FAQs, and resources. All licensure and certification applications have been revised, so that military personnel, veterans and/or their spouses can indicate their military status on the application to enable Board staff to prioritize the application upon receipt. •

DIALYSIS TECHNICIANS

Effective March 20, 2013, the Board of Nursing no longer issues a series of "temporary certificates," including temporary certificate 1, temporary certificate 2, and temporary certificate 3. The new law requires the issuance of a dialysis technician intern certificate. The intern certificate can be issued if the applicant has not taken the certification examination, but has completed a training program approved by the Board. The intern certificate is valid for a period of time that is 18 months from the date an applicant completed a training program minus any time the applicant was enrolled in any training program(s). The intern certificate cannot be renewed. Other certification requirements include submission of civilian (BCI) and federal (FBI) criminal records checks. An intern certificate holder must pass an examination conducted by a testing organization approved by the Board (BONENT or NNCO) in order to receive an Ohio Certified Dialysis Certificate.

Dialysis technicians from out-of-state can obtain an Ohio Certified Dialysis Certificate if they submit evidence that they passed an examination conducted by a testing organization approved by the Board (BONENT or NNCO), completed two contact hours of continuing education on Ohio law and rules, and have performed dialysis care for at least 12 months immediately prior to the application date. Other certification requirements include submission of civilian (BCI) and federal (FBI) criminal records checks.

REACTIVATION AND REINSTATEMENT OF A NURSING LICENSE

An inactive or lapsed license/certificate may be reactivated at anytime by completing a reactivation/reinstatement application. This includes completing the required paperwork, paying a fee (if applicable), and providing proof of continuing education contact hours. In addition, if a license has been inactive or lapsed for five or more years from the date of application for reactivation/reinstatement, the applicant must complete a civilian (BCI) and federal (FBI) criminal records check. Contact the Renewal Unit at (614) 995-5420 or renewal@nursing.ohio. gov to request a reactivation/reinstatement application. Note that submission of reinstatement and reactivation applications online will be available later this year.

NAME/ADDRESS CHANGES

How do I change my name with the Board?

You must submit a certified court document of a name change (i.e. marriage certificate/abstract, divorce decree/dissolution, name change document) within thirty days of the change. Certified documents can be obtained from the court where the original record was filed. Photocopies or notarized copies are **not acceptable** for a name change. Submit your certified document with a "Name/Address Change Form" or with a brief letter which includes your Ohio license/certificate number, your previous name, your new name as you want it to appear on Board records, your current mailing address, county and telephone number. A Name/Address Change Form is available on the Board's website at *www.nursing.ohio.gov* at the "Change Your Name/Address" link. Any name change documents must be mailed to the Board. The Board will return your certified document. There is no fee for a name change.

How do I change my address with the Board?

Address changes must be submitted in **writing within thirty days of the change**. Submit your address change with a "Name/Address Change Form" or with a brief letter, which includes your name, Ohio license/certificate number, mailing address, county and telephone number. A Name/Address Change Form is available on the Board's website at www. nursing.ohio.gov at the "Change Your Name/Address" link. If you wish to verify that your address has been changed, call the Board at (614) 466-3947 for verbal verification. There is no fee for an address change.



BOARD DISCIPLINARY ACTIONS

- **Permanent Revocation** = Prohibited from ever practicing nursing or dialysis care, or working as a certified community health worker or certified medication aide.
- Indefinite Suspension = Indefinitely prohibited from practicing for a specified minimum period of time. The Board will reinstate only if all conditions for reinstatement, set at the time the action was taken, are met.
- Automatic Suspension = Suspension for a violation of a consent agreement or Board order or suspension required by law for commission of a specified felony.
- Immediate Suspension = Suspension required by law for a felony drug abuse offense.
- Indefinite suspension with a stay = On "probation." May practice if the license status is active but will be monitored by the Board under conditions and restrictions.
- Restrictions = Limits such as prohibition from passing narcotics or working in certain areas of practice.
- **Reprimand** = Least amount of discipline. Acknowledgment that what the nurse, dialysis technician or community health worker did was wrong. Does not prohibit practice.
- Voluntary surrender = May not ever practice again. Permanent action following a formal agreement by the nurse, dialysis technician, medication aide or community health worker to give up the license or certificate.
- Fines = A fine of up to \$500 imposed for each violation.

Below are the Board's actions taken during the last Board meeting. The actions are an accurate representation of information maintained by Ohio Board of Nursing at the time of posting. Because the name of a licensee may be the same as another, please do not assume from the name alone that a particular individual has had disciplinary action.
