I am very proud to have been elected President of the Ohio Board of Nursing and I look forward to serving in this important role. Congratulations to the other elected officers, Janet Arwood, LPN, Vice-President, and Sue Morano, RN, Board Supervising Member for Disciplinary Matters.

At the January Board meeting, the Board welcomed new Board member Janet Fuchs, RN, CNS, to the Board. She is a clinical nurse specialist who has been responsible for ambulatory nursing practice for the Cleveland Clinic Health System.

In addition to electing officers for 2015, the Board appointed Patricia Sharpnack, RN, as the Board Nursing Education Liaison. This Liaison works with Board staff in the review of pre-licensure nursing education programs. The Board also appointed Board Member Chairs for the Advisory Groups: Jane McFee, LPN, Advisory Group on Continuing Education; Maryam Lyon, RN, Advisory Group on Dialysis; and Patricia Sharpnack, RN, Advisory Group on Nursing Education. The Advisory Groups meet periodically throughout the year to provide recommendations to the Board on various programs and issues.

Last year the Board reported on its successful LeanOhio event that identified the "Future State" of licensing. One major change was requiring that all renewals be completed online, which will also be required for 2015. Another major change was implementation of a secure web-based, look-up

system to access passwords and user IDs online for renewal. This innovation enabled licensees to access the information 24/7 and dramatically reduced calls to the Board. For the 2015 renewal, the Board will mail postcard reminders about renewal, and licensees will access their passwords and user IDs online. Watch for the postcards in the spring of this year and renew early!

For APRNs, an important reminder: APRNs must renew their RN license, not just their certificate of authority (COA). APRNs cannot legally practice without renewing both their RN and COA. Also, APRNs renewing their certificate to prescribe (CTP) must renew not only their CTP, but also their RN and APRN license/certificate. In summary, if you renew a COA, you must also renew your RN license. If you renew your CTP, you must also renew your RN license and COA. APRNs must remember to renew all applicable licenses/certificates, because the current state licensing system cannot monitor or alert you if you have or have not renewed all the required licenses/certificates.

- To <u>practice</u>, APRNs must renew <u>both</u> their RN license and COA
- To <u>prescribe</u>, APRNs must renew <u>three</u> things: RN license, COA, and CTP

Legislative initiatives of

2014 and Ohio Administrative Code rule changes continue to target prescribing of opioids, benzodiazepines and other drugs that can be dangerous when misused or abused. The Board established a link on the front page of its website, "Prescriptive Authority Resources" at www.nursing.ohio. gov/Practice.htm#CTP, to provide faster access to resources supporting prescriber awareness and education.

The Board wants to remind prescribers of the following:

- ➤ HB 341 imposes new legal requirements for CTP holders. CTP holders who hold appropriate DEA certification and prescribe opioid analgesics or benzodiazepines were required to be registered with OARRS not later than January 1, 2015. To register for OARRS, go to http://www.ohiopmp.gov.
- ➤ Beginning April 1, 2015, the prescriber, before initially prescribing or personally furnishing an opioid analgesic or a benzodiazepine, must request patient information from OARRS that covers at least the previous 12 months, and make periodic requests for patient information from OARRS if the course of treatment continues for more than 90 days. Exceptions to the requirement to check OARRS under these circumstances include drugs prescribed to hospice or cancer patients, drugs to be administered in hospitals

The Board encourages you to register immediately so you may practice in compliance with Rule 4723-9-12, OAC, and additional legal requirements that go into effect April 1, 2015.

or long-term facilities, drugs to treat acute pain from surgery or a delivery, and drug amounts for use in seven days or less. The law further requires the Nursing Board to verify that licensees prescribing in this manner are registered and using OARRS appropriately.

Violations of these legal requirements may subject licensees to discipline.

It is important that all CTP holders with authority to prescribe controlled substances register for OARRS. The Board encourages you to register immediately so you may practice in compliance with Rule 4723-9-12, OAC, and additional legal requirements that go into effect April 1, 2015. The Board strongly encourages CTP holders to review legislation and administrative rules regularly to keep current with laws governing their practice. Licensees are reminded to refer to the Board web site at www. nursing.ohio.gov as another way to keep current with new and changing legal requirements. •

CTP EXTERNSHIP

A Certified Nurse Practitioner, Certified Nurse Midwife, and Clinical Nurse Specialist, who completed a required pharmacology course, usually within their formal graduate program, may apply for a Certificate to Prescribe Externship (CTP-E). Once the Board issues the CTP-E, the CTP-E holder is authorized to prescribe under the supervision of one or more physicians. The supervising physician provides direct and indirect supervision of the CTP-E holder's prescribing practices. The supervising physician must attest to the CTP-E holder's completion of the externship hours before the nurse may apply for a Certificate to Prescribe (CTP). The CTP does not require direct and indirect supervision, though periodic retrospective reviews of the CTP holder's prescribing practices by the collaborating physician are required.

The regulations pertaining to the CTP-E are located in Chapter 4723-9, Ohio Administrative Code (OAC). Rule 4723-9-01(G), OAC, defines the "externship" as:

The practice relationship, consistent with the standard care arrangement between a nurse who holds a current valid externship certificate to prescribe and one or more licensed physicians during which time the nurse's prescribing activities are reviewed and evaluated by a supervising professional for the purpose of ongoing improvement of the nurse's competence, knowledge, and skill in pharmacokinetic principles and the application of these principles to the nurse's area of practice.

During the externship, a CTP-E holder's prescribing practices must be supervised directly for a minimum of 500 hours



and indirectly for 1000 hours. Of the 500 direct supervision hours, up to 200 hours may be supervised by another APRN who has a CTP and who collaborates with the CTP-E's supervising physician. Therefore, the physician must provide the 1000 hours of indirect supervision and at least 300 hours, or up to 500 hours as applicable, of direct supervision. To achieve the 500 hours of direct supervision the supervising physician or CTP holder must be available on site where the CTP-E holder is engaged in his/her prescribing practices. Indirect supervision is achieved through the supervising physician's timely review of both the prescriptions written by the CTP-E holder and the CTP-E holder's prescribing practices (Rule 4723-9-01(M)(2), OAC).

Questions and Answers:

Question: Does the collaborating physician need to co-sign prescriptions during the externship?

ANSWER: No. The law and rules do not require that the supervising professional cosign prescriptions written by a CTP-E holder.

Question: Is there a special Formulary for CTP-E holders or restrictions on the types of drugs a CTP holder may prescribe?

ANSWER: No. There is one Formulary to be used by both CTP and CTP-E holders. Any restrictions or specialty qualifiers addressed in the Formulary would apply to holders of both CTPs and CTP-Es. A CTP-E holder may prescribe any drug listed in the Formulary as "CTP holder may

prescribe" or "in accordance with the Formulary" consistent with the CTP-E holder's specialty scope of practice and the prescribing parameters addressed in the nurse's standard care arrangement.

Question: Does the CTP-E holder need to be engaging in prescribing practices for the hours to count toward completion of the CTP externship?

ANSWER: Yes. The CTP-E holder's prescribing practices are supervised and evaluated during the externship. If a CTP-E holder does not have the opportunity to prescribe or engage in other prescribing practices, e.g., discontinuing medications, evaluating medication regimens, etc., there is nothing for the supervising physician to attest to having supervised during the externship. Also, a CTP-E holder's observation of another health care provider in the provider's prescribing practice does not qualify as CTP-E holder prescribing practices and would not count toward the supervised practice requirement.

Question: What does it mean for the supervising professional to be "available onsite" during the direct supervision hours?

ANSWER: The administrative rules do not further define the term "onsite." The plain meaning of the word should be used. The supervising professional should be positioned in a location that allows for the CTP-E holder's prescribing practices to be appropriately and directly supervised. In addition, Rule 4723-8-04(C)(12)(a), OAC, requires the standard care arrangement to include provisions ensuring continued on page 10

timely direct, personal evaluation of the patient by the collaborating physician or the physician's designee when indicated.

Question: How often does the supervising physician need to review prescriptions written by a CTP-E holder during the indirect supervision hours?

ANSWER: The rules do not address specific requirements for how often the supervising physician should review the CTP-E holders prescribing practices when indirectly supervising the CTP-E holder. Rule 4723-9-04(E), OAC, requires the standard care arrangement entered into between the collaborating physician and the nurse to specify the frequency of the review needed for appropriate oversight of the nurse's prescribing practices.

THE LAWMAKING PROCESS IN THE STATE OF OHIO

"The lawmaking process in Ohio, as in most other states, involves several steps, including introduction, committee action, floor action, defeat or enactment, approval or disapproval by the Governor, and possible legislative reaction to the Governor's action. Since Ohio's General Assembly is a bicameral, or two-house legislature, several steps must occur in each house consecutively; that is, after the first house completes action on a bill, the bill is sent to the second house where the process is repeated. Enactment occurs after both houses have passed and agreed on identical bills" (A Guidebook for Ohio Legislators - Thirteenth Edition 2013-2014, Ohio Legislative Service Commission). Enactment of a bill into law also requires review by the Governor that commonly results in the bill's signing and becoming law 90 days later, unless an emergency clause is added with a more immediate effective date. If the Governor vetoes a bill, the legislature may override the veto with a greater number of votes than required for enactment.

This process is repeated every two years, a period that encompasses a legislative session of the Ohio General Assembly. The 131st General Assembly began on January 1, 2015 and will conclude at the end of calendar year 2016.

Within the legislative process, the House and Senate have rules that allow for consideration and comment on proposed laws during session, including public hearings. The Board of Nursing monitors legislation and may choose to take a position of opposition or support of any proposed law based on an analysis of



its impact on "the effective regulation of nursing care," consistent with the Board's mission. The Board may also comment on a legislative proposal as an interested party. Interested party testimony usually consists of educating legislators and parties advocating for a proposed law concerning the impact the law may have on the protection of Ohio's citizens and Board operations. The Board provides comment and educates in a number of ways, including discussing issues with legislators, professional licensing boards, professional associations and other interested parties as well as testifying in person or in writing at public hearings before House and Senate committees.

The Board's consideration of legislation is a public process that does not take place in a vacuum. The political process by its very nature requires active par-

ticipation. Throughout the year, the Board informs the public, licensees, certificate holders, and other interested parties about the Nurse Practice Act and administrative rules, proposed statutory and administrative rule changes, and other issues relating to regulation through a variety of means in addition to this newsletter. The Board uses Momentum, its web site, eNews, a web based listsery, and social media to deliver Board information and also designates specific pages on the web site to provide quick links to locate information. The Board primarily reviews legislation at its regularly scheduled public Board meetings.

OHIO DEPARTMENT OF HEALTH: Do Not Resuscitate Comfort Care

In its Summer 2014 issue of Momentum, the Board of Nursing (Board) published an article discussing the requirements for nurses to initiate cardiopulmonary resuscitation (CPR) and to take other actions necessary to intervene or rescue a patient unless there is a "do not resuscitate" (DNR) order. A paramount aspect of nursing practice is a nurse's awareness and understanding of orders specific to a patient's advanced directives and code status that address what actions should or should not be taken by the nurse in the event of the patient's cardiopulmonary arrest, and other aspects of the patient's end of life nursing care. The law and rules specific to a patient's advanced directives and an individual's declaration of his/her code status and how it is communicated to nurses through DNR orders are enforced by the Ohio Department of Health (ODH). Nurses should understand the terms specific to ODH law and rules that impact

patients and the nurse's implementation of a health care provider's valid authorized DNR orders for the patient.

ODH Rule 3701-62-01, OAC, contains definitions specific to DNR Protocol. Below are selected terms and their definitions:

Rule 3701-62-01 (E) "CPR" means cardiopulmonary resuscitation or a component of cardiopulmonary resuscitation, but it does not include clearing a person's airway for a purpose other than as a component of CPR. "Component of CPR" means any of the following:

- 1. Administration of chest compressions;
- 2. Insertion of an artificial airway;
- 3. Administration of resuscitation drugs:
- 4. Defibrillation or cardioversion:
- 5. Provision of respiratory assistance;
- 6. Initiation of a resuscitative intravenous line: and
- 7. Initiation of cardiac monitoring.

Rule 3701-62-01(I) "Do-not-resuscitate order" or "DNR order" means a directive issued by a physician, or by a CNP or CNS as provided in Rule 3701-62-02, that identifies a person and specifies that CPR should not be administered to the person so identified. The donot-resuscitation order shall be implemented in accordance with the do-not resuscitate protocol.

Rule 3701-62-01 (J) "Do-not-resuscitate protocol" or "DNR protocol" means the standardized method of procedure for the withholding of CPR by physicians, CNPs or CNSs, provided in Rule 3701-62-02, and emergency medical service personnel and health care facilities, as adopted ODH rules pursuant to Section 2133.25. ORC. The do-not-resuscitate protocol is specified in an Appendix to Rule 3701-62-05. Treatment other than resuscitative, shall continue to be provided or modified as the individual's con-



dition warrants, in keeping with the individuals treatment plan goals. Rule 3701-62-05(B) states that "under the DNR protocol, a person can be a "DNR Comfort Care" patient or a "DNR Comfort Care- Arrest" patient. For a DNR Comfort Care patient, the DNR protocol Is activated when a DNR order is issued or when a declaration that includes a directive that the declarant not receive CPR becomes effective under Section 2133.03 of the Revise Code. For a DNR Comfort Care-Arrest patient. the DNR protocol is activated when the patient experiences cardiac or respiratory arrest."

A nurse is required by Chapter 4723-4, OAC, to maintain competence and accountability in all areas of practice in which the nurse is engaged, and to timely implement orders unless the nurse believes or has reason to believe the orders are inaccurate, not properly authorized, not current or valid, are harmful or potentially harmful to a patient, or are contraindicated by other documented information. Should any of these contraindications be identified, the nurse is required to seek clarification with the appropriate licensed health care provider. The Ohio Nurse Practice Act and the Administrative Rules adopted thereunder are available for review in their entirety on the Board of Nursing website: www.nursing.ohio.gov under the "Law and Rules" link.

EBOLA

Recent concerns and efforts to identify and isolate any person at high risk of suspected Ebola virus have raised questions from licensed nurses and administrators of various types of healthcare facilities. The Board refers individuals to the guidelines and protocols approved and published by the Ohio Department of Health (ODH) and the Centers for Disease Control (CDC) for the care and treatment of individuals diagnosed with Ebola, and those who are identified at high risk of suspected Ebola.

A licensed nurse should adhere to the ODH/CDC guidelines during any direct contact with persons exhibiting Ebola symptoms to ensure public safety. The degree of initial direct contact by the nurse with the individual should be based upon the individual's presenting symptoms, the facility's capabilities or limitations to continue its evaluation of the individual, and the availability of appropriate levels of personal protective equipment necessary to adhere to the ODH/CDC guidelines.

Name/Address Changes

How do I change my name with the Board?

You must submit a certified court document of a name change (i.e. marriage certificate/abstract, divorce decree/dissolution, name change document) within thirty days of the change. Certified documents can be obtained from the court where the original record was filed. Photocopies or notarized copies are not acceptable for a name change. Submit your certified document with a "Name/Address Change Form" or with a brief letter which includes your Ohio license/certificate number, your previous name, your new name as you want it to appear on Board records, your current mailing address, county and telephone number. A Name/Address Change Form is available on the Board's website at www.nursing.ohio.gov at the "Change Your Name/Address" link. Any name change documents must be mailed to the Board. The Board will return your certified document. There is no fee for a name change.

How do I change my address with the Board?

Address changes must be submitted in writing within thirty days of the change. Submit your address change with a "Name/Address Change Form" or with a brief letter, which includes your name, Ohio license/certificate number, mailing address, county and telephone number. A Name/Address Change Form is available on the Board's website at www. nursing.ohio.gov at the "Change Your Name/Address" link. If you wish to verify that your address has been changed, call the Board at (614) 466-3947 for verbal verification. There is no fee for an address change.

Advanced Practice Registered **Nurse National Recertification**

If you are an advanced practice registered nurse,* your certificate of authority (COA) is current and valid only if you meet all requirements of the Board, which includes maintaining certification by the applicable national certifying organization (please refer to the Board's website at www.nursing.ohio.gov for a list of Board approved national organizations). The Board requires primary source verification for advanced practice registered nurse national certification and recertification. You must request that your national certifying organization notify the Board directly of national recertification within thirty days of your recertification. The Board will not accept documentation from a COA holder.

*An exception to this requirement applies to CNSs certified by the Board on or before December 31, 2000. •

Ohio Automated RX Reporting System (OARRS)

APRNs are reminded that Board Rule 4723-9-12, Ohio Administrative Code, sets forth certain situations which require review of OARRS prior to prescribing or personally furnishing a controlled substance to a patient. Note that in Ohio, effective September 1, 2014, tramadol is classified as a schedule IV controlled substance, and effective October 6, 2014, all hydrocodone products are classified as schedule II controlled substances. For information regarding OARRS, access the following link: https://www.ohiopmp.gov/ portal/Brochure.pdf.

HB 341 imposes new legal requirements for CTP holders. CTP holders who hold appropriate DEA certification and prescribe opioid analgesics or benzodiazepines were required to be registered with OARRS not later than January 1, 2015. To register for OARRS, go to http://www.ohiopmp.gov.

Beginning April 1, 2015, the prescriber, before initially prescribing or personally furnishing an opioid analgesic or a benzodiazepine, must request patient information from OARRS that covers at least the previous 12 months, and make periodic requests for patient information from OARRS if the course of treatment continues for more than 90 days. Exceptions to the requirement to check OARRS under these circumstances include drugs prescribed to hospice or cancer patients, drugs to be administered in hospitals or long-term facilities, drugs to treat acute pain from surgery or a delivery, and drug amounts for use in seven days or less. The law further requires the Nursing Board to verify that licensees prescribing in this manner are registered and using OARRS appropriately. Violations of these legal requirements may subject licensees to discipline. For information about OARRS, go to https://www.ohiopmp.gov/ Portal/Brochure.pdf. •

Reactivation and Reinstatement of a Nursing License

An inactive or lapsed license/certificate may be reactivated/ reinstated at anytime by completing a reactivation/reinstatement application. This includes completing the required paperwork, paying a fee (if applicable), and providing proof of continuing education contact hours. In addition, if a license has been inactive or lapsed for five or more years from the date of application for reactivation/reinstatement, the applicant must complete a civilian (BCI) and federal (FBI) criminal records check. Contact the Renewal Unit at renewal@nursing.ohio.gov to request a reactivation/reinstatement application.

Military

The Board of Nursing has established a dedicated page on the Board web site for military personnel and spouses. To access the page, click on the "Military and Veterans" link listed on the left side of the home page. The page provides current military personnel and veterans with information about licensure and renewal processes, continuing education, FAQs, and resources. All licensure and certification applications have been revised, so that military personnel, veterans and/or their spouses can indicate their military status on the application to enable Board staff to prioritize the application upon receipt. •

2015 RN and Advanced Practice Registered Nurse (APRN) Renewal

If you hold an active RN license, advanced practice certificate of authority (COA), or certificate to prescribe (CTP) in Ohio, your license/certificate is current through August 31, 2015. All

nurses will be required to renew their license/certificate online. By utilizing the online renewal process, you may be able to verify the renewal of your license/certificate through the Board's website at www.nursing.ohio.gov in as little as three business days. When renewing online you can pay the required application fee using Master Card or VISA credit cards, or debit cards with a MC or VISA logo.

All RNs who are eligible to renew their license/certificate this year, will be sent a renewal notice in the mail in the Spring of 2015. The notice will be sent to the address of record with the Board. APRNs will be mailed one notice for their RN license and their COA, and an additional notice, if applicable, for a CTP. It is extremely important to notify the Board of a name and/or address change immediately. An incorrect name and/or address may delay the renewal of your license/certificate. Nurses will access their User ID and Password for online renewal through the Board web site at www.nursing.ohio.gov.

APRNs will be required to renew their RN, each COA and CTP, if applicable, separately within the system. Don't forget to log back into the system if you have an RN license and multiple certificates to renew this year!

It is strongly recommended that you renew your license/certificate as soon as you receive your renewal notice. Incomplete applications may result in late or lapsed processing fee charges, and delay the renewal of your license/certificate. Fees for renewal are as follows:

- Before July 1, 2015 registered nurse - \$65 advanced practice registered nurse - each COA - \$85
- July 1, 2015 through August 31, 2015 (includes late processing fee) registered nurse – \$115 advanced practice registered nurse - each COA - \$135
- Certificate to prescribe \$50
- After August 31, 2015 you must request a reinstatement packet

The Board audits nurses each year to determine compliance with continuing education requirements. If you were notified of an audit of your continuing education for the period of September 1, 2011 through August 31, 2013 and have not submitted the information required by the Board, you will not receive your renewal notice for 2015-2017 until you complete the audit requirements.





BOARD DISCIPLINARY ACTIONS

- Permanent Revocation = Prohibited from ever practicing nursing or dialysis care, or working as a certified community health worker or certified medication aide.
- Indefinite Suspension = Indefinitely prohibited from practicing for a specified minimum period of time. The Board will reinstate only if all conditions for reinstatement, set at the time the action was taken, are met.
- Automatic Suspension = Suspension for a violation of a consent agreement or Board order or suspension required by law for commission of a specified felony.
- **Immediate Suspension** = Suspension required by law for a felony drug abuse offense.
- Indefinite suspension with a stay = On "probation." May practice if the license status is active but will be monitored by the Board under conditions and restrictions.
- **Restrictions** = Limits such as prohibition from passing narcotics or working in certain areas of practice.
- Reprimand = Least amount of discipline. Acknowledgment that what the nurse, dialysis technician or community health worker did was wrong. Does not prohibit practice.
- Voluntary surrender = May not ever practice again. Permanent action following a formal agreement by the nurse, dialysis technician, medication aide or community health worker to give up the license or certificate.
- **Fines** = A fine of up to \$500 imposed for each violation.




