

SUBJECT: Certificate of Authority (COA) Employment Location and Primary Specialty Data Collected During the 2011 Renewal Cycle

During this year's RN renewal cycle, the Board collected COA credential holder's specialty and employment location data as part of the mandatory renewal questions. The responses from those who renewed during that period have been tabulated and summarized for your review.

There are approximately 9,627 active COA holders, which constitute approximately 5% of all RNs holding an active license. Of the total number of certificate holders less than 1% have more than one certificate. Additionally, almost 50% of the 9,627 COA holders either maintain or are in the externship process for obtaining their Certificate to Prescribe (CTP).



There are 2,417 nurse anesthetists, 5,466 nurse practitioners and 1,581 nurse specialist certificates active. Both nurse practitioners and nurse specialists have various areas of specialization.

During the 2011 renewal cycle, nurse specialists and nurse practitioners were asked to self report their primary area specialization. The information in table below does not reflect approximately 8% of the currently active COA population who either indicated they were not working in an advanced practice capacity or were initially awarded their COA during the renewal cycle and therefore not subject to the 2011 renewal application.
