The Real Warriors Campaign is an initiative launched by the Defense Centers of Excellence for Psychological Health and Traumatic Brain Injury (DCoE) to combat the stigma associated with seeking psychological health care and treatment. The Real Warriors Campaign encourages servicemembers to increase their awareness and use of the resources available. The campaign features stories of real servicemembers who have sought treatment and are continuing to maintain successful military or civilian careers. In addition, DCoE established the DCoE Outreach Center, a 24/7 call center staffed by health resource consultants to provide confidential answers, tools, tips and resources about psychological health and traumatic brain injury. CAREER & EDUCATION: Tennessee Engineers Program

America's Veterans to Tennessee Engineers Program (AVTEP) at the University of Tennessee (Knoxville) continues to expand. The program is designed to allow Veterans with math skills to earn an undergraduate degree in an engineering field, and upon graduation, "walk across the street" into a engineer position with one of several national companies or Department of Energy agencies supporting the power industry in the Tennessee Valley area. There is a very high probability of obtaining employment. Today, most of those engineer positions start in the high \$50K salary ranges.

There is assistance and mentorship available, and there is a strong Veteran presence on campus. More than 20 Veterans from all services have been selected for the program, and a recent article published by the *Knoxville News Sentinel* at http://blogs.knoxnews.com/knx/munger/2009/09/two_more_companies_join_the_ve.html reports that 11 Veterans are now working for one of several companies in the area. Each of these companies have committed to having positions available to commit to new AVTEP graduates.

CAREER & EDUCATION: Spouse Scholarship Applications Due in January

The National Military Family Association's Joanne Holbrook Patton Military Spouse Scholarships have three scholarship categories—spouses of the wounded, spouses of the fallen, and for all military spouses. Scholarships range from \$500 to \$1,000 and are awarded to spouses of uniformed servicemembers to obtain professional certification or to attend post-secondary or graduate school. The scholarship funds may be used to assist with tuition, fees, and school room and board, and are paid directly to the accredited educational institution involved. BENEFITS: Social Security Tools Available

Military servicemembers receive expedited processing of their disability applications from Social Security. Under an agreement initiated by Social Security, the Department of Defense transmits information that allows us to quickly identify military personnel injured in Operations Enduring Freedom and Iraqi Freedom. The expedited process is available for any military servicemember who becomes disabled during active duty on or after October 1, 2001, regardless of where the disability occurs. Depending on the situation, some Family members of military personnel also may be able to receive benefits, including dependent children and spouses.

MONEY MATTERS: Termination of Pay Allowance Continuation Program

Soldiers who are assigned to Warrior Transition Units (WTUs), Community Based WTUs (CBWTUs), and Military Treatment Facilities (MTFs) and receiving Pay Allowance Continuation Program (PAC) entitlement may have had their entitlement terminated effective November 30, 2009. The Office of the Secretary of Defense (OSD) has made a final determination not to extend PAC entitlement beyond November 30, 2009, for those Soldiers who have received the entitlement beyond 12 months and two extensions that were approved by OSD. Exception to policy will be evaluated on case by case basis if continuation of PAC entitlement is warranted. The final authority for exception to the policy must be approved by Human Resource Command (HRC) and Deputy Chief of Staff, Army G-1. Below are examples to determine if/when to expect the PAC entitlement to terminate.

VA UPDATE: Disability Evaluation System Pilot Program Expansion

Beginning in January 2010, the VA/DoD Disability Evaluation System pilot program will expand to six medical facilities at Fort Benning, GA; Fort Bragg, NC; Fort Hood, TX; Fort Lewis, WA; Fort Riley, KS; and Portsmouth Naval Medical Center, VA. Twenty-one other military facilities have already taken part in the program. The pilot program began in November 2007, within the National Capitol Region and affects servicemembers who separated from the military under honorable conditions for service-related injuries. It addresses redundancy and inconsistency in medical evaluations in separate disability processes used by DoD and VA. Under the pilot programs, evaluations for Veterans are managed first by DoD physicians, then by VA. Physicians in both departments collaborate on medical findings, speeding the claims and benefit payment processes for disabled Veterans. More than 5,400 military members have participated in the pilot program.

"Streamlining our disability claims system and working closely with DoD to care for today's generation of heroes are among VA's top priorities," said VA Secretary Eric K. Shinseki. "We will never lose sight of the fact that Veterans and military personnel have earned their benefits ... by virtue of their service to the nation."

MONEY MATTERS: GIFTS 101

By MAJ Teresa T. Phelps, Command Judge Advocate, Warrior Transition Command AW2 Soldiers, Veterans, and Family members often have questions about receiving gifts from organizations or individuals. I have chosen a few of the frequently asked questions regarding gifts to provide some clarification. There are different regulations for Soldiers and their

Families, wounded Soldiers and their Families, and Veterans and their Families. When in doubt, please contact an ethics counselor or your AW2 Advocate.

Q: What is a gift?

A: A gift is anything of value: cash, property, or services.

Q: What is the general rule on gifts?

A: Soldiers and their Families may not directly or indirectly solicit or accept gifts given

- (1) because of their official position, i.e. a Soldier (see below for additional exceptions for wounded Soldiers)
- (2) or offered by a "prohibited source"

Q: What is a prohibited source?

A: A prohibited source is any person who seeks official action from the employee's agency, does or seeks to do business with his agency, conducts activities regulated by his agency, or has interests that may be substantially affected by the individual employee. (Example: DoD contractors, some private or non-profit organizations)

Q: Are there any legal restrictions on gifts?

A: Yes, but there are exemptions and exceptions.

Q: What are some examples of exemptions?

A: Examples are:

- Modest refreshments that do not constitute a meal (think of it as the "Coffee and donuts" rule)
- Greeting cards and items of little intrinsic value, such as trophies, certificates, and coins, intended solely for presentation
- Loans from banks and other financial institutions on terms generally available to the public
- Opportunities and benefits, including favorable rates and commercial discounts available
 to the public or large groups like all uniformed military personnel even if restricted
 geographically (Example: Free admission at Disneyworld or discounts on cell phone
 service contracts)
- Rewards and prizes given to competitors in contests and events, like random drawings open to the public

Q: What are some examples of exceptions?

A: General rule, gifts, other than cash, that are less than \$20 per occasion and do not exceed \$50 per calendar year, from the same source, can be accepted. Other exceptions:

- Gifts based on a family or personal relationship. (Example: Your brother works for a
 defense contractor and gives you tickets to a sporting event, worth \$50, as a birthday
 gift. Can you accept? Yes, if your brother paid for the tickets. You may not accept if
 his company paid for the tickets. You also can't "pay down" to get under the \$20/\$50
 limit, but you can pay the fair market value for the gift)
- · Gifts based on meritorious public service (see next question)

Q: Are there any additional exceptions for wounded Soldiers?

A: Yes, the Joint Ethics Regulation (JER), 3-400 and 3-401, increases the normal \$20/\$50 limit, *if* the following conditions are met:

- Gifts are *not* offered by foreign governments,
- Gifts are not accepted in return for being influenced in the performance of official duties,
- Gifts are not accepted in violation of any other statute (such as bribery and compensation from other sources for performing Federal duties), and
- For gifts with an aggregate market value exceeding the minimal value (\$335 in 2009) from one source on any particular occasion, or \$1,000 from one source in a calendar year, an agency ethics official has made a written determination that:
- The gift is not offered in a manner that discriminates among covered DoD employees on the basis of the type of official responsibility or of favoring those of higher rank or rate of pay;
- The donor does not have interests that may be affected substantially by the performance or nonperformance of the covered DoD employee's official duties; and
- Acceptance would not cause a reasonable person with knowledge of the relevant facts to question the integrity of DoD programs or operations.

Covered DoD servicemembers are:

- Members of the armed forces (including Reserve and National Guard members on Title 10 orders) on active duty, enlisted members of the Reserve on inactive duty for training, and all members of the National Guard performing official duties who,
- While on active duty, on or after September 11, 2001, incurred an illness or injury
 - o as a direct result of armed conflict;
 - while engaged in hazardous service;
 - o in the performance of duty under conditions simulating war;
 - o through an instrumentality of war; or
 - in an operation or area designated by the Secretary of Defense as a combat operation or combat zone.

To ensure the gift can be accepted, the Soldier should seek an ethics review prior to accepting any gift that exceeds the \$335 value (fair market value).

Q: Are there differences between what Active Duty Soldiers (JER applies to Reserve Component and National Guard Soldiers in a Title 10 status) and AW2 Veterans can accept?
A: Yes, the JER only applies to federal employees, so the medically retired AW2 Veterans are exempt from the gift rules, unless they are currently government employees.
