

PARKING PERMIT REGULATIONS

Effective November 7, 2001

A Parking Permit issued by the United States District Court of the Southern District of Georgia is required for the parking of any motor vehicle in permit-restricted spaces around the United States Courthouse at Augusta, Georgia. The motor vehicle operator who registered for a Parking Permit with the United States District Court is referred to as the "Registrant" herein. Registrants are subject to the following Regulations:

1. The Parking Permit must be visibly displayed on the dashboard of the driver's side of any motor vehicle parked in a permit-restricted space. Any motor vehicle parked in a permit-restricted space without a properly displayed Parking Permit is subject to immediate towing at the motor vehicle owner's expense.
2. The Parking Permit may only be used by the Registrant while on official court business in the United States Courthouse.
3. The Registrant must have a valid driver's license within his/her possession at all times that the Parking Permit is in use. The Registrant must show the driver's license upon request of a Government official or Court Security Officer.
4. The Parking Permit is the property of the United States District Court. It is for the use of the Registrant only. **THE PARKING PERMIT IS NOT TRANSFERABLE.** A Parking Permit found used by or in the possession of any person other than the Registrant will be confiscated, and the parking privileges of the Registrant will be revoked permanently. The non-transferability of this Parking Permit includes, but is not limited to, the Registrant's partners, associates, staff members, couriers, and clients.
5. The use of the Parking Permit subjects any motor vehicle parked in a permit-restricted space to its search by a United States Marshal, a United States Probation Officer, or a Court Security Officer upon request. Any such search may be performed with or without the presence of the Registrant or the motor vehicle's owner or driver.
6. The United States District Court assumes no responsibility for the care or protection of any vehicle or its contents.
7. A single Parking Permit will be issued to each Registrant. The Parking Permit can be moved to any motor vehicle driven by the Registrant.
8. Due to the limited permit-restricted spaces, the receipt of a Parking Permit does not assure a parking space. The responsibility of finding a parking space rests with the Registrant.
9. The Registrant's motor vehicle must be parked legally in a designated space. The Registrant is responsible for all citations issued to the motor vehicle.
10. Motor vehicles which appear to be abandoned are subject to towing at the discretion of the United States Marshals Service or the Court Security Officers of the United States Courthouse, regardless of whether the Parking Permit is properly displayed.
11. If a Registrant is not in possession of a Parking Permit, a temporary permit may be made available on a per day basis at the discretion of the United States Marshals Service or the Court Security Officers.
12. If a Parking Permit is lost, the Registrant may register for a replacement Parking Permit at the discretion of the United States District Court. There shall be a \$100.00 fee assessed to the Registrant for every replacement Parking Permit issued.
13. In the event a Parking Permit is stolen, the crime shall be immediately reported to the Court Security Officers together with a copy of the Police Incident Report therein.
14. A Registrant's Parking Permit is subject to revocation without notice by the United States District Court for any reason.
