Campers are assigned to clans of no more than 10 campers. Each clan is led by individual counselors who are responsible for ensuring the well-being of each camper and keeping the fun-level high!

"Our Children's Camp" is for GTB Youth ages 8 to 14 years old living in the six county service area of the GTB which include the counties of, Antrim, Benzie, Charlevoix, Grand Traverse, Leelanau and Manistee.
