
CDMRP History

- In 1993, grassroots advocacy heightened political awareness of breast cancer
- Federal budgetary opportunities spurred Congress to appropriate \$210M to the Department of Defense (DOD) budget for breast cancer research
- Program assigned to the USAMRMC; subsequent consultation with the Institute of Medicine for programmatic advice
- Additional research programs added, including neurofibromatosis in FY96, ovarian cancer and prostate cancer in fiscal year 1997 (FY97), defense health (now called Peer Reviewed Medical Research Program) in FY99, and prion, tuberous sclerosis, and chronic myelogenous leukemia in FY02
- These and other programs are managed by the CDMRP











Special Populations Program (SPP)

- Purpose: To address the disparities that exist in the incidence, morbidity, and/or mortality among different ethnic groups in diseases for which the CDMRP manages research funding programs
- Background: Established in 1998 in response to the CDMRP Minority Health Initiative, which was launched in 1997 by the Integration Panel (IP) of the Breast Cancer Research Program (BCRP) in response to low receipt and funding rate of proposals submitted from Historically Black Colleges and Universities/ Minority Institutions (HBCU/MI)





Recap of Minority Health Initiative Executive Summary

Purpose:

- **❖** To increase the number of funded proposals from HBCU/MI
- To Increase the number of funded proposals that study minority populations

Process:

- Consensus Conference I (CCI) (23-26 Oct 97): 199 recommendations
- CCII (11-13 Dec 97): Consolidated recommendations from CCI down to 23 recommendations
- Minority Initiative Committee (5-7 Jan 98): Identified and presented 12 categories containing 14 consolidated recommendations to the BCRP's IP and the CDMRP
- 12 of the 14 were accepted by the CDMRP and adopted for all research programs
