# **USDC SDNY ECF Filing Tip Sheet**

## Logging on to ECF

- Use either Mozilla Firefox version 3.5 or Internet Explorer versions 8, or 9. Other web browsers may not be fully compatible with the ECF system.
- If you try to log on to ECF and are unsuccessful three or more times you must delete your Cookies and Cache from your browsing history and restart your computer before trying again. <u>http://www.pcmag.com/article2/0,2817,2480401,00.asp</u>
- Your ECF and PACER Credentials are different. ECF is for filing documents and PACER is for viewing documents. If the main menu bar (blue) has four options, you are logged into PACER. ECF has seven options listed on the main menu bar (Civil, Criminal, Query, Reports, Utilities, Search, Logout).
- Make sure you are using all lower case letters in your log in name.
- If you successfully logged on after 4/26/2014 the system would have prompted you to change your password.
- Minimum 8 upper & lower-case letters; include a digit or a special character (symbol).
- Make sure you leave the "Client Code" area blank. (ECF does not provide you with a Client Code)
- Click the white redaction box that says "I understand that, if I file, I must comply with the redaction rules. I have read this notice."
- There is now a reset password option as of June 15, 2015. If you know your user name you may click "If you forgot your CM/ECF password, you can request a password reset <u>here.</u>" A new password will be sent to the primary email on the attorney's ECF account.

If you are not successful in logging in to your ECF account please call the ECF Help Desk at 212-805-0136, Option 2.

## <u>Size Limit</u>

Each individual PDF file may be no larger than 4 megabytes (MB). The system will not allow you to file a PDF document larger than 4 MB. To determine the PDF file size review the "document properties". If necessary, break large files into parts, each smaller than 4 MB, and label accordingly (eg. Exhibit A1, Exhibit A2...).

## To change the e-mail address:

- Log into the <u>ECF</u> System.
- Click on the Utilities menu option.
- Click on Maintain Your E-mail menu option, then
- Click on your email address.
- Backspace and clear out the old email address.
- Type in the new email address.
- Click the "Submit All Changes" button.

#### Filing a Notice of Appearance

When filing a Notice of Appearance the screen will prompt the filer to select "Lead" and/or "Notice". Checking "Lead" does not activate notifications. The "notice" box should never be unchecked.

#### Filing a Motion and Supporting Documents

A Motion and the Supporting Documents are filed separately.

Each receives their own document number. Supporting Documents are not attachments to the Notice of Motion.

The Notice of Motion is filed under the filing event "Motions" and the Supporting Documents are filed under the event "Replies, Oppositions and Supporting Documents". Each Supporting Document has its own filing event. Any exhibit may be attached to the document it supports.

#### Error in filing a document on ECF

#### 13.20 What if I make a mistake in electronic filing?

Immediately refile the document in correct form on the ECF system. Then send an email to the Court's Quality Assurance Unit (ECF\_error@nysd.uscourts.gov). The email must include the case number, case title, judge's name, the name/title of the document that was incorrectly filed. Please indicate the error that was made when filing the initial document. Do not follow these steps if you made an error filing an initiating document (complaint, notice of removal, petition) during the case opening process.
