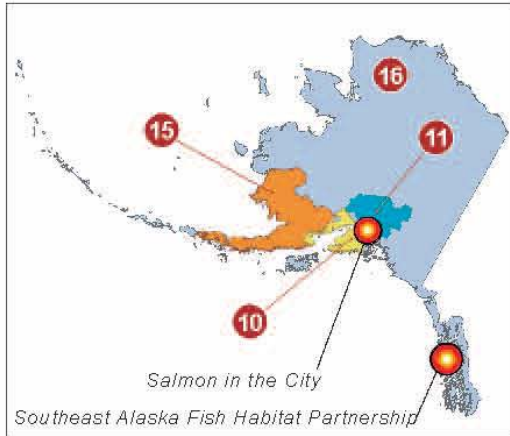
Mission:

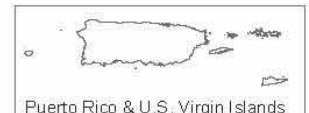
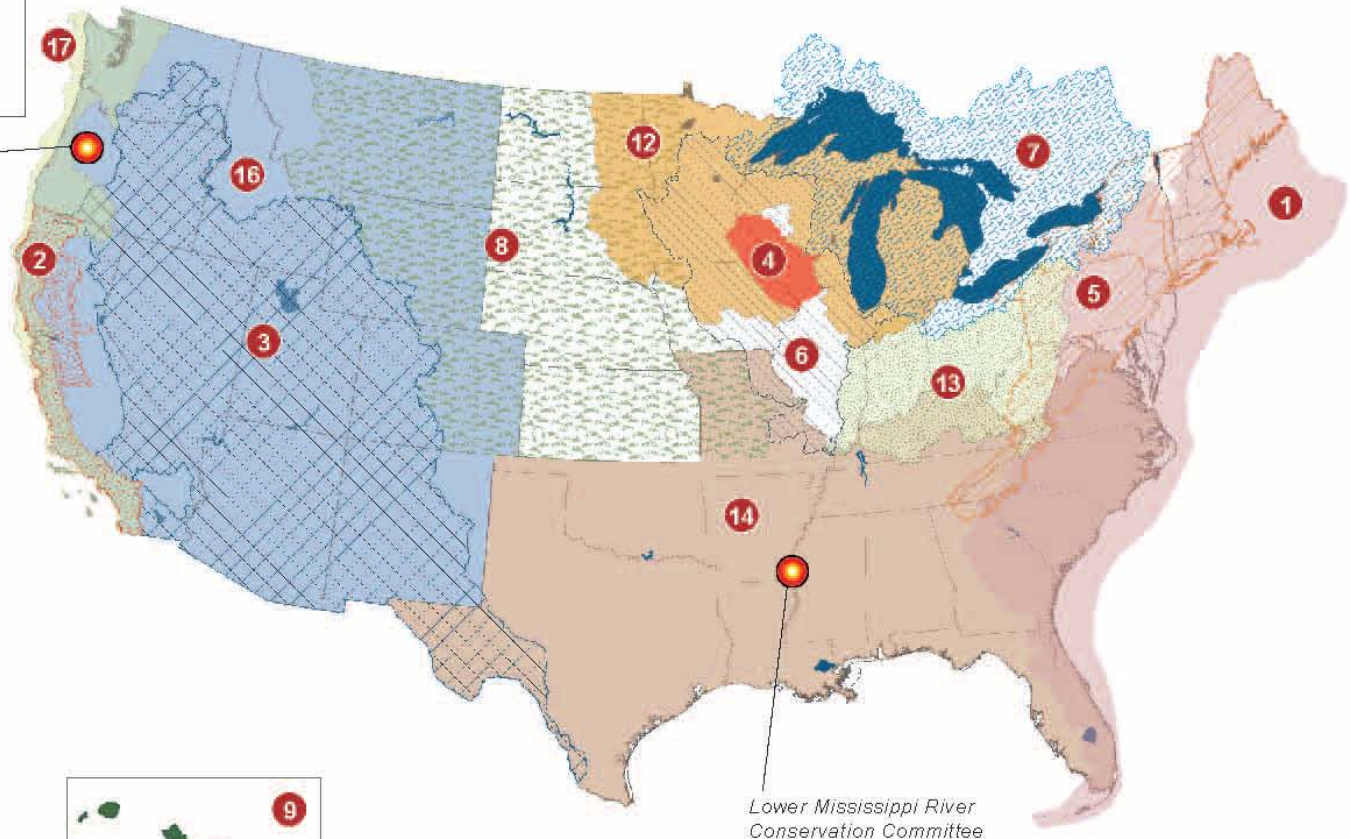
