I. INTRODUCTION

The New York State Division of Criminal Justice Services (DCJS) implemented Operation IMPACT in 2004, targeting the 17 New York State counties that account for more than 80 percent of Part 1 index crime in the State outside of New York City.¹ This initiative has provided participating law enforcement agencies with the information, tools and resources necessary to implement a data-driven approach to policing.

Operation IMPACT is a highly focused initiative, with a strong emphasis on **law enforcement partnerships, crime analysis, intelligence development and information sharing**. To ensure Operation IMPACT resources are funneled to the appropriate areas, the jurisdiction that accounts for the highest volume of violent crime within each county is named as the "primary jurisdiction" and is the focus of the IMPACT crime reduction efforts. The table below lists the 17 participating counties and their respective primary jurisdiction police departments.

A. Law Enforcement Partnerships

The crux of Operation IMPACT is having in place strong, solid law enforcement partnerships from which to draw resources, expertise and assistance. Each of the 17 Operation IMPACT counties has assembled an IMPACT partnership composed of representatives from all levels of law enforcement. The partnership is co-chaired by the primary jurisdiction's chief or commissioner of police and the county district attorney. The other agencies represented are the

county Sheriff's Office and Probation Department; New York State Police; Department of Corrections and Community Supervision; various federal law enforcement agencies such as the Federal Bureau of Investigation (FBI), Alcohol Tobacco and Firearms (ATF), the U.S. Marshal's Service, and the U.S. Attorney's Office. Each year, applications submitted for Operation IMPACT funding must include a Memorandum of Understanding signed by authorized individuals from each of these agencies, indicating their willingness to contribute to the crime reduction efforts within those counties and jurisdictions.

In addition to the 17 primary police departments, five of the partnerships include secondary police departments as participating agencies. There are three DCJS-designated secondary jurisdictions – those where the violent crime volume doesn't reach the level of the primary jurisdiction but are nonetheless substantial enough to warrant participation in the program. Those jurisdictions are Hempstead Police Department (Nassau County); Middletown Police Department (Orange County); and Mt. Vernon Police Department (Westchester County).

The benefit of law enforcement partnerships is that they afford the ability to harness numerous resources, focusing them on the most persistent crime problems within each IMPACT jurisdiction. Each individual agency offers different perspectives, skill sets, and resources to law enforcement. In addition, partnerships allow resources to be coordinated, avoiding the potential for having two different agencies expend time, money and effort on the same offender or incident.

B. The Analysis of Timely, Accurate Crime Data

Crime analysis has proven to be the strongest component of IMPACT. The benefit of a crime analysis program is that it creates a crime "picture" based on the timely and accurate data collected and reported by the police department. IMPACT law enforcement agencies are contractually required to submit their Uniform Crime Reporting (UCR) Part 1 Reports within 30 days of the end of the month. The quality of the crime data being reported by the IMPACT agencies has been both expanded and improved by working closely with the DCJS Crime Reporting and Data Quality Unit. IMPACT jurisdictions also submit a shooting incident and victim report to DCJS monthly so that this important measure of crime can be tracked.

As the quality and timeliness of the crime data improved, agency command staff began to use the data to make informed decisions about when, where, and what type of resources to deploy in response to the patterns and trends revealed through the analysis of crime. Today, IMPACT can lay claim to the fact that every IMPACT chief or designated command staff member meets frequently with other staff members to review recent crime trends and develop a plan to address those trends.

C. Intelligence Development and Information Sharing

Another critical outcome of Operation IMPACT is the enhanced ability of the IMPACT law enforcement agencies to cultivate intelligence and share information with other IMPACT partner agencies within their specific county and beyond. One of the first goals of Operation IMPACT was to encourage each participating agency to find ways to share the information at their disposal with their partners. This included information about their most persistent crime problems, the areas within their jurisdiction with the highest volume of crime, current investigations, etc. This concept, although seemingly simple, meant breaking down barriers that existed among law enforcement agencies for decades. The sharing of information began simply, with partners exchanging information around the table at monthly Operation IMPACT meetings. It has now evolved to near-daily sharing of intelligence and information through regular joint operations and details, shared databases, intelligence bulletins, and more.

In addition, all 17 partnerships utilize the field intelligence concept to facilitate this regular flow of information among agencies. Almost every participating IMPACT law enforcement agency has assigned a field intelligence officer (FIO) who works to obtain as much intelligence as possible through the regular debriefing of arrestees, probationers, parolees, inmates, and other persons of interest. Unlike interrogation, debriefing is an interview method used to obtain actionable intelligence – information that might prove useful in solving other, unrelated crimes and paint a more complete picture of the crime conditions within a given jurisdiction. In nearly all 17 counties, the various FIOs within a partnership work closely together, in some instances even becoming a stand-alone unit. They coordinate the gathering of criminal intelligence based on the particular crime trends of the previous week or month. This maximizes their effectiveness, as the team is then able to determine the exact topic and population to target when conducting their debriefings. For instance, if crime analysis indicates that a cluster of burglaries has occurred in a particular area, the probation and parole FIOs, in concert with the police department and sheriff's office FIOs, might debrief all of the people under supervision for a charge of burglary or those that live in the cluster area. The FIOs share all of the information they obtain with patrol, investigative, supervisory and command staff to enhance their ability to conduct day-to-day operations.

II. OPERATION IMPACT FUNDING

A. Award Process

Each spring, the DCJS Office of Public Safety (OPS) releases a Request for Applications (RFA) for funding to support Operation IMPACT crime reduction initiatives. In 2011, DCJS staff analyzed reported Part 1 crimes and provided IMPACT agencies with target crimes of focus. These crimes were chosen based on the latest data available and focused on crimes that were trending upward. The RFA is very specific, guiding each applicant to provide the strategy they propose to address the crimes of focus; the role that each partner agency, whether receiving funding or not, will play in implementing the proposed strategy; and the amount of funding that they believe will be required to effectively implement their proposed strategy.

Each of the 17 participating partnerships must submit a single, comprehensive application in response to the RFA. This was originally designed to facilitate a deeper level of collaboration between the various law enforcement agencies that had traditionally worked independently of one another and, for the most part, had different missions. The belief was that by working together to analyze the crime, develop the strategy, and submit the applications, the participating agencies would have a common goal for which to strive.

Agencies eligible to apply for and receive funding are the district attorney's office, the primary police department, secondary police departments, the sheriff's office, and the probation department. In prior years, some partnership co-chairs determined that other municipal government agencies or non-profits organizations played an important enough role in the implementation of their strategy that they included those agencies in their strategy proposal and request for funding. However, the 2011-2012 IMPACT RFA was open to only those agencies that received a 2010-2011 Operation IMPACT award.

New York State and federal agencies are not eligible to apply for funding under this initiative, but the strategy proposed through each application must still include the active participation contributions of these non-funded agencies.

Once the applications were received, OPS staff reviewed them and made funding recommendations to the DCJS Acting Commissioner. Recommendations are based on the strength of the proposed crime reduction strategy; prior year compliance with program and contract requirements; and the volume of crime within the primary jurisdiction and the county.

The 2011-2012 Operation IMPACT awards, within each county, are outlined in the chart below.

B. Personnel

In 2011, Operation IMPACT funding supported *112 positions* including police officers, police and district attorney investigators, assistant district attorneys, probation officers, sheriff's deputies, crime analysts, and field intelligence officers. Approximately 51 percent of the funded positions are dedicated to the crime analysis and intelligence development and information sharing facets of the program. IMPACT funding supports *20 crime analysts* and *37 field intelligence officers*. This is an excellent illustration of the partnerships' commitment to those two components of the program and how they have become standard operating procedure within participating agencies.

C. Initiatives

Each year, the Operation IMPACT partnerships are required to develop a comprehensive strategy to address Part 1 crime, particularly violent crime, within the primary jurisdiction. Each strategy is comprised of different initiatives, and each initiative is intended to address a particular crime problem or problems.

The following initiatives are the most common to the crime reduction strategies developed by the 17 county partnerships.

- 1. Directed/Saturation Patrols These patrols, often supported through Operation IMPACT funding, are planned using the most up-to-date crime data available so that they are conducted at the appropriate time, and days of the week, and in the crime hot spots of the jurisdiction, thereby having the maximum effect on identified spikes in crime. These patrols are generally led by the primary police department, but often include major contributions of time and staffing by the county sheriff's office, the New York State Police, and, in some instances, secondary police departments.
- 2. Probation/Parole Home Visits Probation and parole officers have easier access to the people they supervise than the police, and can conduct random home visits, for example. Probation and parole conditions often include curfews, drug and/or alcohol abstinence and prohibition on being in bars or other drinking establishments. As such, the police departments in all 17 primary IMPACT jurisdictions generally include probation/parole joint home visits as part of their strategy. Crime analysis is used to hone the focus of these visits. For example, if robbery is spiking, the police and probation/parole officers may visit all those under supervision for a robbery offense, or all probationers or parolees that live in the area where the increase is occurring. These initiatives have been very successful in not only obtaining actionable intelligence, but also in making those still under supervision aware that their officers are teaming up with the police in a focused manner.

There are variations on the home visit initiative. Joint operations between police and probation/parole have been conducted at problem establishments as part of a focused

effort to build a case against a particular bar or social club. These operations often include the New York State Liquor Authority and other local departments (code, health, fire, etc.). Operation IMPACT funding provides many probation departments in particular with the opportunity to conduct these off-hours details. Parole has conducted "Meet and Greet" operations, requiring their parolees to report to the police station at a predetermined date and time where they are then drug-tested, searched, and debriefed on theirs and others activities.

- **3.** Warrant Sweeps Operation IMPACT funding is often used to conduct warrant sweeps, which seek offenders with more serious warrants or to apprehend offenders who have outstanding warrants and a previous history of violent crime. Sex offenders and individuals with outstanding domestic violence charges are also targeted through these sweeps.
- 4. Chronic Offender Initiatives There are several different variations of this initiative, but the main concept is a heightened level of accountability for the most serious offenders by identifying and focusing on those who are known to commit a disproportionate percentage of the jurisdiction's violent crime. The work of crime analysts is critical to these initiatives, as they generally use very specific criteria to develop the list of chronic offenders. Once the list is developed, other initiatives, such as home visits and warrant sweeps, can be used to hold these offenders accountable if they are currently under supervision or have an outstanding warrant against them. The list is reviewed and updated regularly.
- 5. Narcotics and Gang Operations A portion of every jurisdiction's violent crime is a result of drug and gang activity. In addition to the violent crime associated with these two factors, open-air drug dealing and street-level gang activity can significantly reduce the quality of life within neighborhoods. Police officials agree that every violent crime-reduction strategy must include some details that address these illegal activities. Undercover operations, foot patrols, saturation patrols, and programs designed to intervene in the aftermath of gang and gun violence have had some success in addressing both.
- 6. Enhanced Prosecution Efforts Most IMPACT strategies include some level of enhanced prosecution for violent offenses or firearm-related violent crime. Flagging IMPACT cases for vertical prosecution and creating no-plea zones within a jurisdiction are just two examples of how district attorneys' offices are doing their part to address violent crime.
- 7. Intelligence Led Policing IMPACT agencies have been encouraged to utilize the services of their crime analysts to drill down into reported crimes to determine patterns as well as to attempt to predict future criminal activities. Additionally, the services of the Crime Analysis Centers throughout the state have been utilized to provide information on

shared offenders as well as to share information crime trends and to provide success stories in combating and solving these crimes.

D. Benefits of IMPACT Funding to Local Agencies

Operation IMPACT provides reinforcement and critical funding that allows local agencies to maximize their ability to police effectively during difficult fiscal times. Law enforcement executives have repeatedly stated that without IMPACT funding, vital positions would be lost, the ability to analyze crime would significantly shrink, and funding for additional, strategic operations would dry up, leaving them without the resources to stem crime. For several years now, IMPACT chiefs, commanding officers and other administrators have indicated that their approved complement of officers has shrunk, sometimes to levels not seen in 20 years, and their overtime budgets have been significantly reduced, leaving them to use their overtime to staff for regular patrol shifts. IMPACT provides the additional financial resources for targeted operations that make a difference.

All funding requested through IMPACT must reasonably outline why a requested budget item can't be supported in the agency's general budget. Application budgets must also include clear justification as to how each particular item requested is vital to strategy implementation. Partner agencies that are eligible for funding use the support they get through this program in a variety of different ways. Whether the request is for personnel, equipment, or consultant services, each funding area provides the support needed to successfully implement their strategies. Funding requests are carefully analyzed for need and funding awards are closely monitored.

III. PARTNERSHIP HIGHLIGHTS & STRATEGIES

Each of the 17 IMPACT partnerships uses a significant portion of their funding to implement their strategies to reduce violent crime. Police departments receive little to no funding within their operating budget to develop and conduct targeted anti-crime initiatives beyond their daily operations. IMPACT funding provides this valuable support but with ample oversight from DCJS to ensure strategies are focused and tied into the overall goal to reduce specific Part I crimes. Each partnership has its own unique initiatives and in 2011, DCJS determined the targeted crimes on which each jurisdiction was required to focus. Below is a bulleted summary of each jurisdiction's targeted crime and their strategies to address them.

ALBANY COUNTY – City of Albany Police

Targeted Crimes: Firearms, Robbery and Larceny

- The Safe Homes/Safe Streets Partnership combines the Albany Police Department (APD), the Albany County District Attorney's Office, the Albany County Sheriff's Office, New York State Police, and various city departments to implement this nuisance abatement program through searches of abandoned properties for evidence of illicit activity. One of the most notable initiatives undertaken through this program was the search for "community guns." All searches are pre-approved by the property owner.
- The APD and DOCCS conducted joint patrols and home visits to obtain intelligence and ensure compliance with conditions. A similar initiative was conducted with the county probation department.
- Wireless access points were utilized to allow the Albany Crime Analysis Center (ACAC) broadband connection to cars and handheld devices in real time.
- Saturation patrols were conducted in hot-spots determined by real time crime analysis produced by the ACAC.
- Weekly command accountability meetings involved discussion on topics based on analysis produced by the ACAC.
- The Albany County District Attorney's Office continued to conduct long-term, multiagency investigations targeting the most prolific gang members/associates.
- The DA's Office focused on accountability for problematic property owners, including the seizure of property or recovery for costs of investigations where applicable.
- Recognizing gang membership/activity as a primary link to street robberies, the APD enhanced its intelligence gathering components for gang member/associates.
- With a focus on early intervention, arrest diversion, and truancy abatement, the police department made summer home visits to the Top 100 elementary truants in an effort to reduce juvenile crime.

BROOME COUNTY - City of Binghamton Police

Targeted Crimes: Burglary and Larceny

- Crime prevention and education was a major component in the strategy to reduce burglaries. Educational flyers, e-mail alerts, and door-to-door canvassing were utilized in problematic areas.
- The SUNY Binghamton Police Department was included in the monthly IMPACT meetings since many victims of burglaries are students living both on and off campus.
- Saturation patrols were conducted with the Broome County Sheriff's Office based on crime analysis.
- DNA collection at crime scenes was enhanced and additional training was provided to first responding officers.
- The Binghamton Police Department expanded upon its surveillance camera project in the city.

• The Binghamton Police Department received technical assistance this year to develop a CompStat process and is currently incorporating CompStat into their agencies crime reduction efforts.

CHAUTAUQUA COUNTY – City of Jamestown Police

Targeted Crimes: Robbery and Burglary

- A Burglary/Robbery Task Force was established with investigators assigned from the IMPACT partnership.
- Targeted IMPACT patrols were deployed based on crime analysis.
- A Parolee and Probationer Compliance Task Force was established with an emphasis on robbery.
- Field intelligence officers from the Jamestown Police Department and Chautauqua County Sheriff's Office conducted targeted debriefings using real-time crime analysis.
- The Chautauqua County District Attorney's Office utilized vertical prosecution for all cases of robberies and burglaries that had a component of violence.
- The District Attorney's Office developed a limited plea policy and conducted regular reviews for possible federal prosecution on IMPACT-targeted crimes.
- Services were offered to non-violent burglary offenders who were determined to have a viable chance at rehabilitation.

DUTCHESS COUNTY – City of Poughkeepsie Police

Targeted Crimes: Aggravated Assault, Robbery and Burglary

- Saturation patrols were conducted based on analysis.
- The field intelligence officer conducted targeted debriefings on all IMPACT-targeted crimes using real time crime analysis.
- The Dutchess County District Attorney's Office monitored cases for all IMPACTtargeted crimes and worked with the U.S. Attorney's Office in order to determine which cases were eligible for federal prosecution.
- The District Attorney appointed an IMPACT initiatives assistant district attorney who handled the coordination of the prosecution of all IMPACT-flagged crimes.
- Directed patrols were deployed to areas where robberies and burglaries had the highest incidence of occurrence as determined by crime analysis.
- The District Attorney's Office worked to strengthen the investigation of violent crimes in the IMPACT area through the violent crime forensic enhancement initiative.

ERIE COUNTY – City of Buffalo Police

Targeted Crimes: Firearms, Robbery and Burglary

- Based on information provided by the Erie Crime Analysis Center (ECAC), the IMPACT partners implemented the Violent Crime IMPACT Team, which worked to solve shooting incidents.
- Targeted patrols were concentrated in shooting hot spot and possible retaliatory locations.
- Multi-jurisdictional warrant sweeps of violent offenders were conducted.
- The four IMPACT assistant district attorneys (ADAs) adhered to the no-plea policy for cases involving loaded firearms and referred gun cases to the U.S. Attorney's Office for federal prosecution when appropriate.
- The criminal intelligence specialist and confidential criminal investigator worked with local law enforcement and the IMPACT ADAs to enhance the likelihood of convictions for gun crime and to connect gun violence to additional suspects.
- The ECAC routinely provided the probation officer and sheriff's office field intelligence officer with robbery and burglary information.
- DNA was collected at burglary crime scenes to enhance the investigations of those crimes.
- BPD distributed a burglary safety tip door hanger to residents of burglary hot spots and pattern areas in an effort to prevent burglaries.
- The IMPACT ADAs worked with the ECAC, the Erie County District Attorney's Office criminal investigator and criminal intelligence specialist, and other IMPACT partners to strengthen robbery and burglary cases and link defendants to additional robberies and burglaries using information provided. When possible, the Erie County District Attorney's Office took advantage of DNA hits.

MONROE COUNTY – City of Rochester Police

Targeted Crimes: Firearms, Robbery and Burglary

- The Rochester Police Department conducted joint patrols of firearm violence hot spots as determined through crime analysis; and conducted Violent Retaliatory Dispute Interventions and targeted offender details.
- The police department strived to improve firearms investigations through enhanced ballistic matching.
- Probation and parole officers conducted residence and curfew checks of offenders known to commit firearm-related crime.
- The police department conducted violent crime pattern disruption details.
- Full-time assistant district attorneys were assigned to the Gun; Major Felony; and Drug Bureaus to prosecute IMPACT-related cases.
- The Monroe County District Attorney's Office enhanced the investigation, prosecution and adjudication of all cases on crimes that were the focus of the IMPACT strategy. DA investigators, paralegals, and victim/witness advocates were utilized to strengthen cases and to ensure that witnesses and victims were available for court appearances; experienced prosecutors were assigned to vertically prosecute all IMPACT-related

cases; pleas to reduced charged were strictly limited, especially for firearm and gangrelated crimes; and significant prison sentences were sought for all those convicted of any firearm-related Part 1 crime.

- The DA's Office partnered with the U.S. Attorney's Office on Project Exile, a program which involves weekly meetings where cases were reviewed and referred for federal prosecution in cases where the federal charges and/or prison sentences had the potential to be more effective than the state's.
- The DA's Office worked with the Rochester Institute of Technology, the administrative judge for the Seventh Judicial District, and the Center for Court Innovation to generate community support for, and to implement, a community court in one of the highest-crime areas of the city.
- The DA's Office staffed the Drug Treatment Court, the Mental Health Court, and the Integrated Domestic Violence Court programs.
- The DA's Office partnered with the Boys and Girls Club in support of its activities, specifically Project Step Up and the Accelerated Reading Program, aimed at reducing youth crime.
- The DA's Office participated in offender "call-ins," and other efforts to deter crime.
- The police utilized community notification/engagement details (door-to-door crime prevention) and use of Hyper-Reach, a reverse phone calling tool to quickly disseminate information to the public.
- Probation and parole residence and curfew checks were conducted for known burglars.
- The Police Department enhanced their burglary investigations through increased collection of DNA and fingerprints.
- Burglary problem teams were created to provide a comprehensive response to the crime of burglary.

NASSAU COUNTY – Nassau County Police

Targeted Crimes: Firearms and Robberies

- The Nassau County Lead Development Center (LDC) serves as a centralized crime analysis center that collects, collates, and analyzes crime, and provides analysis and intelligence to county law enforcement.
- The Nassau County Police Department (NCPD) continued to utilize technology in addressing all IMPACT-related crimes. License plate readers (LPRs), shot spotter, and police cameras were all used to enhance investigations and provide intelligence.
- NCPD deployed their Criminal Intelligence Rapid Response Team (CIRRT) based on the analysis of hot spots utilizing real time crime data.
- NCPD continued to conduct extensive debriefing of arrestees, and continued to closely track recovered firearms.
- The NCPD partnered with probation and parole on Night Watch, which involved random night-time checks of offenders to ensure that they were complying with the conditions of their release. Visits included include random drug testing and premise searches.
- Probation and the NCPD also partnered for "Night Light," a program similar to Night Watch but focused on juvenile offenders.

- The Nassau County District Attorney's Office gun unit dedicated eight assistant district attorneys to prosecute gun crimes.
- The District Attorney's Office implemented a policy of debriefing offenders prior to all plea offers.

NIAGARA COUNTY – City of Niagara Falls Police

Targeted Crimes: Firearms, Robbery and Burglary

- Niagara Falls Police Department (NFPD) conducted intensive debriefing whenever an offender, suspect or other person of interest was thought to be connected to gun related offenses.
- NFPD created a task force directly aimed at the eradication of youth gang violence.
- The Niagara County District Attorney's Office reviewed all gun cases for potential federal prosecution under Project Exile; continued a strict no-plea policy for gun possession, gun sales and violent crimes involving guns in Niagara Falls; and ensured the highest bail amount was set on all firearm-related offenders.
- NFPD increased manpower and resources to their Robbery Task Force. This added manpower helped to identify and apprehend robbery offenders.
- The field intelligence officer conducted targeted debriefings on all IMPACT-target crimes using real time crime analysis.
- The DA's Office utilized vertical prosecution for IMPACT-flagged cases for more effective handling of cases from investigation through sentencing. The District Attorney also implemented a strict no-plea policy for repeat offenders of robbery.

ONEIDA COUNTY -_ City of Utica Police

Targeted Crimes: Domestic Violence Aggravated Assault, Burglary and Larceny

- The Utica Police Department (UPD) assigned a dedicated domestic violence officer to focus on repeat and chronic offenders/victims, and to develop a checklist for first responding officers to utilize in responding to domestic violence incidents.
- UPD enhanced their evidence collection process in domestic violence cases (photos, 911 calls, etc).
- Police, parole and probation officers partnered to conduct home visits of domestic violence offenders to ensure compliance with conditions.
- UPD partnered with the YWCA to provide services to victims of domestic violence
- The Oneida County District Attorney's office assigned a dedicated domestic violence prosecutor.
- The DA's office implemented the "flagging" of domestic violence repeat offenders in order to better track those offenders and incidents.
- The DA's office participated in the Oneida County Integrated Domestic Violence Court and the Utica City Domestic Violence Court.
- The City of Utica has been pursuing the implementation of Pawn Shop/Second Hand Shop ordinance to assist in the enforcement of related crimes.

- The UPD enhanced their crime scene processing and trained patrol officers in the gathering of DNA and fingerprints to aid in the investigation of burglary cases.
- The DA's Office designated a prosecutor to handle burglary and larceny cases, implemented a no-plea reduction policy and utilized vertical prosecutions. In addition, providing a DNA sample is now a condition on all plea bargains.

ONONDAGA COUNTY – City of Syracuse Police

Targeted Crimes: Firearms and Burglary

- The Onondaga Crime Analysis Center (OCAC) provided firearms-related analysis for the monthly IMPACT executive meeting to provide the partnership with a clear picture of the current shootings/shots fired trends, hot spots, results of enforcement efforts, and status of offenders arrested.
- IMPACT saturation patrols, were deployed in the high crime areas. The Highway Gun Interdiction directed patrols are conducted by the Syracuse Police Department (SPD), Onondaga County Sheriff's Office, and New York State Police.
- The OCAC monitored the juveniles involved with firearm-related offenses and provided comprehensive juvenile information to the SPD Youth Division, which then worked closely with the Onondaga County District Attorney's Office in an attempt to vigorously prosecute these juveniles.
- The DA's Office, when appropriate, diverted cases to the Syracuse Community Treatment Court, where the offender is fined and sentenced to community service, but also receives assistance with services such as treatment, education, vocational training, housing, employment and counseling.
- Weekly meetings were held between members of the Onondaga County District Attorney's Office and members of the ATF to determine if any firearms cases would be better handled federally by the U.S. Attorney's Office.
- In addition to utilizing many of the same strategies utilized for firearms, SPD used the second-hand dealer laws to target neighborhood stores, pawn shops, and fencing operations. Stores and operations not in compliance were ticketed and owners arrested on various charges.

ORANGE COUNTY – City of Newburgh Police

Targeted Crimes: Firearms, Robbery and Aggravated Assault

- The City of Newburgh Police Department's (NPD) Neighborhood Stabilization Team (NST) conducts its activities based on current crime hot spots, specifically focusing on the IMPACT-targeted crimes.
- NPD conducted joint directed patrols with the Orange County Sheriff's Office and New York State Police based on analysis of crime data.
- NPD utilized strategic deployment of both patrols and plain clothes units as crime patterns developed.
- NPD has developed strong partnerships with federal agencies and conducted joint investigations with those agencies.

• The Orange County District Attorney's office flagged designated cases for enhanced prosecution, reviewed cases for federal prosecution, utilized specialty courts to route offenders appropriately, coordinated adult prosecutions with the prosecution of juveniles when warranted, and enhanced prosecution of violent crimes and witness relocation when necessary.

RENSSELAER COUNTY – City of Troy Police

Targeted Crimes: Firearms, Aggravated Assaults and Burglary

- The Troy Police Department (TPD) Special Investigations Unit targeted illicit firearm activity, related sales, and unlawful possession of illegal firearms.
- The TPD identified and scrutinized known "chronic offenders" of gun crimes.
- The field intelligence officer conducted targeted debriefings on all IMPACT-targeted crimes using real time crime analysis.
- The Rensselaer County District Attorney's Office routinely held case conferences with the U.S. Attorney's Office and transferred gun cases when federal prosecution promised more effective sanctions.
- The DA's Office assigned a chronic offender investigator, who streamlined communication and flow of information and resources regarding firearm violence among the IMPACT partner agencies.
- The TPD continued the operation of its Domestic Incident Unit.
- TPD actively worked with community partners to address the crime of domestic violence/aggravated assault.
- The District Attorney's Office continued the practice of enhanced prosecution of domestic violence cases with a full-time dedicated domestic violence prosecutor assigned to those cases in the city of Troy.
- The DA's Office requires all domestic violence offenders to submit a DNA sample regardless of the nature of the conviction.
- The TPD increased DNA collection at burglary scenes in an effort to enhance burglary investigations.
- The DA's Office coordinated with the local and state police agencies throughout the county and local justice and city courts, to ensure the collection of DNA from court mandated defendants.

ROCKLAND COUNTY - Village of Spring Valley Police

Targeted Crimes: Robbery, Burglary and Larceny

- The Spring Valley Police Department (SVPD) educated the community on robbery, burglary and larceny prevention through the use of pamphlets and flyers.
- SVPD utilized saturation/directed patrols based on crime analysis.
- Joint home visits with parole and probation, coordination of investigations through the SVPD Special Investigations Unit and the utilization of the Rockland County Drug Task Force were all methods and strategies deployed based on intelligence gathered and analysis of "hot spots" related to the crimes of focus.

- The Rockland County District Attorney's Office utilized a holistic approach to crime reduction utilizing the continuum of prevention and early intervention, and, investigation and prosecution efforts.
- When possible, the DA's Office referred cases when federal prosecution promised more effective sanctions.
- The DA's Office utilized a Special Victims Center that includes staff from the DA's Office and local police agencies as well as staff from social services and medical facilities to provide a one-stop location for victims to obtain information and resources.

SCHENECTADY COUNTY – City of Schenectady Police

Targeted Crimes: Aggravated Assaults, Larceny and Burglary

- The Schenectady Police Department (SPD) generated a list of the most frequented calls-for-service locations to prevent further escalation and with a goal of resolving the reoccurring issue.
- The field intelligence officer conducted debriefings to address the increase in aggravated assaults that were related to domestic violence as well as all IMPACT-targeted crimes using real time crime analysis.
- Recidivist offenders were targeted by the Schenectady County District Attorney's Office for enhanced prosecution, and cases were reviewed in order to identify potential stalking charges.
- Special Victim Unit prosecutors, working closely with domestic violence advocates employed by the YWCA, promoted resolutions to cases that enhanced victim safety and achieved offender accountability.
- Weekly detailed burglary and larceny reports were generated and distributed internally and to agency partners.
- Intelligence gathering via field interviews, debriefings, pawn shop reports, partner agency communications and known offender lists were used in determining persons of interest.
- The District Attorney's Office developed a prosecution strategy grounded in rapid indictment; maximum accountability through minimal plea bargaining (exceptions may be made for youthful offenders); and proposed sentences that reflect the degree of harm caused to the community.

SUFFOLK COUNTY – Suffolk County Police

Targeted Crimes: Firearms and Burglary

- Targeted debriefings were conducted by the Suffolk County Police Department (SCPD) specifically in the First, Second and Third Precincts in order to obtain actionable intelligence on the IMPACT-targeted crimes.
- SCPD focused on a coordinated effort between the field intelligence officers (FIO) and analysts to ensure that the FIO was prepared prior to debriefings.
- The SCPD utilized crime analysis to drive strategic deployment of resources.

- A crime analysis program was implemented within the Firearm Suppression Unit to track non-fatal shooting, burglaries, 911 calls for shots fired etc. The analysts identified "hotspots" and then determined which active gangs were affecting those areas.
- SCPD focused on developing intelligence to conduct street gang criminal enterprise investigations.
- The SCPD conducted gang and street crime targeted enforcement by addressing hot spots, debriefing arrestees and developing confidential informants. The Emergency Service Section executed warrants that were generated, canine teams were used to enhance cases, and the probation field intelligence officer was assigned to conduct debriefings and develop a list of high-risk offenders.
- The Detective Bureau focused on preventing retaliatory shootings.
- The SCPD engaged community involvement and awareness by encouraging citizens to drop off prescription drugs, knives and firearms for destruction.
- Gun cases were initiated as a result of intelligence developed.
- All offenders charged with illegal gun possession are now required to provide a written statement of where the gun was obtained prior to entering a plea.

ULSTER COUNTY - City of Kingston Police

Targeted Crimes: Aggravated Assault and Burglary

- Kingston Police Department (KPD) participated in saturation/joint directed patrols with the Ulster County Sheriff's Office and the New York State Police.
- KPD deployed their resources as dictated by crime analysis, mapping and crime spikes. In addition to traditional patrol activity, they utilized foot patrols, bike patrols and ATV patrols.
- The Ulster Regional Gang Enforcement Narcotics Team (URGENT) addressed issues specific to guns and gangs.
- KPD increased the level of training for their patrol officers with regard to more effectively gathering evidence and processing crime scenes.
- KPD officers received enhanced domestic violence (DV) training.
- KPD officers use real time data available to officers via Mobile Data Terminals (MDT's).
- Field intelligence officers (FIOs) provided intelligence developed through debriefings to the IMPACT partners.
- A detective dedicated to domestic violence cases reviewed and followed up on all these cases.

WESTCHESTER COUNTY- City of Yonkers Police

Targeted Crimes: Firearms, Domestic Violence and Burglary

• The Yonkers Police Department (YPD) deployed intelligence-led saturation patrols with an increased focus on narcotic enforcement.

- YPD continued to use Shot Spotter and a successful gun reward program; and conduct warrant sweeps with the U.S. Marshal's Service and extensive undercover operations, both of which targeted illegal firearms and narcotics.
- All firearms felony cases were reviewed by the District Attorney's Office Gangs/Gun Bureau Chief, to ensure that the cases were properly prepared and forensics testing was completed.
- The District Attorney's Office reviewed cases to determine if cases could be more effectively prosecuted federally.
- Drug/Specialty Courts were utilized to determine if offender was a Re-entry candidate for particular programs and coordination took place with the Re-entry Task Force.
- YPD utilizes Leads-on-Line, which tracks property turned into pawn shops, game stores, on-line auctions, etc.
- YPD also focused on the increased collection of DNA evidence from all burglary scenes.
- A bilingual domestic violence aide made phone contact with all victims regarding their service needs.
- The District Attorney's Office worked with My Sister's Place and Hope's Door, two not-for-profit agencies providing services to domestic violence victims.
- A dedicated prosecutor reviewed cases for recidivism risk factors, child safety and warrants for jail calls.

IV. STATE AGENCY CONTRIBUTIONS

NEW YORK STATE DIVISION OF CRIMINAL JUSTICE SERVICES

OFFICE OF PUBLIC SAFETY

The DCJS Office of Public Safety (OPS) is responsible for the day-to-day oversight and administration of Operation IMPACT. The agency has assigned staff to work closely with the 17 IMPACT partnerships to assist them in implementing their strategies and to provide the IMPACT agencies with a single point of contact for all information and services provided to law enforcement by DCJS and other participating State agencies. IMPACT staff attend monthly IMPACT partnership meetings; provide follow-up in areas where a need is determined to exist; make referrals on training and other resources available through DCJS; and coordinate access to other New York State agency resources as needed. In addition, the IMPACT Unit staff and the DCJS Law Enforcement Grants Unit closely monitor various performance measures that IMPACT agencies must meet as part of their participation in the program, such as the timely submission of all required crime reports, proper reporting on sex offenders, timely submission of DNA samples owed by qualifying offenders, and proper designation of arrests that have a Hate Crime component or a Domestic Incident Report on file in conjunction with the arrest.

Since the inception of Operation IMPACT, DCJS staff has coordinated monthly "Crime Trends"² meetings that require IMPACT partners to make a formal, comprehensive presentation on the status of their crime reduction efforts to the DCJS commissioner, and other state partner agencies. The presentation is typically led by the police commissioner/chief of the primary jurisdiction with all agency partners presenting on their respective contributions to IMPACT initiatives. The meetings afford state officials the opportunity to ask questions, and provide additional measure of requiring accountability from the IMPACT partnerships.

Crime Analysis Centers

The Crime Analysis Centers are designed to enhance local efforts to combat Part 1 crime in four IMPACT counties and to promote information sharing locally and statewide. The four centers are located in Albany, Erie, Monroe, and Onondaga counties, and those locations were selected specifically because of the relatively high volume of firearm and other violent crime in the primary jurisdiction and countywide. Using the data-driven policing model implemented through IMPACT, the centers take that approach to the next level through extensive crossagency data sharing, sophisticated technological information dissemination tools, and a professional interagency crime analyst staff.

² Crime Trends Meetings are held monthly and hosted by the DCJS commissioner. Each month, an IMPACT partnership is invited to provide an overview of their crime statistics, the strategies that they are using to address that crime, and the contributions that the partner agencies are making to the strategy. Executive staff members from State partner agencies attend these meetings in order to determine if there are additional resources that can be made available to the jurisdiction that will further assist them in their crime reduction efforts.

The centers are governed by a board of directors that includes the district attorney, sheriff, police chief of the largest local agency, the state police and DCJS. Each center is led by a DCJS-employed director, who reports directly to the center program director in the Office of Public Safety. This structure works to ensure that the centers are fulfilling the overarching goals of the state. The centers are staffed by civilian analysts, who are paid in part by IMPACT and federal Edward Byrne Memorial Justice Assistance (Byrne/JAG) funding, as well as other IMPACT and locally-funded sworn analysts and crime analysts within the county IMPACT partnership. The analysts conduct in-depth analysis of all city and county crime data, allowing all law enforcement agencies within each county to benefit from crime analysis as never before. The centers' analysts use software programs that allow them to link crimes, suspects, telephone numbers and other data from the various agencies within the county. This provides law enforcement with a macro level view of the local crime scene, enabling authorities to discover potential criminal associations. The centers also employ mapping software that provides a regional picture of where crime is being committed. These tools, combined with data drawn from numerous databases and records management systems from police departments in each of the respective center counties, provide center staff and in turn, local police agencies with a wealth of information to combat crime.

The centers share local crime information with the other centers using a single-inquiry search. The New York State Police, the Nassau Lead Development Center and the Suffolk County Police Department Intelligence Center also participate in this statewide crime information sharing network. More than 60 percent of the crime data outside of New York City is thus shared, enhancing the investigative capabilities of local analysts and law enforcement. New York/New Jersey High Intensity Drug Trafficking Area (NY/NJ HIDTA) and the Franklin County District Attorney Drug Task Force share license plate reader records with these other participants in the statewide data sharing network.

The centers emphasize effective dissemination of information as well as analysis. DCJS has funded digital signage in each center jurisdiction. The centers control 42" large video monitors on the walls in prominent places in police departments, out of view from the public, that broadcast slides generated by the Crime Analysis Centers. The slides include most wanted bulletins, warrants, crime maps, alerts, and officer safety information. Bank robbery photos are often posted within 20 minutes of the robbery. There are more than 100 monitors distributed in key precincts, parole offices and police headquarters across the state.

The centers utilize Geographic Information Systems to provide accurate and timely crime maps to the command staff and officers in the field of the local agencies. These online maps highlight crime by any combination of type, date and area, and the incident narrative report. The centers also provide web sites for local law enforcement to access in-depth information.

The commanding officer and the command staff of the Albany Police Department, the Buffalo Police Department, the Rochester Police Department and the Syracuse Police Department meet regularly with their respective center director to identify crime patterns that occurred in the previous 24 hours or more and to make determinations about the deployment of resources in response to those patterns. This regular interaction allows these four IMPACT jurisdictions to address crime patterns before they become crime trends. Every single center can point to cases that would likely still be unsolved were it not for the existence of the center, the technology available through the centers, and the expertise of the analysts staffed at the centers.

The centers are located at the headquarters of the Buffalo Police Department, the Rochester Police Department, the Syracuse Police Department and the Albany Police Department's South Station.

OFFICE OF PROBATION AND CORRECTIONAL ALTERNATIVES

The DCJS Office of Probation and Correctional Alternatives (OPCA) has worked closely with probation departments within the 17 IMPACT counties and has extended the lessons learned through IMPACT to probation departments statewide. Under direct guidance of OPCA, local probation staff has been assigned as probation field intelligence officers (FIOs) within the IMPACT county probation departments. The role of the Probation FIO is quite similar to the FIO assigned within a police department, but the intelligence that is gathered is obtained from people under probation supervision. The Probation FIOs work hand-in-hand with the FIOs assigned within their respective partnerships to maximize both collaboration and data-sharing among IMPACT law enforcement agencies.

The information that probation departments can provide to law enforcement is unique and valuable, and more of that information is being used by law enforcement to enhance investigations and their intelligence systems. Probation officers conduct joint warrant and curfew enforcement initiatives, bar checks and ride-alongs with police officers and assist in identifying offenders that have a high risk of reoffending. Probation FIOs have also been assigned to all four Crime Analysis Centers.

OCPA encourages departments in non-IMPACT jurisdictions to embrace these strategies to enhance public safety throughout the state. Additionally, OPCA has promoted several initiatives statewide that provide benefits to the IMPACT partnerships. These initiatives include:

- Correctional Offender Management Profiling for Alternative Sanctions (COMPAS) and Youth Assessment Screening Instrument (YASI) are risk an need assessment tools that assist probation departments in identifying probationers with the highest risk and need levels and assessing the "criminogenic needs" of probationers that must be addressed to prevent reoffending. All 57 probation departments outside of New York City utilize the state's webbased adult COMPAS and juvenile YASI risk and need assessment instruments.
- OPCA has encouraged the utilization of the Persistent Convicted Offender Report, created by DCJS, by local probation departments statewide as a supervision tool to help focus resources on high-risk offenders. This report is county specific and identifies individuals with five or more convictions within a recent three-year window. The report indicates whether the

offender is under supervision and is therefore valuable in assisting probation departments to focus supervision resources accordingly.

- Probation departments are required by law to collect DNA samples on certain offenders. OPCA tracks the percentage of required DNA collected by probation departments. Since the inception of DNA collection, probation departments have collected more than 125,000 samples of DNA from probationers in New York State, leading to the identification of offenders connected to more than 1,400 crimes, including nearly 120 homicides.
- OPCA is working with county probation departments and a state contract vendor to automate probation departments. This automation provides uniform data that can be utilized for crime analysis to support IMPACT strategies. Currently, 44 counties are either implementing or in production with the case management system, Caseload Explorer, and 39 counties have implemented the integration of Caseload Explorer with the state's Integrated Probation Registrant System (IPRS). This information is now being provided directly to Crime Analysis Centers.
- OPCA has embarked on a cooperative initiative with the U.S. Marshals Service, other DCJS staff, local probation departments and the NY/NJ High Intensity Drug Trafficking Area Center (HIDTA) to apprehend Sex Offender Registry Act (SORA) Level 2 and 3 probation absconders. Operation Return provides a package of guidance, resources and funding to facilitate the location and arrest of these offenders; probation absconders from 11 IMPACT counties are included in this initiative. To date, more than 50 offenders have been located, warrants have been lodged and 33 offenders have been extradited back to New York State for judicial action. Of the absconders returned and processed, 12 were sentenced to state prison, 17 were sentenced to local jail time, two were sentenced to time served; outcomes are still pending in two cases. Of the 33 absconders returned to New York for processing, further information indicates that one absconder was taken into Immigration and Customs Enforcement (ICE) custody, 10 were charged with violations of New York's Sex Offender Registration Act, and four were charged with federal Adam Walsh Act violations.
- OPCA has worked with the New York State Police, the New York State Association of Chiefs of Police and the New York State Sheriffs' Association to implement a statewide initiative for law enforcement agencies to share Domestic Incident Reports (DIRs) with supervising probation and parole authorities. The initiative is designed to hold offenders accountable and reduce the incidence of domestic violence homicides, of which, an overwhelming proportion are women. This procedure was codified into law with the passage of Chapter 476 of the Laws of 2009. Building on the foundation establish through prior DIR policy training, additional training has recently been provided to probation departments regarding proper interpretation of DIRs and appropriate probation supervision responses to these reports. OPCA has also been working with leaders from various tribal nations in New York State to develop and deliver domestic violence training to probation departments in areas with Native American populations regarding sovereignty and jurisdictional issues,

governance and structure, tribal criminal justice process, victim services and establishing protocols. Many IMPACT jurisdictions benefited from this training.

OPCA has provided continued support to the IMPACT initiative through direction and guidance provided to county probation directors and through participation and input at both agency Crime Trends meetings and monthly IMPACT state partner meetings.

NEW YORK STATE POLICE

The New York State Police (NYSP) continue to make critical contributions to Operation IMPACT efforts. By actively participating in a variety of IMPACT initiatives, they provide supplemental resources to enhance the police presence within the IMPACT jurisdictions. Their Community Narcotics Enforcement Teams (CNET) work with narcotics investigators in the IMPACT jurisdictions to address the sale and purchase of illegal narcotics and guns, while their Violent Felony Warrant Squads (VFW) add resources and expertise in coordinating warrant operations.

OPERATION IMPACT-SPECIFIC CONTRIBUTIONS

The New York State Police has continued to contribute valuable personnel resources to assist with Operation IMPACT efforts. The following data summarizes the number of sworn personnel assigned and the total number of hours logged in a variety of IMPACT details and initiatives in each jurisdiction³.

In 2011, the New York State Police significantly contributed to criminal interdiction efforts in 11 of the 17 IMPACT jurisdictions by issuing 10,911 traffic tickets. They also continued to assist local police agencies by responding to and investigating 49 traffic accidents.

NEW YORK STATE OFFICE FOR THE PREVENTION OF DOMESTIC VIOLENCE

The New York State Office for the Prevention of Domestic Violence (OPDV) has been an active partner in Operation IMPACT since its inception. Its role grew beginning in 2008 when domestic violence was designated by DCJS as a specific crime that jurisdictions were invited to address. Starting in late 2009, OPDV began communicating directly with designated staff in each of those jurisdictions, such as the chiefs of police, district attorneys, and probation directors. Those relationships have continued, and OPDV is regularly called to provide training or technical assistance regarding domestic violence.

During 2011, OPDV provided a total of 26 training sessions to 1,014 law enforcement officials in 11 of the 17 primary IMPACT jurisdictions. OPDV also provided technical assistance and training in a variety of different areas, including: additions and revisions to Criminal Procedure and Penal laws, such as strangulation offenses and stalking; Domestic Incident Reports (DIRs); mandatory arrest; primary physical aggressor determination; orders of protection; and New York's expanded access to Family Court laws. In the 2011-2012 RFA cycle, DCJS identified the crimes that jurisdictions should plan to address based on their crime data. Two communities, Yonkers and Utica, were asked to address domestic violence. OPDV reviewed and provided input to DCJS on the content of the proposals, and has provided support to both jurisdictions as they implement their plans.

Finally, OPDV, in collaboration with OPS, OPCA and the Department of Corrections and Community Supervision (DOCCS) continued work on a federally-funded grant project around

the successes of the IMPACT collaborations. In 2010, four IMPACT jurisdictions: Nassau, Orange, Dutchess and Albany served as pilot sites for the development of enhanced training for the criminal justice and advocacy community on key topics in domestic violence. The grant deliverables consisted of a series of web-based training tools for police, probation, and parole officers that will be made available statewide.

NEW YORK STATE DEPARTMENT OF CORRECTIONS and COMMUNITY SUPERVISION

The New York State Department of Corrections and Community Supervision (DOCCS) (which includes the former Division of Parole) has been an important partner in Operation IMPACT since its inception in 2004. DOCCS parole officers work on a daily basis with law enforcement agencies throughout the state as they supervise parolees released into their communities. These officers bring a unique contribution of support and information to the 17 Operation IMPACT partnerships.

Parole officers join with law enforcement for joint warrant sweeps, curfew enforcement and bar checks, debriefing of parolees and ride-alongs with other agencies. During 2011, Parole Officers participated in 208 joint operations with local Operation IMPACT partners to address specific crime problems in those jurisdictions.

DOCCS recognizes the critical importance of intelligence development and information sharing. The agency's Area Offices have always provided information about parolees to other law enforcement agencies, but that has been enhanced, particularly in jurisdictions with Crime Analysis Centers. Some examples of intelligence sharing are:

In Albany and Schenectady, information on parolees is provided through the Local Law Enforcement Data Information program. In exchange, those departments provide information on crime trends mapping and specific crimes, which are then reviewed by Parole officers. There is an exchange of wanted cases, which have significantly improved arrests. Daily arrest reports and field intelligence reports are shared, resulting in quicker, more efficient responses and better intelligence gained through debriefing. Intelligence sharing has risen to a new level among DOCCS and other law enforcement agencies with the creation of the Albany Crime Analysis Center. A monitor was installed in the Albany Area Office allowing staff to receive information in real time.

In Dutchess, Orange, Rockland, Ulster and Westchester Counties: the Peekskill Area Office has plans underway to install a monitor to allow staff to receive Orange County IMPACT information in real time. The New Rochelle Office and the Poughkeepsie Area Office provided a parole officer to the County Intelligence center meeting/discussions. In 2011, the Yonkers Police Department, using Intelligence from DOCCS, visited targeted parolees throughout the year.

The Syracuse Area Office continued to be an active participant in Operation IMPACT in Onondaga County committing 212 staff hours on eight details in 2011. Those officers worked with the Onondaga partner agencies to gather and share intelligence to better focus on high crime areas and crime trends. Each month, the partner agencies meet and discuss current crime trends and identify high crime areas in Onondaga County. Details are then planned around this data. The Syracuse office participated in search details that have targeted parolees who have a history of burglary, drug sales and gun violence.

The Syracuse DOCCS office has been granted access to the Central New York Law Enforcement Analysis Database System (LEADS), which gives the office the ability to access police reports and intelligence gathered by other agencies. It also gives the Syracuse office the ability to generate field intelligence reports that are sent through LEADS to the Onondaga Crime Analysis Center to be shared with other law enforcement agencies.

In Rensselaer County, the Northeast New York Area Office actively participates in the Operation IMPACT monthly coordinators' meeting to share criminal intelligence and develop and analyze crime patterns and strategies with the IMPACT partners. Additionally, they participated in fugitive apprehensions, warrant executions, joint home visits, and surveillance activities with the Operation IMPACT partners. The focus of Operation IMPACT in Rensselaer County is concentrated on gun violence, burglary and domestic violence. The excellent communication between the area office and the Rensselaer partners enable the office to respond to and support public safety strategies by targeting supervision efforts on parolees with histories consistent with current crime trends in the county.

In Oneida County, the DOCCS Utica Area Office partnered with the Utica Police Department, New Hartford Police, Oneida County Probation and the U.S. Marshals Service Central New York Fugitive Task Force. In 2011, the details occurred on average two times per month during which parole officers rode with police and initiated targeted residence inspections or conducted surveillance in addition to assisting with police operations.

In Broome County, DOCCS met regularly with the IMPACT partners to discuss the community supervision of parolees and the crime trends in the county. In 2011, the focus was on attempting to reduce the high burglary rate and the successful apprehension of parole absconders. Additionally, parole officers assisted local law enforcement agencies with sex offender address verification. parole officers, who participated in these operations throughout the year, reported that their collaborative efforts with local law enforcement agencies have enhanced their working relationships with those agencies and the shared information has often led to the apprehension of delinquent parolees.

In Erie County, the DOCCS Buffalo Metro Area Office engaged in collaborative activities with the Buffalo Police Department's Mobile Response Unit (MRU). During these operations, two teams consisting of one uniformed police officer and one parole officer typically worked together. The teams conducted home visits on parolees who were of interest to either department. In addition, areas known to have a high concentration of crimes were patrolled, absconder searches were conducted and parole warrants were executed. The contacts made with parolees during these special operations sent a message that the law enforcement community in Buffalo is engaged in a team effort to make the community a safer place. An additional benefit of this program was the sharing of information between partners at the officer level.

In addition, the Buffalo Metro Office participated in the monthly IMPACT meeting conducted at the Buffalo Police Department where crime trends were discussed and plans to address them were formulated. They continued to participate in the Erie Crime Analysis Center signage board program and have posted parole absconders to the board resulting in several of the warrants being enforced. Parole officers have also provided valuable information to the partners when they identify a releasee or criminal pattern on the signage board.

In Chautauqua County, during 2011, Operation IMPACT details were scheduled for Chautauqua County in Jamestown and surrounding areas. During those operations, two parole officers regularly participated. These details were broadly defined and normally consisted of compliance checks, warrant enforcement and bar checks.

In Monroe County, the DOCCS Rochester Metro Bureau continued to participate in Operation IMPACT in Monroe County. The field intelligence officer attended weekly Crime Stat meetings hosted by the Rochester Police Department and the Monroe Crime Analysis Center. Weekly crime trends, as well as discussions regarding violent disputes, were discussed with all participating partners. A parole analyst from the Monroe Crime Analysis Center forwarded field intelligence forms (FIFs), which consisted of parolee contacts with the police in the community, to the Bureau on a daily basis. A digital display, streaming crime trend information, has been installed in the Area Office. DOCCS participated in weekly warrant sweeps with the local Warrant Task Force that included the partners from the Rochester Police Department, Monroe County Probation, Monroe County Sheriff's Office, New York State Police and the U.S. Marshals.

In Niagara County, DOCCS continued to participate in compliance checks twice per month. While warrant enforcement efforts have decreased, they were scheduled on an as needed basis in combination with compliance checks or special operations. Special operations were scheduled on a periodic basis and included targeted searches, bar checks and warrant enforcement.

Suffolk and Nassau DOCCS staff remained an active partner. They attended the monthly Operation IMPACT partnership meetings and shared intelligence with their law enforcement partners when crimes occurred in communities throughout their respective counties (for example, spikes in robbery, burglary, shootings, etc.). Parolees, who reside within the crime-spike communities whose supervisory offense is related to the seven major crime areas, are debriefed jointly by parole and police officers for information about pending criminal activity.

Both Long Island Field Offices monitored all police reports that were forwarded to them regarding parolees arrested for domestic violence. Further agency investigation and case conferencing determined the appropriate supervision action to be taken. DOCCS also maintained

a preventive supervision approach by monitoring domestic violence parolee cases with electronic monitoring devices (GPS).

County law enforcement agencies continued to monitor and share gang member intelligence with Suffolk and Nassau field staff. This was further enhanced with parole officers utilizing the photo imaging system and taking photos (new releases and updated) of known parolees affiliated with gangs. This data was then downloaded and distributed to the Operation IMPACT partners.
