- 2017 Course registration form for the DEC Certified Installer course. Mail, fax, or e-mail completed form at least 5 days prior to class date. - Those who intend to become Certified Installers must be a licensed general or specialty contractor as described in 18 AAC 72.405(a)(2) or provide proof of employment for a licensed contractor per 18 AAC 72.415(b).
