## **Looking Back at an Eventful Year**

The year 2002 has come and gone, but not without some very positive changes. Most importantly, 2002 can be remembered as the year the Oklahoma Ground Water Association was resurrected. Oklahoma was only one of three states without a state affiliation, but not any longer. We expect the Association to grow into an organization in which everyone in the industry can be proud.

Theda Adkisson and I have been busy trying to stay up with the many activities associated with the drillers and pump installers program. During 2002, Theda renewed 149 firms and 228 operators. We have also licensed 22 new firms and 37 new operators in the state since the first of the year. That figure indicates that the demand for water well and monitoring well drillers has continued to increase.

The Advisory Council has also been extremely busy. We have met at least once a month during 2002. The members are continuously recommending positive suggestions on how to improve the program. Currently the Council and the OWRB have proposed several rule changes for the 2003 legislative session. But the OWRB and the Advisory Council will need everyone's help in getting the

proposed rules approved, so please get involved. I would like to commend the Council on their dedication and hard work, which takes away from their own busy lives and businesses.

We are looking forward to major improvements in the area of online well searches and online filing of well logs within the next six months. The funding has been approved and work has begun on the development of both of those programs. The upgrades should reduce the paperwork burden for the drillers and also help assist citizens and drillers search online for well information.

# **Ground Water Association Selects Board Directors**

# Rule Changes Proposed for the 2003 Legislative Session

The Well Drillers and Pump Installers Advisory Council and the OWRB have proposed several rule changes in Chapter 35 for this upcoming legislative session. The rule changes have been proposed in an effort to improve quality of well construction and to increase professionalism within the industry.

Highlights of the proposed changes include the following:

- Provide a more specific definition of Direct Push (Geo-Probe) Geotechnical Borings and provide specific plugging requirements for these types of borings.
- Clarify conditions and penalty associated with failure of a licensee to submit a completion report within the required 60 days.
- Create a new continuing education requirement of 4 hours per year or 8 hours per 2 year renewal period for each licensed operator.

- Eliminate the requirement to affix a rig sticker on well drilling rigs.
- Provide separate and more specific standards relating to construction of geothermal/heat exchange wells.
- Amend the requirement that the Board may require a licensed professional engineer to certify variances for well construction unless specifically requested by the Board and clarify that the landowner will be required to assume all liability resulting from the variance if issued by the Board.

The Board wishes to receive any and all comments regarding the proposed changes. Public meetings will be held in Guymon on January 15, Tahlequah on January 16, and Oklahoma City on January 21.
