Proposed Rule Changes for 2004

The Well Drillers and Pump Installers Advisory Council and OWRB have proposed several rule changes in Chapter 35 for this upcoming legislative session. The rule changes have been proposed in an effort to improve quality of well construction and to increase professionalism within the industry. Highlights of the proposed changes are listed below:

- Reference by rule National Ground Water Association documents regarding pump installation standards;
- Provide for new distance requirements for water wells being located close to potential sources of pollution;
- Provide for an alternative method for sealing groundwater wells and to clarify sealing requirements when surface casing and production casing are installed;
- · Provide construction requirements for sand point wells;
- Provide for permanent rules relating to construction of geothermal/ heat exchange wells; and
- Provide for over-drilling requirements for contaminated monitoring wells.

Public Meeting Scheduled to Discuss Rule Changes

A public meeting will be held in Oklahoma City at OWRB offices on February 3, 2004, to accept public input on the proposed rule changes. Written comments may also be submitted. A complete description of each proposed rule change can be requested by contacting Theda Adkisson at (405) 530-8800.

Well Log Amnesty Period Ends

The Well Drillers and Pump Installers Advisory Council and OWRB announce that the "well log amnesty period" has ended. The Board wishes to thank all the firms that have taken the time to review their records and provide the Board with well logs not previously submitted. The amnesty period allowed the Board to obtain records on numerous older wells throughout the state.

The Board established the amnesty period from July 1 through December 31, 2003. After that date, any firm identified as drilling a well since January 1, 2000, and not submitting a well log can be fined \$50 for the first infraction and up to \$250 for each additional violation.

Information from well logs is an important resource to the State of Oklahoma, and data is requested daily by consultants, state agencies, drilling firms, and land owners. The OWRB and the state's drilling industry thank the firms who cooperated.
