The year 2006 was a record year for number of wells completed (see table below). The total number of private water wells completed in 2006 was 3196, total number of agricultural wells completed was 831, and total number of public water supply wells completed was 81.

The 6th annual conference will be held at the Clarion Hotel in Oklahoma City on February 21-22, 2008. # Water Supply Wells Completed for 2003-2006\*

Total number of private water supply wells completed in 2006 was 3196, up by 11% from 2005 and up by 21% from 2004. Total number of public water supply wells completed was 81, up by 41% from 2005 and 28% from 2004. Total number of agricultural wells completed in 2006 was 831, up by 42% from 2005 and by 54% from 2004. Total number of commercial wells completed was 31, down by 81% from 2005 and up by 19% from 2004.
