# **Eighth Annual OGWA Trade Show and Conference**

The Oklahoma Ground Water Association (OGWA) presented the eighth Annual Conference and Trade Show February 18-19, 2010, in Oklahoma City. Approximately 300 participants attended. The Trade show was opened by outgoing President Pat Smith from Smith Pump & Supply and adjourned by incoming President Lyndon Pence from Baroid Industrial Services.

Kevin McCray, Executive Director of the National Ground Water Association (NGWA), presented a discussion on national issues regarding the groundwater industry. State Representative Mike Jackson, Majority Whip, gave an update on legislative issues, and Dana Murphy, Oklahoma Corporation Commissioner, spoke about oil and gas well hydrofracturing.

Pump Installers heard presentations from Franklin Electric, while drilling operators gained valuable knowledge of Highway Patrol and Corporation Commission inspection and compliance issues. Cheryl Cohenour of Cherokee American Drilling also provided an excellent presentation on rig safety.

## **Renewal Applications Due**

The Oklahoma Water Resources Board will be mailing renewal application forms to all licensed well drilling and/or pump installer firms required to renew in 2010. Please be advised that new State rules, scheduled to become effective May 27, 2010, affect renewal due dates and grace period as follows:

- Complete application packets (including the items listed below) received by May 27, 2010, will be eligible for the discounted early submittal fee rate of \$200.
- Complete application packets received after May 31 through June 30, 2010, will be eligible for renewal; however, the regular fee of \$250 plus a late fee of \$150 will apply.
- Applications received after June 30, 2010, are ineligible for renewal, and considered new applications.

Please complete the online application at https://www.owrb.ok.gov/wd/login/login.php or return your renewal forms along with the fee and attachments.

#### Notice on Outstanding Multi-purpose Completion Reports:

Oklahoma law requires that reports for drilling and plugging of test holes, borings, and wells be filed within 60 days of completion of work, subject to fines up to \$250 per report, license suspension, or renewal denial. During the 2010 renewal period, licensees will have the opportunity to file any outstanding reports without penalty. Reports must be filed on-line or received in the OWRB office by June 30, 2010.
