The OWRB has published the Oklahoma Driller's Log since 2001 as a source of information for the state's licensed water well drillers and pump contractors. # Enforcement of Rules Regarding Well Driller/Pump Installer Licensing and Multi-purpose Completion Report Submittal

As part of the 2012 Oklahoma Comprehensive Water Plan Update, new measures were added to state regulations for water well drilling, including an administrative fine schedule for unlawful activities, an automated fining process, and an online well log reporting requirement.

The OWRB regularly receives complaints from the public regarding unauthorized activities. Each of these complaints is taken seriously. If you observe or receive a call from a citizen regarding suspicious drilling activities, please contact the OWRB office so the appropriate action may be taken. All reports will be kept anonymous.

Citations are now being issued according to a fine schedule: \$1,000 for the first offense and \$5,000 for subsequent offenses, for the following activities:

- · unlicensed/uncertified drilling activities;
- · no licensed driller/pump installer onsite;
- · improper drilling rig identification; or
- minimum construction and plugging standard violations.

Each licensed company or certified operator is required to file a multi-purpose completion report (with latitude and longitude data) for all drilling activities within 60 days of completion (Please review OAC 785:35-5-3). Fines will be enforced according to the schedule, \$50 to \$250 per offense, and acceptable reports must be filed within 30 days of notice. Entities failing to file multi-purpose completion reports are being identified and fines will be forthcoming.

We appreciate your compliance and assistance in keeping licensee standards high and in submitting important groundwater data.
