Workplans

FY04 Workplan - FY05 Workplan

The Program Decision Document “Process for Receiving and Utilizing Financial Credit for LCR MSCP Work Tasks Performed in FY 2004 and FY 2005” (Program Decision Document 05-001) was discussed. There was agreement that the document would be more universal if the specific dollar amount cited was deleted.

Following discussion of the Report of the Technical Review Committee for FY04 Credit, the Program Decision Document was further amended to provide for further action as appropriate by the Steering Committee should there be any modifications to the Decision Document. (Motions 05-009 and 05-009(r))

Report from FY04 Technical Group

The Memorandum to the LCR MSCP Steering Committee from the Technical Review Committee, “Review and Recommendation on Reclamation FY04 Credit Request”, (Program Decision Document 05-002) was discussed and provision was made for modifications or future action, as appropriate, by the Steering Committee. The need for such action could be the result of U.S. Fish and Wildlife Service review or other changed factors. A motion to approve the recommendations of the Technical Review Committee, as amended, was approved by consensus (moved by Douglas Miller, seconded by Phil Lehr). (Motion 05-010)

FY06 Workplan

Lorri Gray reported that the non-federal share of FY06 program dollars is projected to be \$6,072,381. She will send a letter to Jerry Zimmerman, George Caan and Douglas Miller, on behalf of their respective states, formally stating the dollar requirements. It is understood that CRC of Nevada will follow-up with letters specifying the funding share of each state.

The schedule is for the FY06 Workplan to be presented to the Steering Committee for discussion at its July meeting and for approval at the August meeting. Implementation of the Workplan begins October 1, 2005.

Reports and Informational Items

Gail Iglitz, Bureau of Reclamation, presented a power point presentation on a mass tree planting research project that was undertaken in the Cibola National Wildlife Refuge this year. The plantings were on land that had been in agricultural use. They experimented with different planting techniques and strategies and the results were positive in terms of the projected success of future habitat restoration efforts

Doug St.Pierre, U.S. Fish and Wildlife Service approved acquisition boundary for expanding the Bill Williams National Wildlife Refuge. The Service is currently preparing its NEPA compliance documents. Public scoping meetings are projected for fall 2005. Foci will include biological, ecological and socio-economic factors. He noted that the Service does not have funding for such an acquisition but that this process would facilitate future expansion should the adjacent properties be acquired under the LCRMSCP or by other entities.
