**All requests for service will be honored as soon as possible on a first call basis. There will be a 4-hour minimum call in for any requests after regular business hours.**

**Cancellation and on-call charges:** If a start time is requested during non-regular hours and withdrawn prior to the requested start time, a 4 hour per person cancellation fee will be assessed at the applicable hourly rate. During non-regular hours, the elevator must contact agency personnel prior to the requested starting time to report loading status. If the elevator withdraws the request for service without contacting the agency, or fails to contact the agency regarding delays, an on call charge of 50% of the applicable hourly rate, per man, will be assessed until loading commences or the request for service is withdrawn.

**Standby time will be charged at the applicable hourly rate for all applicant caused delays.**
