# AGENCY FEE SCHEDULE July 1, 2016

EFFECTIVE DATE: July 1, 2016. United States Department of Agriculture - Grain Inspection, Packers and Stockyards Administration - Federal Grain Inspection Service (USDA-GIPSA-FGIS) must approve all fees for official services and Titus Grain Inspection, Inc. will assess only fees appearing on the current approved fee schedule. USDA-GIPSA-FGIS Administrative fees are included.

**REGULAR HOURS:** Monday through Friday between the hours of 8:00 a.m. and 5:00 p.m., to be negotiated with each applicant not to exceed 8 hours per day, except holidays.

**NON-REGULAR HOURS:** All hours other than regular posted hours, all hours in excess of 8 hours per day, Saturday, Sunday, and Holidays.

HOURLY RATES: Assessed in quarter-hour increments.

HOLIDAYS: New Year's Eve Day, New Year's Day, Easter, Memorial Day, Independence Day, Labor Day, Thanksgiving Day, Christmas Eve Day, Christmas Day.

MILEAGE: The Internal Revenue Service (IRS) Standard Mileage Rate is assessed for all services outside West Lafayette, IN. All charges for mileage will be pro-rated where possible. Any changes to the mileage rate are effective when the IRS changes their standard rate.

**OFFICIAL ON-SITE INSPECTION SERVICE:** Official On-Site Inspection Services are available to locations, which provide a furnished, and suitably equipped, approved lab.

**OFFICIAL COMMERCIAL INSPECTION SERVICE:** Official commercial inspection services are available to locations, which provide a furnished, and suitably equipped, approved lab. Be negotiated on a case-by-case basis.

Service requests not covered under this fee schedule will be assessed at the applicable hourly rate stated herein. Payments are due upon receipt of the invoice. A monthly finance

charge of 2.45% (APR 29.4%) will be applied on accounts not received with 20 days of invoice date.
