4. Summary of Proceedings

- a. Welcome Remarks
 - (1) Mr. Stephen Glasscock, ITS JPO Program Analyst and Committee Designated Federal Official, called the meeting to order and welcomed committee members and other meeting participants. Mr. Glasscock reminded members to identify themselves when presenting remarks for purposes of the meeting transcript, and turned the meeting over to Mr. Ken Leonard, ITS JPO Director, for introduction of the ITS JPO Acting Managing Director.
 - (2) Mr. Leonard stated that Mr. Egan Smith had joined the ITS JPO for a 90-day assignment as Acting Managing Director and requested that Mr. Smith introduce himself.
 - (3) Mr. Smith stated that he is assigned to the Federal Highway Administration (FHWA) Office of Planning, where he has been involved in performance-based planning and programming, and planning for ITS-related and connected vehicle operations.
 - (4) Mr. Leonard requested that committee members help publicize that a position vacancy announcement for the ITS JPO Managing Director position has been posted on USAJOBS, the Federal government's official job list, with a May 22 closing date. Mr. Leonard added that the ITS JPO is also in the process of filling a Program Manager position, available due to Kate Hartman's promotion to Team Lead.
 - (5) Mr. Glasscock turned the meeting over to Ms. Sheryl Wilkerson, Committee Vice Chairman, to chair the meeting in the absence of Committee Chairman Steve Kenner.

b. Roll Call

- (1) Ms. Wilkerson conveyed to Mr. Glasscock a committee member request that he recirculate the meeting agenda, which he did.
- (2) Ms. Wilkerson conducted the roll call. Committee members and others present are listed at paragraph 2.

c. Meeting Purpose

- (1) Ms. Wilkerson stated that the purpose of the conference call was to receive subcommittee updates on the topics the committee identified at its February meeting as foci for its advice to the Secretary of Transportation. For the benefit of committee members who were unable to participate in the February meeting, Ms. Wilkerson summarized that meeting's topics of discussion:
 - (a) Presentation by Mr. Tim Klein, Acting Director, Technology Policy and Outreach, Office of the Assistant Secretary for Research Technology, U.S. DOT, on the recently released report, *Beyond Traffic: U.S. DOT's 30-Year Framework* for *the Future*.
 - (b) Presentation by Mr. Daniel Morgan, Chief Data Officer, U.S. DOT, on *Trends in Open Data*.
 - (c) Presentation by Mr. Jack Hall, Contra Costa Transportation Authority ITS/Connected Vehicle Program Manager, on Contra Costa Transportation Authority *Multimodal Transportation Projects*.
 - (d) Presentation by Mr. Brian Cronin, Acting Director, Office of Transportation Management, FHWA, U.S. DOT, on *Operations and the Connected Vehicle* at FHWA.
 - (e) Presentation by Mr. Walton Fehr, Systems Engineering Program Manager, ITS JPO, Office of the Assistant Secretary for Research Technology, U.S. DOT, on *Connected Intelligent Transportation System Complete View*.
 - (f) Presentation by Mr. Nat Beuse, Associate Administrator, Vehicle Safety Research, National Highway Traffic Safety Administration (NHTSA), U.S. DOT, on major NHTSA light and heavy connected vehicle Vehicle-to-Vehicle activities.
 - (g) Remarks from Mr. Gregory Winfree, Assistant Secretary for Research and Technology, U.S. DOT, thanking committee members for their participation on the committee's important work.

- (3) Following a brief discussion of additional changes to subcommittee membership, Ms. Wilkerson invited Mr. Denaro to begin the subcommittee updates.

d. Subcommittee Updates

- (4) Members will submit recommendations for the August meeting agenda to Ms. Wilkerson and/or Mr. Glasscock.
- (5) Ms. Wilkerson and Mr. Glasscock will consider Mr. McCormick's recommendation to include, time permitting, Connected Vehicle and capacity building updates in the August meeting agenda.
